We are still awaiting the governments response to the Education Committees Fostering Inquiry and the National Fostering Stocktake, so it remains to be seen how seriously they will take the very mixed recommendations made by both. Some of GMB's key recommendations were included in both reports and it is vital that we keep up the pressure on making changes whilst we wait—that is where you come in. We need more foster carers to join the GMB and have their voices heard.

### Foster Carers & Allegations



Are you aware of what to do if an allegation is made against you?

Do you know what the procedures are for your fostering local authority or agency?

Many foster carers don't think about the answers to these questions until they find themselves the subject of allegations.

Sometimes these allegations are related to children currently in your care, other times they may be historic allegations from children you fostered many years ago.

As a GMB member you are entitled to contact and meet with your local representative for advice, support and representation throughout the whole procedure. This is whether it is an internal procedure with the local authority or agency, or whether you are subject to a criminal investigation being conducted by the police.

You will always have access to GMB legal support whilst you are a GMB member. Retiring from fostering? Speak to us about the options for keeping your membership protection for life.
