## **GPPA Names New SC, Candidates for 2010**

Packer to run for U.S. Senate; Bortz for Congress; D'Agostino, Giordano, Farrington and Sweeney for State Rep.

*Monroeville, PA* - During its Nominating Convention in February, the Green Party of Pennsylvania chose a new Steering Committee and approved nominations for six candidates to compete in the November General Election.

#### **Steering Committee**

I.K. Samways and Katrina Brabham, both of Pittsburgh, were elected to serve as Chair and Secretary, respectively, and Vivek Ananthan of Philadelphia was retained as Treasurer. Mr. Samways, who had been serving as Interim Secretary since April 2009, follows in the footsteps of Hillary Kane of Philadelphia, who stepped down as Chair after three years of service.

"I can only hope to approach what Hillary accomplished as Chair to strengthen the party and get more Greens involved at the State and National levels," said Samways. "I have learned much to guide me from her example."

Newly elected Steering Committee members include Guy Gray of Northampton County and Sandra Hazley of Pittsburgh. Returning to for another one-year term are Tim Reim of Erie and Bob Small of Delaware County.

#### **Candidates**

Long-time peace activist **Mel Packer** will be at the top of the ticket as the Green Party candidate for U.S. Senate. Packer works as a emergency room Physician Assistant in Pittsburgh. While a member of the Teamsters, Packer helped organize Teamsters for a Democratic Union, a rank-and-file movement for greater union democracy. Packer recently served on the board of the Thomas Merton Center, a nationally-known peace and social justice center in Pittsburgh.

In a speech to convention-goers Saturday night, Packer referred to the country's economic condition by saying, "As a nation, we must rise to new personal and collective heights; understand that this battle is not just an economic battle, but a moral battle to save the soul of this nation. We must take on the Goliaths that stalk our land, plunder our economic wealth, pillage our communities and soil, and recognize that they only have power because we give them power."

The Green Party also approved the nomination of **Ed Bortz** of Pittsburgh to run against Rep. Mike Doyle in the race for U.S. House of Representatives, 14th District. The Green Party has challenged Doyle twice before with Titus North, who received one of the highest percentages for a third party candidate in Pennsylvania history.

Bortz distinguished Green Party candidates from the rest of the field by saying, "The Green Party offers a non-corporate clean break from the dirty-money-dominated 'politics as usual.' Greens propose funding for education, not Wall Street bailouts. Greens propose sanity in foreign policy, bringing all of our troops home from Afghanistan and Iraq, and redirecting the bloated war budget toward universal healthcare, human and environmental needs. Green Party legislators will send the health insurance and corporate lobbyists packing, and open up the process to the stakeholders that have been locked out – the voters."

Four Green candidates have declared for the Pennsylvania General Assembly. **Dr. Rex D'Agostino** will run in the 183rd District, which covers parts of Lehigh and Northampton Counties. **Roy Farrington** of Clinton County will vie for the 76th District, while former GPPA officer and longtime activist **Jay Sweeney**, a expert on the Marcellus Shale, will run in the 111th District. **Hugh Giordano** will be running for an open seat recently left vacant in Philadelphia's 194th District by Kathy Manderino's retirement. "We're very excited about the upcoming campaign season," said Samways. "Our slate of candidates is very impressive and all are passionate about challenging the two-party orthodoxy with which voters are increasingly expressing their displeasure. Their geographic diversity speaks volumes about how far and wide our message is already propagating throughout the Commonwealth."

When civil rights workers James Chaney, Andrew Goodman, and Michael Schwerner were murdered in Mississippi in 1964, folks didn't wait for Congress and Federal investigations to show their unequivocal commitment (along with tears and shouts) for equal rights...we brought it to the streets, even as teenagers in my hometown of Pittsburgh.

#### About Senate Candidate Mel Packer



Mel Packer is a physician assistant working in the Emergency Department of a Pittsburgh-area hospital.. He is married and has two adult children. He is firmly rooted in his community and remains committed to building strong neighborhoods as a way to develop local democratic control.

Mel has a 40-year history of social, political, labor, and community activism, from the civil rights and Vietnam war eras to current protests against the wars and the G20 summit in Pittsburgh. While a member of the Teamsters, he was instrumental in the founding of Teamsters for a Democratic Union. More recently, Mel served on the Board of the Thomas Merton Center, the Pittsburgh-area peace and justice center, and served as Board President in 2008. In addition, he has been a frequent speaker at recent rallies and events organized to protest the closing of Braddock Hospital by the University of Pittsburgh Medical Center.

Regarding healthcare, Mel recently stated, "Were I a member of the US Senate, I not only would have voted against the health care bill, I would have called on citizens to come to DC and/or rally in their own towns to demand Medicaid for all – universal health care for all – an end to the forprofit health care system. As much as I respect Dennis Kucinich, he was wrong to support this bill. One does NOT vote for bad legislation – one opposes it and argues AND organizes for the health care we need: universal, lifelong, and non-profit."

Mel has long been, and continues to be, a strong and principled critic of our government's current economic, military, social, and environmental policies, not only nationally, but locally and regionally. His position papers posted on his website, <a href="https://www.melpackerforsenate.org">www.melpackerforsenate.org</a>, offer sound alternatives.

#### **Giordano Hits the Ground Running**

The campaign of Hugh Giordano, the Green Party candidate for State Representative (194th District), is off to a great start. On Friday, March 5, two weeks after receiving the official nomination from the 2010 Green Party Nominating Convention, the campaign held its first fundraiser. Friends and supporters packed into the Holy Smoke Bar and Restaurant to help kick off the campaign. (The 194th District covers the Roxborough, Manayunk, and Wynnefield sections of Philadelphia, as well as parts of Montgomery County such as Bala Cynwyd and Narberth.)

Giordano told the crowd why he should be the 194th District's next Representative in Harrisburg. "I care about working people and will fight for workers' rights," said Giordano. "I have seen three generations of poverty living in the same house – that's almost 90 years of poverty among hardworking people, people who worked in factories and never took a dime from the system. There's something wrong with that picture."

The event raised over \$2,000, some of which has already paid for professional-looking palm cards and yard signs.

Since the kick-off, Hugh and his supporters have diligently canvassed the district gathering signatures for his ballot access petition. He also has two major events scheduled for early April: a candidate debate sponsored by the

#### **Delaware County Outreach Efforts**

#### **Report from Honduras**

On Saturday, February 13, 2010, the Delaware County Green Party hosted a gathering at The Peace Center of Delaware County to hear longtime peace activist Sylvia Metzler, who reported on her experiences as a member of the Quixote Center's Quest for Peace and its 8th International Witness Delegation to Honduras from November 25 through December 2, 2009.

After President Zelaya was ejected from the country by a military coup d'etat on June 28, 2009 Hondurans took to the streets to protest and they have never stopped. The two main demands of the resistance movement are the restitution of Manuel Zelaya to the presidency and the implementation of a Constitutional Assembly to reform the Honduran Constitution.

The purpose of Ms. Metzler's Quest for Peace delegation was to bear witness to what was going on in Honduras before, during and after the November 29, 2009 vote. Their group of 19 spread out over the country. They met with a range of representatives from the Honduran resistance movement to better understand their goals, their decision to boycott the elections, and the violence they faced. They also met with Canadian and U.S. government officials about their respective governments' decisions to support and recognize the electoral process executed by the coup regime.

Now that they are home, these delegates seek to inform ordinary citizens about the unjust and undemocratic conditions existing in Honduras. They

encourage ordinary citizens to pressure the U.S. and Canadian governments to reject the new Honduran government put in place by the illegal coup regime, condemn the dangerous and deadly human rights conditions in Honduras, and cancel all government aid to Honduran security forces.

# **Crude: The Real Price of Oil**On the evening of March 27<sup>th</sup>, the

Delaware County Green Party presented the documentary *Crude: The Real Price of Oil* to an audience of about 30 at Swarthmore Borough Hall, as part of Rainforest Action Network's "Change Chevron Campaign." The film traces the history of the "Amazon Chernobyl" in Ecuador and the twists and turns of a case that has gone on for generations. Chevron/Texaco has fought judgments for their environmental crimes which have caused death, disease, and destruction to the indigenous people of Ecuador. Frances Whittenton of the Delco Alliance for Environmental Justice (<a href="www.ejnet.org">www.ejnet.org</a>) introduced the film, and Jocolyn Bowswer-Bostick spoke about the Delco Greens. After the film, Bob Small led a lively discussion. We are continuing to "brand" the Delco Greens by being involved with events such as these.

The New Zealand Parliament, which is elected using a proportional representation system, typically has between 7-9 Green Party members. Interestingly, the Maoris, who are New Zealand's indigenous people, are automatically allocated a block of Parliamentary seats to fill. Green MP Jean Fitzsimons, who was well respected across the political spectrum, recently retired from political life. There is a movement to get her to come back.

"Keith was an intelligent and thoughtful man who listened attentively to our 'two-party system' woes in the States," said Steve. "We gave him a signed copy of Ralph Nader's DVD, An Unreasonable Man, and a GPUS 'Green Party – Peace Party' button. He seemed to especially like the button."

#### EARTH DAY ACTION ALERT!

On **Earth Day, Thursday, April 22,** activists from the Green Party of Pennsylvania and other groups will be gathering outside each of the regional offices of the Pennsylvania Department of Environmental Protection to call as one for the following demands:

- An immediate moratorium on all horizontal hydrofracturing ("fracking") in the Commonwealth, including our state forests and floodplains,
- An immediate freeze on all new Marcellus Shale drilling permits throughout Pennsylvania,
- The immediate suspension of the authority of the Delaware River Basin Commission and Susquehanna River Basin Commission to approve drilling~related water withdrawals anywhere in Pennsylvania, and, if necessary,
- The unconditional resignation of DEP Secretary John Hanger.

Keynote speakers and scheduled activities will commence at **noon** at DEP Regional Offices in Norristown, Wilkes-Barre, Pittsburgh, Williamsport, and Meadville, and DEP Headquarters in Harrisburg.

April 22, 2010, marks the 40th anniversary of the first Earth Day. In 1970, almost 20 million people gathered across the nation to celebrate, educate and demonstrate. It was a nationwide grassroots teach-in that gave rise to the modern environmental movement.

The 1970s saw passage of the Clean Air Act, the Clean Water Act, and the creation of the Environmental Protection Agency. Beginning in the 1980s, however, large Earth Day events have been dominated by corporations with little grassroots input and limited citizen involvement.

Today, gas drilling in the Marcellus Shale, utilizing horizontal hydrofracturing, is a serious and growing threat to the precious clean waters and majestic state forests of our Commonwealth.

Pennsylvania's Constitution states that "All power is inherent in the people." This April 22nd, it is time to come together as one to protect our Commonwealth's public natural resources and to renew the promise of the first Earth Day.
