**Technical stuff we're required to inform you of...**

1. You have the right to participate in the governance of Granite City Grocery.
2. You have the right to receive patronage dividends as net earnings permit.
3. The above rights take effect with your first payment and stay in effect as long as payments are kept reasonably current.
4. Shares are entitled to no dividends, and they may not be sold or transferred except through Granite City Grocery.
5. The first share you purchase is returnable only upon termination of ownership. Other shares are returnable as you request. Returns are payable only from replacement capital provided by other owners. You can receive no more than you paid in, and it may be less if Granite City Grocery encounters financial difficulties.
6. The minimum share purchase is subject to assessment for the reasonable capital needs of Granite City Grocery.
7. These limitations and other terms and conditions are further described in the Interim Rules or Bylaws of Granite City Grocery.
8. Funds expended for the purchase of shares are risk capital, and you could lose all or part of such funds.
