OFFICIAL GIVEAWAY RULES – the Giveaway (the “Giveaway”)

GIVEAWAY PERIOD

The Giveaway will be awarded to individuals who have completed the Credit Valley Conservation Survey until Saturday, September 26th, 2015. With three Friends and Family Annual Memberships for the Credit Valley Conservation being awarded on September Monday 28th, 2015. Saturday, September 26th, 2015 is the last day to complete the survey in order to be eligible for the draw of the giveaways.

GIVEAWAY ELIGIBILITY

Who is Eligible?

The Giveaway is open to all legal residents of Ontario:

- completed the Credit Valley Trail survey; AND
- provide their legal first and last name; AND
- have a valid email address; AND
- have provided a city; AND
- reside in one of four Areas: Western (hereby “Western Ontario”), Central (hereby “Central Ontario”), Toronto (hereby “Toronto”) and Eastern (hereby “Eastern Ontario”).

A “Valid Email Address” is defined in all cases as an Address which (a) represents a real business or individual in Ontario and (b) includes the minimum contact information necessary for the Foundation staff to contact the candidate by email. For giveaway winners under the age of 18, a legal parent or guardian must give consent to accept the prize.

“Central Ontario” Area is defined as: Peel and York Regions.

“Eastern Ontario” Area is defined as: Durham, Lennox and Addington, Northumberland, Frontenac, Peterborough, Haliburton, Hastings, Renfrew, Lanark, Leeds and Grenville, Parry Sound, Muskoka, Kawartha Lakes and Prince Edward Regions.

“Toronto” Area is defined as: Toronto, Etobicoke and Scarborough.

“Western Ontario” Area is defined as: Waterloo, Halton, Niagara, Bruce, Dufferin, Middlesex, Dufferin, Elgin, Essex, Oxford, Perth, Grey, Huron, Simcoe, Lambton, Wellington, Brant, Brantford, Chatham-Kent, Greater Sudbury, Haldimand, Hamilton and Norfolk Regions.

Who is Not Eligible?

Notwithstanding the above, the Giveaway is not open to individuals who are directly associated with the Foundation, including (a) Employees of the Foundation; (b) the agents or representatives of the Foundation (including their respective divisions, subsidiaries, affiliates

and advertising or promotional agencies) and suppliers in connection with this Giveaway. (collectively, the "Excluded Individuals"). This Giveaway is not open to the immediate family members of the Excluded Individuals, and all other persons with whom the Excluded Individuals reside.

HOW TO ENTER

No purchase is required to win the giveaway.

Need to complete the Credit Valley Conservation Trail survey before Friday September 26th, 2015 in order to be eligible for the giveaway.

Only one submission is required for entry—submitting multiple or duplicate entries will render the entry ineligible.

Method of Enter:

Chances of Winning

Entries will not be eligible if sent by any method not specified above or if not submitted within the noted duration of the Giveaway Period. Multiple entries, duplicate entries, and entries from multiple accounts from the same candidate will not be accepted—multiple or duplicate entries will render the entry ineligible. The Foundation will not be responsible or held liable for entries lost, for entries which cannot be submitted because of technical issues, or for entries which, for any reason, appear to have been submitted after the end of the Giveaway Period.

Winner Selection

The *survey takers* will all be entered in a random draw, where a random number generator will be used to pick the giveaway winners. This will be executed by the Foundation.

Giveaway

There are a total of 3 giveaways begin awarded on Monday, September 28th, 2015. The giveaway consists of 3 Friend and Family Annual Memberships for Credit Valley Conservation, Valued at \$100 + HST awarded to 3 survey takers, with each survey taker receiving one giveaway.

Awarding of Prize

For the first week of each month that the giveaway is running, the winners will be contacted via email during regular business hours (Eastern Standard Time). If the person selected as the winner cannot be reached within 3 business days from the time of initial contact, an alternative submission may be selected until such time as a selected person satisfies the terms of this selection. Upon initial contact, the potential winner must respond by phone to the provided contact number in the notification during regular business hours (Eastern Standard Time). Before the potential winner is declared the official winner by the Foundation the potential winner must: (i) correctly answer, unaided, a time-limited mathematical, skill-testing question administered by telephone; (ii) be in compliance with the rules for the contest; and (iii) fully complete, properly sign and return a standard release document confirming compliance with, and agreement to, be bound by the contest rules, release of the Foundation and its directors, officers and employees from any and all liability, and acceptance of the prize as awarded within 5 days after receipt. The potential winner must also provide their full legal name and contact information as requested.
