During 2012, the organization held 93 educational events at 25 colleges and universities, as well as 4 national events, 4 professional events in Washington, DC, and 2 professional events in New York City. These events covered basic principles and contemporary issues in foreign, economic, and national security policy. The aggregate attendance at these events was 3,564.

The organization's second National Symposium took place on October 13, 2012, in Washington, with 189 registered, including 120 students from 32 colleges and universities, almost twice the number of schools represented at our 2011-12 Symposium. The topics of the panel discussions included Iran, energy and foreign policy, and grand strategy. Highlights were the keynote address by the philanthropist Roger Hertog, and a presentation by former CIA Director James Woolsey.

The organization held its third student leader conference in June 2012, with representatives from 23 schools, a 27 percent increase from its second conference in 2011. The conference included sessions on policy, chapter organization, and professional life. The students attended a model debate between faculty, received counseling on managing a chapter's finances, and listened to professionals discuss how they have pursued their policy interests in a number of fields. There is a direct correlation between a chapter's progress and its officers' participation in this event, making the conference an important leading indicator of the organization's growth for the following academic year.
