## **PART 1: Short-Answer Questionnaire**

1) Please describe your qualifications for the position you seek (include your key issues/priorities if elected and any key endorsements you'd like to share), plus anything else that you'd like our members to know about you and your candidacy.

My qualifications for Member, Community College Board, include serving as student trustee of the College Board from June 2012 to May 2013, during the first year of the accreditation show cause determination, three years of serving in several student government roles at City College of San Francisco-Ocean Campus, including student body president, student body vice president, senator, elections commissioner, shared governance coordinator, BSU president and Oueer Alliance Vice President. My experience with public education includes being a graduate of three public schools in San Francisco, serving as a student organizer and activities coordinator with the San Francisco Unified School District Student Advisory Council and my current occupation as a Counseling Services Specialist with Foothill College, where I have worked as a classified staff member since 2011. Additionally, I have more than ten years of work experience in nonprofit organizations throughout the Bay Area where my primary responsibility has been youth development, particularly with young people that were underrepresented as I was when I was a youth. These organizations include Coleman Advocates for Children and Youth, Community Health Network/Department of Public Health, CHALK Youthline, American Civil Liberties Union of Northern California and KPFA Radio.

2) If you are running for College Board, tell us about what you have done to support CCSF during its accreditation crisis and what you plan to do to keep it open and funded. Even if you aren't running for College Board, if you have been a part of the fight to save CCSF, feel free to tell us about what you have done to help.

I took it upon myself to run for this same college board seat in the 2012 election while holding the non-voting Student Trustee seat that year, attending school full time, dealing with typical housing situations that students face in San Francisco, and being the student spokesperson for why one should not shut down the largest single campus community college district in the nation. I created a blog where I communicated my every move, whether it was attending an accreditation task force work group, speaking at the opening of a new campus or program, voting against raising student fees at a board meeting, or marching in Sacramento to raise awareness about the importance of CCSF to the region's workforce, the city's residents, and the 90,000 students that depended upon it every single day of their life.

3) Do you support repeal or reform of the Ellis Act? Locally, what specifically would you do to fight for housing affordability in San Francisco?

As a native San Franciscan, who currently occupies a bank-owned house under pre-foreclosure proceedings, I have received three illegal eviction notices at my place of residence over the past year. Over the past three years, I have been homeless for as long as I have been housed. I support any changes to the Ellis Act that will prevent law abiding tenants from facing speculative evictions. I also support any policy statements on housing balance to be ratified as binding legislation in a future election.

4) In your opinion, what kind of reform of Prop 13 is needed, if any? Would you support a split-roll property tax system?

Proposition 13 cannot continue to allow for businesses to enjoy tax savings protections that were intended for fixed income California residents. I would support a split-roll property tax system.

5) LGBTQ elders and older people living with HIV face a number of challenges, including finding affordable housing, accessing health care and a general lack of services. Many are being evicted. If you were elected, what would you do in your power to help address these challenges?

Existing programs that support the elderly and those suffering from HIV should be evaluated for their efficacy and it should be determined if these programs require more funding to ensure that all who seek services from these at-risk communities can access these services. Accessing these services should also be streamlined through an easily identifiable network provider, such as an LGBTQ liaison placed at up to a dozen adult day centers in different parts of San Francisco.

6) Similarly, LGBTQ youth face challenges including bullying and a high rate of homelessness if ostracized by their families. If you are elected, what would you do in your power to help these youth? For School Board candidates, what would you do on the SFUSD board to help LGBTQ students who are bullied?

As a graduate of City College of San Francisco, I supported the creation of a safe space for the Queer Alliance in 2002; LGBTQ students did not feel safe in the Associated Student Union at CCSF and the work of the Council that year created a safe space for queer students. I am proud to say that twelve years later, the Queer Alliance holds their meetings in the newly established Queer Resource Center. The space is great, but a number of alliances between queer leaders in San Francisco and the queer students that attend CCSF would be very empowering to students. Whether this program is a mentorship program or a speaker series of successful queer leaders in San Francisco, more programs where young queers can see elder queers that are contributing to the community can help boost the self-esteem of students who face bullying on a daily basis.

Additionally, much of the legislation being presented at the state level by Assemblymember Ammiano and Senator Leno should be tracked at the local level to determine what changes are happening locally as a result of legislation enacted at the state level.

7) Supervised injection facilities or drug consumption facilities have been shown to reduce new HIV and hepatitis infections, overdose deaths, and public drug use, and to increase linkage to medical care and substance use treatment and save money, yet they remain controversial and illegal. If you are elected, what would you do to advocate for supervised injection sites?

I am willing to convene a few town hall forums in parts of San Francisco that are supportive of the facilities and parts of San Francisco that have no desire for the facilities to see if there are any ways of determining common ground between each side of the issue, whether any pilot of the facility would be palatable, and determining which allies in elected positions in San Francisco would be willing to introduce legislation to pilot a facility in an area that both understands the need for and can benefit from a pilot facility.
