I believe the Harvey Milk Club should consider endorsing my campaign because of my vast dedication and community service to the citizens of San Francisco Bay Area for the last 37 years and my leadership.

If you are running for College Board, tell us about what you have done to support CCSF during its accreditation crisis and what you plan to do to keep it open and funded. Even if you aren't running for College Board, if you have been a part of the fight to save CCSF, feel free to tell us about what you have done to help.

3) Do you support repeal or reform of the Ellis Act? Locally, what specifically would you do to fight for housing affordability in San Francisco?

Yes, I support any reform measures for renters that will keep them living in decent and safe housing conditions in San Francisco. My housing advocacy includes Co-Founder of Tenant Associations Coalition of San Francisco and Program Director since 1998; Co-Founder of Manor Advocates in 1997; Advocate of National Community Land Trust since 2001;

Member of San Francisco Community Land Trust since 2002; Member of Affordable Housing Accountability Working Group since 2004; and Member of Housing Justice since 2005.

With median rents approaching \$3,500 and real estate speculators contributing to a steep rise in evictions, the stories of seniors, disabled and longtime residents uprooted from our neighborhoods have been heartbreaking.

I've worked to pass laws that prioritize Ellis Act victims for our scarce affordable housing, legalize tens of thousands of in-law units, make it easier for tenants suffering financial hardship to be exempted from rent increases, and provide more pro bono attorneys for residents facing eviction. But we need to do more than build a safety net; we need to build more housing.

Yet dueling proposals aimed at the November ballot (and at each other) miss the mark. Last month, Supervisor Jane Kim introduced a ballot proposal to limit production of market-rate housing based on the total percentage of affordable housing in the city. Critics say such strict limits will not increase affordable housing, but will drive up prices for existing housing stock.

In response, Mayor Ed Lee proposed a rival ballot measure that reaffirms the city's commitment to building 30,000 housing units by 2020, with "poison pill" provisions that would invalidate key portions of Supervisor Kim's measure. Kim's supporters point out that the mayor's measure is a policy statement that does not create funding sources.

Our energy is better spent focusing on a housing bond initiative for the 2015 ballot. In recent years, San Francisco has lost \$70 million to \$80 million a year in state housing funding, mostly a result of the governor eliminating redevelopment agencies. The time is ripe for a local housing bond.

In 2012, I joined tenant and affordable housing advocates, and market-rate developers to establish a trust fund approved by voters that sets aside an average of \$50 million a year toward affordable housing and housing programs. While this is a down payment, it won't come close to meeting our city's 33 percent affordability goal for 30,000 units by 2020. A housing bond would achieve our goal, particularly because housing finance experts have identified an opportunity to take advantage of the growth in property values.

Also, to prevent buildings from being sold to speculators, several cities have established the right for tenants to make a first offer to purchase a building; if tenants were to receive financial assistance for such purchases from a city fund and philanthropic contributions, we could leverage several revenue streams to protect our most vulnerable renters. Others have suggested changes to our city's inclusionary housing rules, such as partnering affordable projects with market rate developments. These and other ideas are worthy of consideration.

Let's find a way to put housing first.

In your opinion, what kind of reform of Prop 13 is needed, if any? Would you support a split-roll

property tax system?

Since 1978, Proposition 13 has been sacrosanct in California politics. Those who have tried to tinker with it have been thwarted by court rulings, legislative timidity, and the weight of arguably the most potent citizen's movement in the state's history.

No longer do we hear about senior citizens being forced to sell their homes because they can't pay outrageously high property tax bills. But Proposition 13 had the unexpected result of putting a lid on taxes from commercial properties — and shifting the overall burden toward homeowners. The share of state revenue from residential property taxes has steadily increased, while the proportion from commercial properties has steadily declined. Why? Proposition 13 requires reassessment of a property only when it changes ownership. Commercial property simply doesn't change hands as often as residential property. That means there are fewer opportunities to reassess them at market rate.

Another key factor is the legislation passed in the wake of Proposition 13 specifying that commercial property can only be reassessed when ownership changes by 50 percent or more. But commercial property owners have benefited from rules that allow them to avoid triggering the 50 percent "change in ownership" provision.

5)
LGBTQ elders and older people living with HIV face a number of challenges, including finding affordable housing, accessing health care and a general lack of services. Many are being evicted. If you were elected, what would you do in your power to help address these challenges?

First, would insure adequate mental health services for LGBT older people, to prevent feelings of loneliness and isolation, to depression and thoughts of suicide.

In June 2012, San Francisco's Board of Supervisors passed an ordinance establishing a task force on issues affecting lesbian, gay, bisexual and transgender (LGBT) elders. The task force will address housing, legal equity, research and demographics, social services and inclusion of elders within the community. The Board selects the 15 task-force members in September, and they will have 18 months to investigate the issues and report back with their recommendations.

I will review these recommendations and support them and advocate amongst my fellow SF Board of Supervisors to implement these recommendations.

6) Similarly, LGBTQ youth face challenges including bullying and a high rate of homelessness if ostracized by their families. If you are elected, what would you do in your power to help these youth? For School Board candidates, what would you do on the SFUSD board to help LGBTQ students who are bullied?

Since I am a co-founder of Larkin Street Youth Center, and a former Public Health Department employee. I have much personal experience being involved for 15 years providing and implementing programs for LGBTQ youth in San Francisco, I would make this a priority of mine. I would review current contracts for services for LGBTQ programs that the city currently provides funds for and assist and advocate for more programs and secure additional funding for existing programs.

Supervised injection facilities or drug consumption facilities have been shown to reduce new HIV and hepatitis infections, overdose deaths, and public drug use, and to increase linkage to medical care and substance use treatment and save money, yet they remain controversial and illegal. If you are elected, what would you do to advocate for supervised injection sites?

There are between 11,000 to 15,000 intravenous drug users in San Francisco, most of them homeless men. The city already operates a clean-needle exchange program to reduce HIV and Hepatitis C infections.

At least sixty-five supervised facilities exist in 27 cities in eight countries, but no other U.S. cities have considered creating one. Let's San Francisco change that and create this service for a underserved population in need.

I would work with advocates that have been seeking to pioneer this. Another very important health concern that can be address through prevention practices.
