PART 1: Short-Answer Questionnaire

1)Please describe your qualifications for the position you seek (include your key issues/priorities if elected and any key endorsements you'd like to share), plus anything else that you'd like our members to know about you and your candidacy.

As a native San Franciscan, I am a product of San Francisco's public schools, transportation and library systems, and I am acutely aware of the challenges our City faces. My work experience as a community organizer, small business owner and a former City employee has afforded me the knowledge and skills to spearhead legislation, advocate for important issues and interface with all communities to move forward policies that have a positive impact on our Southeastern neighborhoods.

In my first term on the Board of Supervisors, I have delivered for District 10 residents and San Franciscans by championing the development of affordable housing for seniors and families; spearheading landmark legislation to toughen



regulations on guns and lethal ammunition to curb violence; creating and protecting local jobs in construction and manufacturing; supporting the creation of an LGBT Senior Task Force to address the needs of the aging LGBT community and the increased funding for services targeting at-risk LGBT seniors and youth, particularly in communities of color; co-authoring legislation that provides a fair chance at jobs and affordable housing for individuals with a conviction history; securing funding to stop domestic violence, increased healthy food options and expanding language access services; and supporting free Muni for youth and fighting to secure more funds for Muni service.

District 10 deserves a leader in City Hall who has the experience, commitment, and pragmatism to guide us through the next four years -- my priorities will be tackling housing affordability, increasing public safety, bringing more living wage jobs to residents in District 10, and expanding neighborhood services in the Southeastern sector of our City including improved transportation.

2)If you are running for College Board, tell us about what you have done to support CCSF during its accreditation crisis and what you plan to do to keep it open and funded. Even if you aren't running for College Board, if you have been a part of the fight to save CCSF, feel free to tell us about what you have done to help.

I have been a strong supporter of saving and preserving CCSF's accreditation. CCSF is an institution that is essential to our City. I have supported Board resolutions, made calls and signed letters in support of efforts to save CCSF. I will continue to be an advocate for CCSF.

3)Do you support repeal or reform of the Ellis Act? Locally, what specifically would you do to fight for housing affordability in San Francisco?

I have fought to support increased payments for victims of the Ellis Act and stood behind State efforts to reform the law because I am a firm believer that we must create more affordable and middle-income housing in San Francisco. In my first term, I took significant steps in rebuilding our City's public housing and moving forward key projects that deliver low and middle-income units. In District 10, we are building thousands of units of middle-income housing at the Hunters Point Shipyard/Candlestick Point, Alice Griffith and the old Schlage Lock site. In an effort to grow middle-income housing, in my capacity as a trustee on the Retirement Board I initiated the investment of \$50 million of pension funds into the City's first time homebuyer program. I will continue to support projects that deliver not only low income, but also middle income units in San Francisco and will push for additional incentives for developers who deliver these key community benefits.

4) In your opinion, what kind of reform of Prop 13 is needed, if any? Would you support a split-roll property tax system?

I do support Proposition 13 reform. Just a few months ago, I sponsored a resolution at the Board of Supervisors urging the State legislature to close the



commercial property tax loophole that has been implemented as a component of Proposition 13. Commercial property owners don't pay their fair share under this system shifting the tax burden to others. By not assessing these properties properly, San Francisco is forgoing \$46 billion in assessed property values that would result in hundreds of thousands of dollars in annual revenue to the San Francisco Unified School District.

5) LGBTQ elders and older people living with HIV face a number of challenges, including finding affordable housing, accessing health care and a general lack of services. Many are being evicted. If you were elected, what would you do in your power to help address these challenges?

Nearly every corner of the City is facing an affordability crisis centered on rising rents and a flood of new residents. In order to meet demand, we must focus on building more affordable and middle-income housing. Many minority communities are being pushed out of their neighborhoods, and we must take action to keep diversity alive in San Francisco. I am currently working with community leaders to develop and initiate a new marketing plan focused on attracting minorities and people of color to the housing units being built throughout the Southeastern neighborhoods. I believe a similar program could work in the LGBTQ community. In my first term we took significant steps in rebuilding our City's affordable housing and building key projects that deliver low and moderate-income units. I supported increased payments for victims of the Ellis Act and supported State efforts to reform this State law which is being used by speculators to displaces long time residents in our communities. During the height of the economic downturn I implemented a mandatory mediation program with the Superior Court to ensure that foreclosure victims had access to the legal services they needed to keep their homes. I believe we need to continue all of these efforts in order to preserve the diversity and character of San Francisco. San Francisco shouldn't just be a City for those who can afford it, we have a long been a City that embraces everyone.



6)Similarly, LGBTQ youth face challenges including bullying and a high rate of homelessness if ostracized by their families. If you are elected, what would you do in your power to help these youth? For School Board candidates, what would you do on the SFUSD board to help LGBTQ students who are bullied?

I believe that one of the most important things we can do to support LGBTQ youth are to provide key services such as housing, mental health and employment that are tailored to their specific needs. This is why I was a supporter of budget requests that cam from the TAY budget coalition for key services. I was also a supporter of adding TAY to the re-authorization of the Children's Fund and increasing the age of individuals that can access TAY services. Additionally, I believe that one of the most important ways to elevate a community is to support and help appoint and elect leaders to public positions. I have been proud to support LGBTQ candidates for City Boards and Commissions.

7)Supervised injection facilities or drug consumption facilities have been shown to reduce new HIV and hepatitis infections, overdose deaths, and public drug use, and to increase linkage to medical care and substance use treatment and save money, yet they remain controversial and illegal. If you are elected, what would you do to advocate for supervised injection sites?

I have not taken a position on the issue, but I remain open to hearing more about it.
