1) Please describe your qualifications for the position you seek. Feel free to add anything else that you'd like our members to know about you and your candidacy. I've lived in the Bay Area for 10 years now, employed as a project manager in multiple industries. After the 2016 election, I was horrified by the ugliness in our country, and yet energized by Bernie and the growing progressive movement, inspiring me to political activity. I joined organizations like the San Francisco Berniecrats and of course our very own Harvey Milk LGBTQ Democratic Club, and ultimately chose to run for the Board of Supervisors in my district. This is because I believe City Hall needs a project manager to organize for the progressive cause.

2) Do you have any key endorsements you'd like to share?

Most are still pending, so I cannot claim them for sure at this time. However, I am cooperating with Mike Murphy in a mutual endorsement as part of a ranked choice voting strategy.

3) More than 7,000 individuals are experiencing homelessness in San Francisco. Due to the physical and mental trauma inherent to living without stable housing, these individuals suffer from increased health problems and are three to four times more likely to die prematurely than their housed counterparts.

What do you see as the most important short-term and long-term solutions to the homeless crisis in San Francisco? What can you do in the office you are running for to help end homelessness?

Right away, we need more beds, caretakers, and healthcare - medical and mental - to house the homeless and start the process of healing their trauma. And some will require permanent housing and care depending on their situation. Programs like that proposed by Our City Our Home (Prop C) will be a major part of the solution. But for others, it's a matter of means and the lack of affordable housing. And so in addition to the immediate care and shelter needs, we must increase the affordability of housing and availability of below market rate housing.

4) What are your priorities and plans to address housing affordability and economic inequality in San Francisco? What have you done on this in the past?

San Francisco policy is heavily weighted to favor corporations, investors, and the wealthy. To counter this, I propose anti-speculation and vacancy taxes, elimination of corporate tax cuts, and increased BMR housing mandates on inclusionary housing. I would also like to see the passage of more public housing, such as that proposed by the SF Community Housing Act. I collected signatures for this measure, and I would do so again in the future, or better yet, push it onto the ballot by sponsoring legislation as supervisor.

5) Describe your philosophy and priorities for developing a legislative framework for recreational marijuana. Do you agree with the current framework adopted by the Board of Supervisors? What would you change, if anything?

It's become apparent that even in a new industry like recreational marijuana, city policy still caters to the well-funded corporate world. With chain retail outlets for marijuana springing up all over the Bay Area, we must pave the way for small marijuana shops owned locally by those in underprivileged neighborhoods, focusing on business owners previously targeted by the clearly discriminatory War on Drugs of yesteryear. We must have an equitable approach to marijuana regulation or else once again see marginalized communities suffer, particularly those lower-income individuals whose well-being depends on medical cannabis treatment.

6) The African American population in San Francisco is steadily declining. The racial bias of our police force and criminal justice system is well documented. SFUSD's achievement gap for African Americans students is the highest in the country as of 2017.

What do you think are the most important actions that you can take in your office to stabilize and support the African American community in San Francisco?

As supervisor, I believe it is critical to be involved in the police reform process to push for de-escalation training. With recidivism proportionately higher among people of color, we must analyze and recognize patterns behind these crimes and sentencings and revise antiquated legislation to remove these biases. I would also like to cooperate with the school board to recognize schools with disproportionately underprivileged student bodies and increase the resources and educators available to those schools. A major part of my platform is a better funded SFUSD and equitable disbursement of resources.

7) How have you support the LGBTQ community and how will you continue to do so if elected?

I continue to learn and grow from the struggles of my peers who identify as LGBTQ, and it is by taking in the input of the LGBTQ community that I can continue to understand and support them, particularly with the blatant bigotry we increasingly face as a society. As supervisor, I wish to be an ally to the LGBTQ community and a voice to address the issues that they face. I'll continue to fight for gender-neutral facilities in all spaces and advocate for increased LGBTQ awareness education and cultural development.
