In addition to this questionnaire, we invite you to participate in a recorded video interview on Zoom with Club leadership on either July 25th or July 26th from 10am to 5pm. This virtual interview replaces the typical in-person presentation to our Membership, and the recording will be shared with our Members ahead of our endorsement recommendation and final vote.

1. Describe your qualifications for the office you are seeking. Feel free to add anything that you would like our Members to know about you and your candidacy.

I currently serve as President of the Board of Trustees at City College, as a member of the San Francisco Democratic County Central Committee and as a member of the Prop C Oversight Committee. I was elected to City College Board in 2016 and prior to being elected I was co-founder and a lead organizer for the Save City College Coalition during the accreditation crisis. In addition to serving on the board I work during the day for the UCSF California Preterm Birth Initiative as Director of Community Engagement and Partnerships to reduce disparities in pregnancy and birth for Black, Brown and API women in San Francisco, Oakland and Fresno. I am a native San Franciscan, a product of all public schools which includes SFUSD and City College. My father was a construction laborer and worked on many building projects in the City and my mother was a nursing assistant. I am working class background like many students who are served by City College. I took my first course at City College after graduating high school and transitioning out of the foster care and juvenile justice system in 2002. I have been an advocate and organizer in the Bay Area over the past 20 years have worked with numerous labor and nonprofit organizations. I am honored and proud to have had the support of the Milk Club in for my past elections and to have received the "City College Champion" award from the club in 2014. I have broad supporters which includes the endorsement of all our progressive allies on the Board of Supervisors, my colleagues on the Board of Trustees, the Tenants Union and Sierra Club. If reelected to the board I want to utilize my eight years of experience at City College to focus on serving our students during the pandemic and deep recession. I want ensure fiscal stability and the success of our bond program. I want to ensure equity. diversity and inclusion across the college which includes diversifying our faculty in partnership with our academic leaders. As a board member I have had to make hard decisions for the benefit of the future of the City College and I am ready to take on many challenges we have ahead.

- 3. What do you see as the most important short-term and long-term solutions to SF's homelessness crisis? What can you do in your office to help end homelessness?

We need to build affordable housing at the Balboa Reservoir and as a Trustee I want to continue advocating for this to happen.

Short term: Expanding navigation centers throughout the city, utilize empty lots for safe sleeping sites, provide hotel rooms for emergency shelter, tax measures to fund housing development and supportive services

Long term: Build more affordable supportive housing, Mental Health SF, expand drug treatment programs

4. What work have you done to address economic inequality and housing unaffordability in San Francisco? What will you do to address them if elected?

I believe that all of my work at City College is addressing economic inequality by providing an accessible, affordable pathway to education. It has personally transformed my life and has provided career advancement and opportunity. In terms of housing affordability in my role at UCSF I was able to work with housing advocates and health experts to secure a policy change from the Department of Homelessness and Supportive Housing to prioritize pregnant people for emergency housing before their third trimester. I support COVID-19 rent relief, repealing Costa-Hawkins and the Ellis Act, rent control expansion and all tax

measures that support development of affordable housing. As a member of the Prop C Oversight Committee I am looking forward to implementing the solutions that housing advocates and houseless individuals have identified.

5. Describe your work addressing racial injustice, economic inequity, and police brutality in San Francisco.

I have worked for organizations such as the Human Rights Commission, Jobs with Justice San Francisco, the Young Womens Freedom Center, the Western Addition and Bayview Community Police Relations Board, the Safety Network Partnership and Unite Here Local 2. As a Black working class and formerly incarcerated person I have experienced in the past and have currently experienced racial injustice, economic inequity, and police brutality in San Francisco firsthand. It is exhausting and traumatizing what we as BIPOC experience and I strongly believe that our White allies with more racial and economic privilege need to carry more of the labor to address these longstanding structural and institutional issues.

6. How have you supported LGBTQ San Franciscans, and how will you continue to do so if elected?

I have endorsed and campaigned for numerous LGBTQ candidates and will continue to do so as a Bisexual elected official. I am also a 2020 Victory LGBTQ Institute Empowerment Fellow which is a national program and network that supports LGBTQ individuals to run for office.

7. Describe your work addressing the climate crisis, and what specific steps you would take if elected to confront climate change and environmental injustice.

As a student organizer and Development Director for the California Student Sustainability Coalition I was part of the effort to have the entire UC system divest from fossil fuels. At City College we have a comprehensive sustainability plan that we need to continue to implement.

Fighting the ACCJC to protect City Colleges accreditation.

As President and a member of the board I have:

- Led the transition of our former permanent Chancellor and served on the search committee with faculty, staff, students and administrators to hire our current Interim Chancellor who has 30 years of experience and will help led the college during this unprecedented crisis
- Worked closely with our administration on the process of moving all our course offerings online and providing wrap around support for students experiencing food insecurity and technology needs during the COVID-19 pandemic.
- Campaigned for the passage of our \$845 million facilities bond which will radically transform our facilities and infrastructure
- Served on the Joint Select Committee with representatives from SFUSD and the Board of Supervisors to address issues like Dual Enrollment programs expansion and policing on our campuses
- Supported the passage of Prop W and a 10 year MOU for Free City College. I
 want to expand the program to workers in San Francisco and ensure this is a cost
 neutral program
- Advocated for State debt forgiveness of \$24 million which was due to issues with documentation of online classes
- Advocating for representation for Community Colleges on the State Workforce Economic Recovery Board.
- Advocating for Prop 13 Reform "Schools and Communities First"
- Advocated at the federal level including travel to Washington, DC to advocate for dedicated funding for Community Colleges that includes dollars earmarked for job training H.R. 6800 (HEROS ACT) and engaged federal representatives Pelosi, Spier, Feinstein and Harris
- Supported Supervisor Walton's proposal for bridge funding and currently support WERF. We know we are in difficult times in terms of our economy and we hope that the labor community will be united in the fact that City College provides 300 million dollars of economic activity and should have more funding from the City's general fund. Retraining our most vulnerable communities will be the key work of the college during this time.
- Serving on the MOU negotiation committee to advocate for our interests with the Balboa Reservoir. This MOU if it meets the needs of our college will be integrated with the City's development agreement to ensure our college community is supported and not negatively impacted.
- Supported the passage of preferred name policy and gender neutral bathrooms

This is not an exhaustive list. I have been committed to City College of San Francisco remaining an accredited community college providing transfer to university, career and technical training, and opportunities for lifelong enrichment for the past eight years.

2. What is your plan to address the bullying of LGBTQ students, as well as students of traditionally marginalized communities?

We have a zero tolerance policy for bullying and hate crimes at City College. We are a Sanctuary Institution and to continue to maintain a safe space I want to advocate for more funding for all our student resource centers like the Queer Resource Center.

3. How would you address the needs of homeless students?

We need to build housing for our students and expand our HARTS program which provides wrap around support services such as food vouchers and transportation support.

3. What are your plans to protect undocumented students and their families?

City College does not engage with ICE and as a Trustee of City College I am committed to ensuring that our collection of data does not endanger students and immigration status is protected.

4. Did you support or oppose the hiring of former Chancellor Mark Rocha? How would you describe his tenure as chancellor?

The hiring of the Chancellor is a participatory process where students, faculty, staff and administrator representatives screen and interview all the candidates and send their top candidates to the Board. The Board received three candidates and Dr. Rocha was the most qualified out of the three at that time. Six of our seven board members myself included voted to hire him. Before the search process started I traveled to Tucson, Arizona to try to recruit David Doree our former Business Dean who is beloved and talented but was turned down. I believe strongly that we did not have an exceptional pool of candidates in 2016 with the college coming out of the accreditation crisis. I would describe Dr. Rocha's tenure as starting out strong which is a perception by a number of elected and community college leaders across the State. We negotiated a fair multi year contract with AFT2121 that included pay raises and there was a good relationship with the board. It all went downhill with the administrative raises "salary gate" and the class cuts "midnight massacre" which the board was not informed of. When I became President this year I knew my first task was to address our leadership issue in the least chaotic and litigious way possible with my colleagues. This is to ensure we can stabilize the college and attract permanent leadership with experience that will be respected by our college community and across the State.
