The Clerk gave an update on the grant applications. The grant for the Housing Needs Assessment had been submitted and contact had been made with AECOM from Open Plan and the Clerk. A decision on whether the bid was successful would be received this week. A bid for £8,000 additional grant funding had been submitted.

The Committee confirmed that the invoice from Open Plan totalling £1,848.24 plus £369.65 VAT was to be paid.

However, following discussion some form of skeleton plan would be available in January 2020. The Committee would also need to consider holding a formal public consultation on the draft Plan.
