CREATIVE INDUSTRIES TASKFORCE – REPORT RELEASED

Last week Creative Victoria released the findings of the Creative Industries Taskforce. The report was written by the Taskforce, chaired by Louise Adler AO, to advise on the development of Victoria's first creative industries strategy. It outlines 42 initiatives for government consideration which the Taskforce believes would strengthen and grow Victoria's \$23 billion creative and cultural economy, and reap social and cultural benefits right across the State.

The consultation summary report, which accompanies the Taskforce report, states that there was "a particularly enthusiastic response from libraries, local councils, heritage societies and historians to become more involved in increasing and improving creative places and spaces, and to build on opportunities for the community to participate in the creative industries throughout the state...Museums and heritage organisations are major cultural custodians."

The Minister has invited public comment on the 42 initiatives before 20 December 2015. The report will be considered by government and will inform its strategy to be released in 2016.
