The uncertain tax position standard must be applied to all existing tax positions upon initial adoption.

As of June 30, 2015, the Organization had no material unrecognized tax benefits and no adjustments to liabilities or operations were required under ASC 740. The Organization's practice was and continues to be to recognize interest and penalty expenses related to uncertain tax positions in income tax expense, which were zero for the years ended June 30, 2015. Generally, the Organization's three preceding tax years are subject to examination by federal and state tax authorities. There are no income tax examinations currently in process.
