### POLICIES AND PROCEDURES

- ★ All campers must **wear long pants, closed toe shoes and their Humane Society t-shirts (to be provided on the first day of camp)**. Hats and sunglasses are optional.
- ★ **Bring a sack lunch.** Lunch is around 12:00. We will provide drinks and snacks. No microwaving or refrigeration available.
- ★ Campers must be signed in/out daily by Parents/Guardians (or other pre-authorized person). Please be punctual.
- ★ The shelter does not open until 10:00am. **Do not leave your child at the shelter unattended until they have been signed in with the camp director.** You may start signing in your child no earlier than 9:55am.
- ★ Campers must be picked up promptly. We do not provide after care. Late pick-ups will be charged at a rate of five dollars for every 10 minutes starting 10 minutes after camp has ended.
- ★ Please notify The Humane Society of Ventura County if your camper is going to be absent.

**WAIVER AND RELEASE OF LIABILITY**

Knowing the risks of handling domestic animals, on behalf of the minor and myself, I agree to assume those risks and to release, indemnify, and hold harmless The Humane Society of Ventura County and/or any of its Officers, Directors, Employees, Agents, Volunteers or Contractors for any and all personal injury and property damages resulting from said child's participation in activities.

I also understand that said child is to remain on The Humane Society of Ventura County property for the duration of the activities. If my child leaves the property during participation, with or without permission from a staff member, I release, indemnify, and hold harmless The Humane Society of Ventura County for any and all personal injury and property damages resulting from said child leaving The Humane Society of Ventura County property.

I give The Humane Society of Ventura County authority to seek emergency medical treatment for said child. I know of no medical or other condition that would prevent said child from participation in activities at The Humane Society of Ventura County.
