A political scientist, he was educated at Dickinson College and the George Washington University. As Director of Heldref Publications at the Helen Dwight Reid Educational Foundation in Washington, DC, he served on numerous academic and charity boards and held officer positions with the DC Democratic Party. His family's dedication to blindness prevention led him to IEF. He received our 2001 *Promotion of Peace & Vision Award*. Walter Beach was the quintessential public citizen involved in community, national and international service whether political, philanthropic, educational, or social and he is greatly missed".
