During 2019, Jubilee USA Network was featured in tens of thousands of newspapers and media outlets. Jubilee's educational efforts on debt relief and disaster aid for Somalia, Puerto Rico and US states resulted in billions of dollars of support for recovery. The network increased awareness on the connections between "anonymous" shell corporations, the loss of development aid and human trafficking. The world's largest religious institutions and hundreds of faith communities participated in Jubilee's grassroots educational efforts on the need for trade policies to protect the most vulnerable. Pope Francis and major religious leaders highlighted Jubilee USA's analysis on economic issues that impact vulnerable populations. The central IMF event for world leaders on understanding debt and accountability issues, was organized by Jubilee USA. Jubilee USA's executive director was invited to address the Presidents and Prime Ministers of the world on Jubilee USA Network's efforts during the 2019 United Nations General Assembly.
