Dear Friends,

This year, Congress is considering the Corporate Transparency Act (H.R.2513), a bill that would help fight poverty and corruption in some big ways.

This bill will create a registry of the true owners of corporations so that law enforcement can stop anonymous shell companies from stealing money from low-income countries, evading taxes, laundering money, and engaging in human and drug trafficking and terrorism.

By asking companies to reveal their beneficial owners, Congress can close a loophole allowing bad actors to commit financial crimes and perpetrate human rights abuses.

This Jubilee Weekend, we pray for an end to these injustices. We call upon Congress to swiftly take action and shine a light on this darkness in our financial system.

Included in this guide are sample prayers, relevant scriptures, action guides and other resources to help you plan your Jubilee Weekend. We welcome you to adapt any of the following materials for your tradition. We invite you to simply be inspired by these examples and let G-d move your congregation to pray and act for a Jubilee. These materials are for use at the time Jubilee Weekend is celebrated nationally or any time during the year.

## PLAN AN EVENT

Plan an event with your faith group to discuss the importance of the Corporate Transparency Act and its consequences for global economic justice. This is also a great time to pray for the poor and victims of human trafficking.

This year, we are encouraging congregations to light candles as a way to symbolize our work and shine light on the abuses of shell companies as well as our goal of corporate transparency. Lighting candles can be a great way to accompany prayer for the Corporate Transparency Act during your event or during your service. Other things to keep in mind when planning an event:

- Let your local press know what you have planned. Many smaller local papers are glad to get information about communities getting involved in social justice. If you need help, contact us at outreach@jubileeusa.org
- Have your clergy or faith leader share what you are doing for service at local clergy meetings
- Set up a prayer corner in your house of worship. Pray for people living in poverty and for our leaders in Congress. Include pictures and short facts. The corner is a good place for individuals to light candles and write prayers. If the prayer space is in the sanctuary, you might invite people who wish to visit the prayer station to do so at appropriate times during the service.



# Anonymous Shell Companies

Anonymous corporations, also called shell companies, are companies created on paper that don't do significant business and don't disclose the company's true owner. They are often used as vehicles for financial crimes, including tax evasion, Medicare fraud, terrorism, human trafficking, drug dealing and weapons trafficking. Our partners at Global Witness call these companies the "getaway cars" for financial crime. Shell companies contribute to the estimated one trillion dollars that leaves the developing world annually through crime, tax evasion and corruption. This flow of dirty money takes resources away from the world's poorest countries and people.

When someone forms a company in the U.S., they do not have to disclose the real people who profit from its existence or activities, known as the "beneficial owners." Instead, the real owners can conceal their names and identities by

using a front person (such as a lawyer) to represent the company. This lack of transparency allows criminals and the corrupt to launder money and makes it difficult for law enforcement to solve financial crime. ensure that companies formed in the U.S. disclose their true owners. This will make it much easier for law enforce-



Shell companies facilitate crime and fraud.

Financial transparency is critical to ending poverty and protecting both the resources and tax revenues of poor countries. Here in the United States, we have an important role to play in promoting transparency and stopping the flow of dirty money out of developing countries.

The bi-partisan Corporate Transparency Act would ment to track down criminals and prosecute and prevent illegal activity. Corporate transparency can reduce the flow of dirty money and ensure that vulnerable populations can access resources to build schools, hospitals and infrastructure. This bill will make it harder for those stealing from the most vulnerable to use the U.S. financial system as their "getaway car."
