

Report from Sharon Hodgson MP

This summer, the Labour Party entered into another leadership contest, where Jeremy Corbyn and Owen Smith set out their stalls on the future of Labour and our country as a whole. I congratulate Jeremy on his victory. Now that the result has been decided, it is important that we find a way to work together.

This will mean reconciliation by both sides, but despite the differences that became apparent over the summer, the Labour Party must remain a broad church whereby we all work together to hold the Tories to account on their Brexit negotiations and their plans for the future of our country. Labour is a party which founded the NHS, brought in the National Minimum Wage promised by Keir Hardie, and passed the Equality Act and Child Poverty Act. We can be that Party again.

One issue which has united Labour is our opposition to Theresa May's plans to open new grammar schools. Her plans on social inclusion and mobility hark back to a time when a child's life was defined by a test they took at the age of 11. We should be supporting all children, not just a

certain few in society, and as all major evidence shows, where grammar schools currently operate they are not improving the widening educational gap. This is why Labour will be working hard to reverse these plans and oppose them in Parliament at every available opportunity.

Brexit

Last week, we reached the 100-day milestone since the EU Referendum vote and despite a summer where Brexiteer ministers should have been getting to work on what Brexit will mean for the UK, we still got their same old line of "Brexit means Brexit". This week, we found out that Article 50 will be invoked in March 2017 and we will have a Great Repeal Act in the next Queen's Speech which will repeal the European Communities Act of 1973, but still nothing more.

Theresa May's speeches this week should have allayed many of the questions posed to her by the public, politicians and business leaders alike, yet she has given us further questions that need to be answered, such as our future access to the single market and what will happen following the Great Repeal Act once it is pushed through Parliament next year - there are still important questions left unanswered. It is important that throughout this process that the jobs and livelihoods of people here in the North East are not negatively affected. For example, Nissan here in Sunderland, which depends greatly on access to the single market, needs to have answers from the Government on our future post-Brexit. As always, I will be holding the Government to account on what Brexit will mean for my constituents and ensure that we finally get the answers we all need.

Recently, the Boundary Commission announced its initial proposals for the redrawing of the constituency map. As many will already know, Washington will be split between three constituencies and Sunderland across six.
