




## Visiting St Johns' & St Clements Primary School in Peckham

#### **Campaigning on remittances with Mayor of Southwark**

On 17<sup>th</sup> July Parliament debated the decision by Barclays Bank to close the money transfer businesses that enable families to send money from the UK to relatives back home and I met with the new Mayor of Southwark, Councillor Abdul Mohamed, to discuss the impact this will have on communities in my constituency. We planned our campaign activities to oppose Barclay's decision, which will have severe consequences for the flow of remittances to some of the poorest areas in the developing world.

### Too few parents and children in C&P are getting their first choice of secondary school

Once again this year I have published my report "Are parents in Camberwell & Peckham getting the choice of secondary school they want for their child?" which examines first preference applications. It shows that more than one third of parents in the area are not getting their children into their first choice secondary school.

This year only 58.7% of parents in Southwark got their first preference secondary school compared to 96% in York. This is one of the biggest concerns that my constituents raise with me as their MP.

Three out of the eight secondary schools that serve children in my constituency—The Charter School, Kingsdale and Sacred Heart— were oversubscribed for first preferences i.e. had more first preference applications than places available but five out of the eight schools—Harris Girls East Dulwich, Harris Peckham, ARK All Saints Academy, Walworth Academy and St Thomas the Apostle—were undersubscribed for first preferences i.e. had more places available than parents who made the school their first choice.

The important thing is for the schools, the council and the Government to understand the reasons why parents are choosing not to send their children to these schools - and take action to address those concerns. I am demanding a meeting with the Minister for Education to insist that action be taken. Until all secondary schools in Southwark have the confidence of all parents the school report card will still read "must do better".

#### **Camberwell & Peckham casework stories**

A pensioner from Camberwell contacted me about a tax issue. She was told by the tax authorities (HMRC) that because she had 'underpaid' income tax for 4 years, she owed them almost £3,000. I contacted HMRC and they admitted that they had handled the situation incorrectly and had failed to act on information they had received regarding her employment status. In this instance they agreed to waive the debt and instructed her pension provider to refund any deductions which had already been taken since the beginning of the tax year.
