- Local Council Election Campaign May 1982. In Peckham, the Labour vote was 32.9% ahead of our nearest rival - the Tories - which makes us 5th in the league table of Labour constituencies in London. returned 100% Labour councillors, and the election campaign was well organised in all wards. I made the campaign to win a large majority for Labour in the elections a priority in my work in the months leading up to the election. (1) As a result of a meeting called by the South London co-ordinating committee of the TGWU to help with the election in Southwark, Aubrey Edwards (TGWU officer) set up a pre-election meeting for TGWU members in Kings College Hospital. About 200 members attended the morning meeting and about 70 members attended the afternoon meeting.. The meeting was addressed by a number of council candidates as well as myself and Kate Hoey (prospective Parliamentary candidate for Dulwich). (2) Election posters and leaflets were distributed in the bus garages. (3) Canvassing and leafletting in each of the eight wards provided me with a welcome opportunity to get to know party members better as well as meeting many of the electorate on the doorstep. The help that the TGWU was able to provide in the local elections in Peckham will, I hope, be a very good basis to build on for the forthcoming general election:
- 2. Health Service dispute. The Peckham Labour Party has made campaigning in support of the health workers major priority over the last four weeks. Speakers from health service unions have been invited to the General Management Committee, local wards meetings and both the women's section meetings. At each of these meetings collections were taken. Together with Labour Party members I have attended pickets on each of the days of action and a march from Dulwich Hospital past. Kings to the Elephant and Castle on 23 June. The Peckham party, jointly with the Royal Arsenal cooperative Society and the SERTUC health services committee, is organising a rally in support of the health service workers on 21 July 1982. Aubrey Edwards, TGWU, will be speaking at the meeting and I will be chairing it. The Peckham Labour News carried an article I wrote urging Party members to support the health workers, and there was a similar article in one of the ward newsletters.

But there was a strong sense of division between the women delegates from the Labour Party women's section and women delegates from trade unions. I feel this could be remedied in two ways.

Candidate's Report on follow-up to by-election campaign

We managed to stick firmly to the objectives of our campaign as agreed at the September GMC and at the first meetings of the Campaign Committee. Those objectives were to highlight Peckham's problems and Labour's Socialist alternatives on

Jobs * Housing * Living standards * Peace

We also ensured that in addition to the vital work of leafletting, canvassing and knocking-up we had a campaigning approach. In particular

- * Leafletting youth clubs and unemployed Benefit Offices
- * Leafletting and visiting pensioners
- * A leaflet plus a day of activities on women in Peckham, involving women MP's, candidates, and councillors
- * Writing to and visiting black groups in the area and arranging stories in the ethnic minority press
- * Identifying with trade union struggles e.g. NHS dispute and the Post Office unions' Day of Action

Looking back over the dampaign, my main impression is of its strengths and the deep support that the Party commands in Peckham. But we must not be unselfcritical! Though the campaign showed our strengths, it also revealed where more work needs to be done to lay a solid base to win support for our policies and to build for the General Election. I make the following suggestions as points for discussion in the GMC. branches and affiliated organisations.

1. Trade Unions The support from trade unionists at local and regional level was magnificent. We must ensure that local support continues by getting branches to affiliate to the Party and developing our involvement in local workplace issues. It should be possible to get the bus garages, local hospitals and POEU branches (to mention just a few) to affiliate if we approach them prompty. If I, together with the Secretary and/or T.U. liaison officer, visit them to thank them for their support, we can urge them to affiliate at the same time. There are two huge telephone exchanges in our area. Perhaps we should meet the branch officers of the Post Office unions to discuss work on the battle against privitisation with them. An early meeting of party officers, myself and those most directly involved in mobilising support for our campaign will no doubt

yield more ideas for action.

- 2. Unemployment Ian Hamilton and many members of Southwark Unemployed Peoples Action did a marvellous job campaigning at the U.B.O.'s. I hope to include a message of support from Labour on the leaflet on the Southwark Unemployed Centre which will go out to all U.B.O's and unemployed projects and will advertise the opening of the centre on 4th December.
- 3. Pensioners There is a great deal of good will towards Labour among the pensioners. I will be revisiting all the lunch clubs, bingo sessions, old folks homes, etc. which I went to during the campaign. We need to turn that support into membership. Perhaps the Membership Officer (as well as the relevant councillor) would come with me on these re-visits, possibly with a special leaflet urging pensioners to join the Party they support. Members of the Southwark Pensioners Action Group will help us with this campaign.
- 4. Women I think ours was the first Election campaign in which a special leaflet to women went in with the election address. I will be re-visiting the Mothers and Toddlers Clubs, schools etc. that I went to during the campaign. Perhaps with the women's sections we can produce a leaflet to recruit more women into membership and take them with us on visits to Mothers and Toddlers Clubs.
- There were two large articles about me Ethnic Minority Groups in the Greek language newspaper which is very widely read in the I don't know what they said! But I assume they Cypriot community. There are enough Cypriots in Peckham to make it well were friendly. worth having a registration/membership drive. I am sure we could find a member in the Cypriot community who would be our Greek Liaison Officer! Anstey Rice (Consort) and Jeremy Hawthorne helped arrange a letter to, and visits to black groups and the by-election campaign got universally supportive coverage in the black press. The Asian community supported us But we are still very much a white party. in the by-election. developed in the election campaign needs to be discussed and developed in the branches.
- 6. Peace movement Due to a problem with the word processor we were not able to contact directly all the CND members in Peckham. CND is not, of course, affiliated to the party, but it's important that Labour is seen as the party of peace. Perhaps the Labour Party members who are most active in CND and the Party officers and myself can discuss our future work on this vital issue, in addition to discussion in the branches.
- 7. Youth The youth leaflet, planned for inclusion in the envelope with the election address never appeared! We should try and do it now. The electoral register identifies young voters in the constituency. Perhaps, with the YS we can discuss the content and the possibility of getting it out through the wards.

- Council tenants Problems with Council housing are a major area of concern for people in Peckham. The new council has an excellent programme for attempting to deal with hold-ups on repairs and for devolving power and rights to tenants' associations. There are many Labour Party members in the Peckham tenants movement. Yet despite this the Party's involvement with tenants is not nearly as good as it should be. strategy for campaigning on housing is not really yet fully developed. I feel this ought to be a priority issue. Perhaps we should have a special GMC or EC discussion on the subject (if the officers feel that time permits) together with our councillors who are on the housing committee and Labour Party members who are active in their Tenants Associations. I know many branches are already discussing campaigning on housing at ward level and are using their newsletters to this effect - but we need, as well, a campaigning strategy at constituency level.
- 9. <u>Membership levels</u> Now that we have a record of all those who promised to vote Labour, plus a record of those who actually voted, we should be able to use visits by ward members to turn that support into membership.
- 10. Thank you for voting Labour leaflet would be an important follow-up to the election campaign.

The by-election effort put up by the Peckham Labour Party was magnificent. I know that the whole trade union and Labour movement was encouraged and impressed by the campaign. It was a real pleasure and privilege to be the candidate and my thanks are warmly extended to everyone in the Peckham Party. In particular I'd like to thank the person with the most difficult job - the Agent - Tony Goss!

REPORT - NOVEMBER, 1982

- 1. Following the by-election on 28th October, I "took my seat" on the 4th November, which was the earliest possible date I could do so. I was "introduced" by Jo Richardson, M.P. for Barking (and the only other London Labour woman M.P.) and Clive Soley, M.P. (who had been my parliamentary aide during the election).
- 2. I made my first speech the next day during the debate on that part of the Queen's speech which dealt with "inner cities." I emphasised the points we had made during the by-election about government policies being directly responsible for joblessnes poor housing, increased crime and the run-down of our inner cities. And that only socialist planning for peoples' needs will end the despair and hopelessness which is now growing.
- J. In my first weeks in parliament I have concentrated on building links with local organisations in the constituency and intervening in debates on matters of greatest importance to Peckham. This means I have drastically pruned my other commitments and am turning down dozens of invitations to meetings all over the country, from CLPs, Unions, students and women's groups. I will be trying to remain active on the NCCL Women's Committee, the Labour Co-ordinating Committee and within the TGWU, but I have had to resign from a number of committees and will only take up new ones if they are a matter of great priority. This will enable me to make work on constituency issues a priority in my first year in parliament.

4. <u>Pensioners</u>

- (a) On my first day in the House of Commons I received a delegation of London pensioners lobbying against standing charges.
- (b) Together with Jock Stallard, M.P., I have put down an Early Day Motion on the government's "claw back" on the pension. (An Early Day Motion is similar to a resolution and M.Ps are asked to sign it). I do not yet know how many signatures our EDM has attracted.
- (c) I spoke at the Southwark Pensioners Action Group AGM and was able to thank them for supporting Labour.

5. Transport

(a) The Government have introduced a Transport Bill which is the latest in the attacks on the Labour GLC's cheap fares policy. After liaising with the TGWU and the GLC Transport Committee, I spoke in opposition to the Bill. I had hoped to gain a seat on the Standing Committee considering the Bill but was unable to do so. Reg Race, M.P. is the only London Labour M.P. on the Committee and I am liaising with him in supporting amendments on the Bill.

Transport Cont'd

(b) I will be meeting with Terry Allen, TGWU Bus groups Officer, Ollie Jackson, TGWU Peckham Garage rep. and Penny Newall, Secretary of Liddle Ward, to discuss putting pressure on the GLC to extend the P3 route.

6. Privitisation of Public Services

The Government have introduced the Telecommunications Bill, which will hive off the profitable parts of British Telecom. The Bill threatens both jobs and services as well as spiralling prices. I have arranged to meet the Trade Union representatives in the telephone exchanges in Peckham and Walworth to discuss opposition to the Bill in Parliament and how the Bill will affect them at local level.

7. Women

- (a) I have tried to ensure that press coverage of my pregnancy highlights the inadequacies of childcare facilities not just for members of Parliament but for millions of working women trying to balance the commitment of young children and a job.
- (b) I have initiated a back bench women's committee of Labour M.Ps. Jo Richardson, M.P. will convene it and we expect to meet soon. The aim is to co-ordinate the activity of those in parliament concerned with women's issues and to provide a forum where women's organisations can come to call for support from sympathetic Labour women M.Ps. I hope the committee will support the work of our spokesperson on women Joan Lestor, M.P.

8. <u>Social Security</u>

Staff working in DHSS offices are finding it increasingly difficult to cope with the massive workload caused by soaring unemployment. The Civil Service Unions (SCPS and CPSA) have called a day of action on December 3rd and I will be attending the picket line of the Peckham DHSS offices and meeting with the members there to discuss further support.

9. The Council

(a) I have had extremely useful discussions with Alan Davies, the leader of Southwark Council and the Chief Executive as one using parliament to defend and support the Council's work.

The Council Cont'd

(b) It is rumoured that the Government plans to take over a prime site owned by Southwark and the GLC and force the Council to allow the Lysander company to develop it for shops and offices. The Council want to keep the site for much needed housing. I have enlisted the support of Gerald Kaufman, Labour's Shadow Housing Minister, and together we will be meeting the GLC and working with Southwark to oppose the Government's plans.

10. Surgeries

- (a) As discussed at the last meeting of the GMC, I am setting up an extra surgery. This surgery will be in addition to the two evening surgeries, but will be held during the afternoon to enable those who cannot get out in the evening to attend particularly pensioners and people with small children. It will be on the 2nd Friday of every month, 2-3.30 p.m. at Camden Tenants Hall.
- (b) Roy Kennedy (Newington Ward) and Peter Troy (Consort Ward) have very kindly agreed to help with my surgeries. The surgeries are so packed they last nearly 5 hours! I feel it is very important for party members to be involved in the surgeries so that there can be as much feed-back of the issues raised there as possible. Would anyone like to help with the Camden afternoon surgeries?

 Please let me know if you can.

11. Visits to the House of Commons

Clare Mundy, Francis Boyle and I are discussing plans for a Peckham Labour Party outing to the House of Commons.

Each M.P. gets 2 tickets on a regular basis. My next set are for December 13th. Please let me know if you'd like to come. I very much welcome seeing Peckham Labour Party members up here!

PECKHAM BY-ELECTION

REPORT TO T.G.W.U.

- 1. Harry Lambourn, Peckham's M.P., died suddenly in August, 1982 and the by-election was fixed for October 28th 1982. The Conservatives put forward John Redwood, who had previously stood for the Conservative Party in the GLC Election. The SDP candidate was former Labour Minister Dick Taverne.
- 2. The Peckham Labour Party and myself decided at the outset of the campaign to highlight Peckham's problems, and Labour's Socialist Alternatives on -

Jobs * Housing * Living standards * Peace

It was also agreed that in addition to the vital work of leafletting, canvassing and knocking-up, we would have a campaigning approach.

- 3. The support from the T.G.W.U. in the by-election campaign was magnificent and was very greatly appreciated both by myself and by the Peckham Labour Party.
 - (i) TGWU Camberwell Office This office became our Press headquarters where our Press Officer was based and where we held our daily Press Conferences. It was ideal for us to have a Press headquarters separate from our Party's Organisation headquarters. The daily Press Conferences throughout the campaign were very well attended and this meant that hordes of journalists started tramping into the TGWU office from first thing in the morning until late at night. I am very grateful to the TGWU Officers based at Camberwell who so willingly put up with the disruption to their work, and also to the office staff who were so helpful. Particular thanks must go to Terry Allen who as well as co-ordinating the office facilities, was of considerable assistance to the Press campaign.
 - (ii) 20 per cent of the electorate in Peckham are over 65 and we, therefore, had a special pensioners campaign. This consisted of a leaflet specially directed at pensioners (copy is attached); a team of pensioners going round the constituency in the TGWU mini-bus canvassing other pensioners and visiting OAPs lunch clubs, pop-ins and bingo sessions.

Peckham By-Election Report to TGWU Cont'd

The TGWU Retired Members' Association gave marvellous support to this initiative, as did Jack Jones, who is President of the Southwark Pensioners Action Group, and who spoke at our eve of poll rally. Particular thanks must go to John Newe, the full-time Officer who was mainly responsible for co-ordinating the pensioners' campaign, together with Margaret Davies of the Brighton Co-Op.

- (iii) Peckham contains three large bus garages, Peckham,
 Walworth and Camberwell. Ollie Jackson, TGWU Bus Rep.
 from Peckham Garage, took us round these garages and also
 to New Cross bus garage, to help mobilise support.
- (iv) In and around the Peckham area there are a number of large hospitals, including St. Thomas's, Guys, Dulwich, King's College Hospital, The Maudsley, St. Giles and New Cross hospital. Aubrey Edwards, (TGWU Health Service Officer) greatly assisted in the by-election campaign by ensuring that our leaflets went to all TGWU members working in those hospitals and also assisted in arranging for me to address mass meetings.
 - (v) We received tremendous help with the vital work of canvassing, leafletting and knocking-up both from lay members of the TGWU and also from full-time Officers. In particular, on the day of the election a very large number of officers came and assisted with the work, including taking people to the polling station by car and using loudspeakers.
- (vi) Jack Dromey (TGWU Officer) was responsible for co-ordinating the efforts of the Trade Union Movement in London to help with the by-election campaign and did a magnificent job of mobilising help including, in particular, the campaign of leafletting with a special leaflet on Unemployment outside the Unemployed Benefit Offices. Jack helped prepare and was responsible for the printing and distribution of leaflets on Unemployment, the Health Service, and the pensioners (see attached). The work that Jack Dromey and the other Officers put into the Peckham by-election campaign has gone a long way to cement good relations between the industrial and political wings of the Party at local level and has replaced a relationship which was sometimes rather distant, with a firm intention of working closely together in the future.

4. Trade Unions for a Labour Victory (London)

TULV was most helpful in providing the enormous resources of equipment (microphones, photo-copiers, typewriters, etc.) required at short notice in a by-election campaign. It was also through TULV (London) that Trade Union help was put into the wards, arrangements were made to use Trade Union in-house printing facilities and a great deal of fund-raising was done. I believe this is the first by-election campaign TULV (London) has been involved in and it certainly proved the vital role that TULV can play.

- 5. The Peckham Labour Party has some 350 members, many of whom actively helped in the election campaign and we had a local agent. We were also greatly assisted by full-time Officers from London Region and received a great deal of help from London Labour M.Ps, M.Ps from outside London and from Labour Parties throughout the country.
- 6. The result of the by-election was as follows :-

7. At the previous General Election Harry Lambourn for Labour had a majority of nearly 11,000 over the Conservatives, who came second. In the by-election the Conservative vote collapsed and John Redwood lost his deposit. Most of the Conservative vote went to the SDP. Part of the reduction in our majority was due to the SDP taking 10% of the Labour vote. Partly the reduction in the majority for Labour was due to the low turn-out. Peckham characteristically has much lower turn-outs for elections than the rest of the country. At the by-election in 1972, in which Harry Lambourn first got into Parliament, the turn-out was only 29%! We were very pleased that despite the low turn-out, Labour took over 50% of the votes cast but we cannot be complacent about the result and the Party has, therefore, embarked on a comprehensive programme of campaigning leading up to the General Election, which we hope will involve cementing our relations with the Trade Union Movement, as well as building our relations with the Tenants' Movement, the pensioners and the unemployed in the area.

REPORT - DECEMBER, 1982

I hope everyone had a good break over Christmas and the New Year.
 No party deserves it more, having fought 2 elections in one
 year - as well as all the day to day work. I'd like to warmly
 thank the party for all your support over the past 12 months.

This year will probably see a General Election. Our major task will be to win the mass of people to our policies and to work closely with the community on issues which affect them. The only way we will win the next election is to convince people that Labour provides a credible alternative to the Tories. The next election will be vital, the consequences of defeat would be dire and the election is likely to determine the shape of politics in this country for a decade to come. Another 5 years of Thatcherism would spell disaster for working people and set further back the cause of world peace.

2. Unemployment


New figures produced by Southwark Council show that, for the first time, unemployment in Southwark has gone over 20,000. The rate of registered unemployment among men has also for the first time, gone over 20%. The rate of female unemployment has also risen sharply.

In response to a Parliamentary question I put down to the Minister for Employment, the Government have revealed that between April 1979 and October 1982 the number of long term unemployed (over 52 weeks without a job) rose by 211%.

I attended the opening of the new Southwark Unemployed Centre in December and will be working with the Centre in the future.

3. Women

- The Campaign is a really excellent initiative, started by unemployed women in Greenwich. They have discovered that literally hundreds of millions of pounds of Unemployment Benefit remains unclaimed by women. The Campaign aims to urge women to claim and highlight the enormous hidden problem of unregistered female unemployment. On behalf of the Campaign I hosted a press conference in the House of Commons; have tabled 13 Parliamentary questions; spoke for them on "You and Yours" on Radio 4 and to the New Standard. Jointly with the GLC 100,000 leaflets will be produced for distribution in London. I hope to liaise with the Women's Sections about future work on this vital issue.
- (b) I spoke in the debate called for by the Labour Party, in the House of Commons, on the effect of the recession on women concentrating on measures that must be taken to ensure a more equal share of work in the home, such as shorter hours of work and more childcare facilities.



4. Transport

The TGWU bus workers tipped us off that London Transport plans to change from the flat fare of 30p to a graduated fare from 20p - 40p on the P3, P4 and P5 routes on January 29th, 1983. For many this would mean a 33% increase in fares.

Jointly with the TGWU Camberwell Office, I organised a quick delegation to protest to Dave Wetzel, Chair of the GLC Transport Committee, and to urge him to set up the new route from Peckham to the Elephant. The Delegation consisted of bus workers, representatives from the Labour Party wards most directly affected (Ann Hayley - Friary and Penny Newall - Liddle), Gloucester Grove Tenants Association, Kate Hoey, Labour candidate for Dulwich, Tony Goss (Vice-chair Southwark Transportation Sub-Committee) and Southwark Transport Campaign. We have yet to hear whether the GLC will be able to stop LT putting the fares up but follow-up campaigning on this will be very important. I'll be raising this at Southwark Transport Campaign's meeting on 10th January.

5. Ireland

- (a) I introduced a mini-debate on the use of plastic bullets in Northern Ireland by means of a question for oral answer to the Minister for Northern Ireland and I have sponsored the forthcoming Connolly Association conference on working for a united Ireland and the conference in Manchester on plastic bullets.
- Party effective, I think it is very important to vote according to the Labour Whip. But I am totally opposed to the Emergency Provisions Act, which denies the right of jury trial for terrorist offences in Northern Ireland and which has never properly been debated by Parliament, as it was supposed to be a temporary, short-term measure. So I voted against the whip in opposing the renewal of the Act on the ground that it fuels terrorism by further undermining confidence in the courts and makes a political solution more difficult to achieve. I also intend to vote against the Prevention of Terrorism Act, which comes up for renewal in January on broadly similar grounds (unless I am in labour!)

6. Immigration

- (a) The Home Office's hard-hearted attitude to deporations together with racist and sexist nationality provisions, have produced some tragic situations for families in Peckham. I have been doing my best, together with the Joint Council for the Welfare of Immigrants, to try and stop deportations and the break up of families.
- (b) I spoke in the debate on the proposed new Immigration Rules

Immigration Cont'd

on the plight of children who, although previously entitled to citizenship, will be made stateless by the new rules.

7. Building Unions

At the request of the building unions in London and the South East, the South East Region of the TUC convened a meeting of London Labour M.Ps and the building unions to discuss a major new initiative in the new year. The building unions will be aiming to fight back against the increase of "labour only" sub-contracts and attacks on unionisation in the industry by a campaign to be launched on sites in the City. I have arranged for the Tribune Group (which I have joined) to support this initiative with press statements, advertisements, speaking at site meetings and picketing and I hope that the London Labour Group of M.Ps will do likewise.

8. The Southwark Site - Lysander

Environment Minister, Michael Heseltine, has announced he will be taking this site in Bermondsey from the Council and giving it to the London Docklands Development Corporation, in order to allow building for offices, hotels, shops and housing. Southwark Council want to keep the site for housing.

After a meeting at the GLC, I issued a press statement, together with Gerald Kaufman (Shadow Housing Minister for Labour) and George Nicolson (GLC Councillor, Bermondsey), saying that Labour will strenuously oppose the "vesting order" Heseltine intends to put through Parliament.

9. Black People

I had an extremely useful meeting with the Southwark Black People's Association and will be putting down some Parliamentary questions for them about the involvement of black people in tenants' consultative procedures at national level.

- 10. I have agreed to do a regular column both in Labour Weekly and Walworth Inprint. Any ideas for or comments on the columns will be very welcome.
- 11. I attended a large number of Xmas Socials, including the Trades Council, the Women's Sections and the excellent Peckham Labour Party dance in Warwick Hall. I also popped in to the People's Care Association dinner at Dulwich Baths and the Friends of Walworth Association dinner at the Aylesbury Day Centre. The work that Party members do for these events in ensuring a good day for pensioners who otherwise would spend the day alone is really magnificent. The efforts particularly of Ron & Sylvia Slater and George and Lil Smith and Jim Greening are outstanding.

12. With my baby due in February I am noticeably slowing down. I shall be making arrangements to ensure cover for all urgent work around the time of the birth. There is no maternity leave for M.Ps - but I hope to sort out a reasonable period of absence with the Peckham Labour Party Officers and with the Labour Party Whips in the House of Commons. My Secretary, Leonie Foulkes, will continue to be available on 219 4218.
