A scholarship can help you get on your way to achieving your study goals by assisting with an array of costs, including textbooks, tuition fees, accommodation and living expenses. But there are many more benefits of applying for a scholarship. Many of the vital skills required when applying for scholarships are the same skills required for successful job applications. You can also add your scholarship award to your resume. Some scholarships offer opportunities to undertake paid work experience with your scholarship donor or sponsor, play sport, travel overseas or perform.

Confidence is also gained from a successful scholarship application, giving you belief in your skills and ability. There is recognition and prestige associated with being awarded a scholarship.

It is astounding that people can access any song or video in the world in no time, but struggle to find scholarship opportunities. My advice is to investigate your options early, as the amount of information to read and applications to complete can be overwhelming.

By producing this booklet, I hope to provide students and their families with a sample of some of the scholarships that are available and offer links to find them. These links may lead you to discover other scholarship opportunities.

I encourage every student to investigate whether they may be eligible for a scholarship and wish you well in your application.

## **TAFE Queensland Merit Scholarships**

Merit scholarships are awarded to students who have achieved outstanding academic merit or demonstrate strong work performance along with the demonstrable desire to secure ongoing employment in the industry in which they have applied for the scholarship. Scholarships are available across a wide range of study areas. A full list of eligible TAFE Queensland courses can be found at [scholarships.tafeqld.edu.au](https://scholarships.tafeqld.edu.au).

Eligibility:

To be eligible to apply for a scholarship, you must be:

- An Australian citizen or Australian permanent resident (certified evidence must be provided);
- A current student enrolled or a prospective student intending to enrol in an approved TAFE Queensland qualification for the next period of study.

The TAFE Queensland Scholarships are awarded subject to the TAFE Queensland - Scholarship Programs Terms and Conditions which can be found at [scholarships.tafeqld.edu.au](https://scholarships.tafeqld.edu.au).

## **TAFE Queensland Access & Equity Scholarships**

Access and equity scholarships provide equitable access to study at TAFE Queensland. They are awarded to students who can demonstrate a genuine interest in and commitment to their chosen career and identify themselves with one or more of the following categories:

- Aboriginal or Torres Strait Islander descent;
- Significant caring responsibilities;
- A disability or long-term medical condition or illness;
- Long-term unemployed (longer than 6 months);
- Sole parent;
- Suffering significant financial difficulties or social barriers to study;
- Another specified disadvantage.

Eligibility:

To be eligible to apply for a scholarship, you must be:

- An Australian citizen or Australian permanent resident (certified evidence must be provided);
- A current student enrolled or a prospective student intending to enrol in an approved TAFE Queensland qualification for the next period of study.

The TAFE Queensland Scholarships are awarded subject to the TAFE Queensland - Scholarship Programs Terms and Conditions which can be found at [scholarships.tafeqld.edu.au](https://scholarships.tafeqld.edu.au).

## TJ Ryan Memorial Medal & Scholarships

Up to 10 TJ Ryan Memorial Medal and Scholarships are awarded each year, to support exemplary Queensland students to pursue tertiary studies.

State and non-state secondary schools can nominate **one** high achieving year 12 student for this award. Nominees should demonstrate outstanding leadership in their school and community and academic excellence.

The TJ Ryan Memorial Medal represents a long-standing tradition of recognising educational achievement in Queensland. The award is a memorial to Thomas Joseph Ryan, former teacher, barrister and Queensland Premier (1915–1919), and are provided to students who demonstrate a strong commitment to high academic achievement and outstanding leadership in both their school and the local community.

Each year, the Queensland Department of Education awards:

- up to 10 TJ Ryan Memorial Medallists:
- a scholarship of up to \$10,000 over 5 years
- a certificate of recognition
- up to 5 TJ Ryan Highly Commended awards:
- a one-off cash payment of \$1,000
- a certificate of recognition
- up to 20 TJ Ryan Merit awards:
- a certificate of merit.

## Veteran Dependent Scholarships

If your parent served in the ADF, you might be eligible for a scholarship to support your tertiary studies and help you achieve your career aspirations. RSL Queensland Scholarships provide financial support to students who have overcome challenges in their lives and demonstrated their determination to gain a tertiary qualification.

Children of ex-serving ADF personnel are eligible to apply. In your application, you will need to include:

- information about yourself and the ex-serving ADF member you are related to, including service history and age;
- your academic results and background;
- details of your family's financial situation.

Ongoing eligibility criteria also applies.

The Veteran Dependent Scholarships program is managed by the Australian Veterans' Children Assistance Trust (AVCAT) on behalf of RSL Queensland. Contact AVCAT directly to apply.

## Upskilled Education Scholarship

In an endeavour to provide ongoing support and commitment towards the knowledge economy of Australia, Upskilled is providing a scholarship to the value of \$2000 to help with costs surrounding tuition, textbooks, laptops, etc across all disciplines.

The scholarship is **open to all students** over 18 (both Australia-based and international) who have a desire to learn and develop their education. **You must be currently studying** at a registered training organisation or university.

## UQ Link Scholarship

This scholarship provides assistance to students who have experienced educational disadvantage as a result of financial hardship, who are undertaking tertiary studies for the first time.

QTAC applicants approved for UQ Link receive 5 entry rank adjustments to assist with their entry to UQ. After enrolling, scholarship recipients receive \$3,000 per year, which may be held for up to 3 years. In the first semester of enrolment, \$500 of the scholarship value for the year is paid at the beginning of semester to assist with up-front costs associated with coming to university. After this initial payment, the scholarship is paid in semester instalments after full-time enrolment at UQ and ongoing eligibility are confirmed.

## Aspire Scholarship

The purpose of the scholarship scheme is to provide assistance with transition to tertiary study to students in their first year of study who have experienced financial hardship and are commencing a relevant program at The University of Queensland.

Funded by the many thousands of gifts to the Scholarship Endowment Fund and the Aspire Scholarship Fund, these scholarships will grow to help increasing numbers of students during their university studies.

This scholarship scheme supports students who have demonstrated significant financial disadvantage through achieving the maximum points for the 'Financial Hardship' category of QTAC's Educational Access Scheme, and are eligible for a **UQ Link Scholarship**.

As being in receipt of a 2020 UQ Link Scholarship is a requirement for eligibility for the **Aspire Scholarships, Aspire Residential-JD Adams Memorial Scholarships and UQ Senate Create Change Residential Scholarships**, applicants only need to complete and submit **one Aspire Scholarships application form** to be considered for all or any of the three scholarships.

## CQUniCares Kestrel Coal Scholarship

CQUniCares Kestrel Coal Scholarship assists students with expenses associated with studying at university. Those expenses can include non-deferrable costs such as textbooks, uniforms, computer equipment and internet access, specialised equipment, childcare, income supplement, travel and accommodation costs associated with compulsory residential schools and unpaid work placements.

To be eligible to receive a CQUniCares Kestrel Coal Scholarship successful applicants must be enrolled in one of the following courses (or double degree): Bachelor of Accounting, Bachelor of Business, Bachelor of Environmental Science, Bachelor of Information Technology/IT Co-op, Bachelor of Occupational Health and Safety or Bachelor of Science. Applicants must also be residing and studying in Queensland. ## Aspire Residential Scholarship

This scholarship assists students from a regional or rural background to undertake undergraduate studies at The University of Queensland.

It was established in 2018 through a bequest to the University under the will of John Dugald Adams, a long time donor and a Bachelor of Commerce graduate of this University from 1961, who died in 2017.

You are eligible for this scholarship if you:

- apply by the closing date for applications,
- will be a domestic student in the year of award in accordance with the University's Fee Policy,
- intend to enrol as a commencing student in any Bachelor program at UQ in the year of the award,
- have not completed any prior tertiary study at bachelor level or higher, and

All applicants will be considered for the **JD Adams Memorial Scholarship**. In addition to the above, you are eligible for the JD Adams Memorial Scholarship, if you:

- are from a rural or regional background, and
- have demonstrated educational disadvantage as a result of financial hardship as determined by QTAC's Educational Access Scheme. To meet this eligibility requirement, applicants will be in receipt of a 2020 UQ Link Scholarship.

## UQ Senate Create Change Residential Scholarship

The purpose of the UQ Senate Create Change Residential Scholarship is to encourage and support high achieving financially disadvantaged students to undertake undergraduate studies and live as a resident on campus at The University of Queensland.

An applicant is eligible for a Scholarship, if the applicant—

- applies for the Scholarship by the closing date for applications;
- will be a domestic student in the year of award in accordance with the University's Student Fees Policy;
- intends to enrol as a **commencing student** in any Bachelor program in the first semester of the year of the award;
- has not completed any prior tertiary study at bachelor level or higher;
- achieves an **OP1 – OP6**, or equivalent;
- has a **residential place confirmed** with an approved accommodation provider located on a UQ campus; and
- has demonstrated significant financial disadvantage through achieving the maximum points for the 'Financial Hardship' category of QTAC's Educational Access Scheme.

To meet the eligibility of (d) and (g), applicants will be in receipt of a 2020 UQ Link Scholarship.

### CQUniCares GWI Scholarship

CQUniCares GWI Scholarship assist students with expenses associated with studying at university. Those expenses can include non-deferrable costs such as textbooks, uniforms, computer equipment and internet access, specialised equipment, childcare, income supplement, travel and accommodation costs associated with compulsory residential schools and unpaid work placements.

To be eligible to receive the CQUniCares GWI Scholarship an applicant needs to meet the following criteria:

- Enrolled or intending to enrol at CQUniversity in Term 1, 2020
- Be a first year student
- Be enrolled in any Bachelor course
- Be enrolled with a minimum term study load of 12 credit points or more
- Be able to demonstrate low personal/family income or financial need
- Be an Australian citizen, permanent resident, holder of a Humanitarian Visa or New Zealand citizen with a permanent home address in Australia
- Be enrolled at Census date of Term 1, 2020
- Not be in receipt of another CQUniversity Scholarship of similar or higher value

Preference will be given to applicants who:

- Are the first in their immediate family to attend University;
- Speak English as Second Language;
- Are of Aboriginal and/or Torres Strait Islander descent;
- Have a formally diagnosed disability, medical or mental health condition;
- Reside and study in a remote or regional location.

### CQUniCares Adam Scott Foundation Scholarship

This scholarship fully funds the tuition and amenities fees of a deserving first year student who, without this support, would not be able to attend university. Recipients can enrol in any academic discipline and will receive support for the duration of their course.

The CQUniCares Launch Scholarship assists students from low SES backgrounds with expenses associated with undergraduate study. Those expenses can include non-deferrable costs such as textbooks, uniforms, computer equipment, internet, equipment or travel costs associated with compulsory residential schools and unpaid work placements.

To be eligible to receive the CQUniCares Launch Scholarship successful applicants must:

- be identified as low SES in the current term of study with CQUniversity
- be enrolled or intending to enrol in an undergraduate course as the primary course of study in Term 1, 2020: Bachelor; Associate Degree; Advanced Diploma; Diploma (higher education).

### CQUniCares Accommodation Scholarship

The CQUniCares Accommodation Scholarship assists students from low SES backgrounds with expenses associated with relocating for the purpose of undertaking internal studies at CQUniversity Rockhampton or Mackay campuses. To be eligible, successful applicants must:

- be identified as low SES in the current term of study with CQUniversity
- be enrolled or intending to enrol in an undergraduate course as the primary course of study in Term 1, 2020: Bachelor; Associate Degree; Advanced Diploma; Diploma (higher education)
- be relocating to live on-campus at either Rockhampton or Mackay due to the course not being available by distance.

### CQUniCares Student Success Scholarship

### Rural and Regional Enterprise Scholarships

The Rural and Regional Enterprise Scholarships Program supports students with the costs of studying at university or at a vocational education and training institution. Scholarships are for qualifications from Certificate IV; Diploma; Advanced Diploma or Associate Degree; Bachelor Degree; Bachelor Honours Degree, Graduate Certificate or Graduate Diploma; Master Degree or a Doctoral Degree.

### Charlie Bell Scholarship for Future Leaders

### Sir Samuel Griffith Scholarships

High-achieving commencing students who are expecting to receive an OP 1–3 or ATAR equivalent can apply for this scholarship to Griffith University.

To be eligible you must:

- Be an Australian Citizen or Australian Permanent Humanitarian Visa Holder; **or**
- an Australian Permanent Resident, New Zealand Citizen or International student who is completing or has completed Years 11 and 12 in Australia.
- be a student commencing University for the first time ever in trimester 2 2020.
- have NOT undertaken/commenced any tertiary study (Bachelor award) with the exception of those undertaken as part of Year 11-12 studies (eg. Enhanced Studies Program); and
- Have applied to commence Griffith University in trimester 2 2020.
- Meet the eligibility criteria for degree program and receive and accept an admission offer
- Achieve a result which places you in the range of the OP Band 1-3 (including International Baccalaureate (IB) and interstate equivalents or an equivalent Australian Tertiary Admissions Rank (ATAR). Bonus ranks do not apply.
- current year 12 school leavers: You will also be required to upload your OP/ATAR/IB results.

## TAFE Queensland Indigenous Pathways Scholarships

Reduce study costs with tuition support to the value of \$5000 through Advance Queensland and TAFE Queensland. The Advance Queensland - TAFE Queensland Indigenous Pathways Scholarships initiative focuses on growing the economy and supporting students to obtain qualifications to pursue their chosen careers in science, technology, engineering, arts and maths (STEAM) industries.

Eligibility:

To be eligible to apply for a scholarship, you must be:

- Of Aboriginal or Torres Strait Islander descent;
- A Queensland resident for the duration of the scholarship;
- A current student enrolled or a prospective student intending to enrol in an approved TAFE Queensland qualification for the next period of study.

To apply for an Advance Queensland - TAFE Queensland Indigenous Pathways Scholarship, you will need to complete the online application form which can be found at [scholarships.tafeqld.edu.au](https://scholarships.tafeqld.edu.au). Scholarships will be assessed and awarded annually, for start of study in Semester 1 the following year.

## Indigenous Commonwealth Education Costs Scholarship

Provides assistance with education costs to Aboriginal and/or Torres Strait Islander students who are enrolled in an Approved Program. A recipient may not concurrently be receiving a Startup Scholarship or Startup Loan from Centrelink or an ICECS from UQ or another institution. The scholarship is valued at \$1500 for each semester in which the Scholarship is held for recipients enrolled full-time. The Scholarship will be paid pro-rata where a recipient is enrolled part-time.

An applicant is eligible for the award of an Indigenous Commonwealth Education Costs Scholarship (UQ-ICECS) in a year, if the applicant—

- is an Australian citizen;
- is a person of Australian Aboriginal and/or Torres Strait Islander descent who identifies as an Australian Aboriginal and/or Torres Strait Islander person and who is accepted as such by the community in which they live or have lived;
- provides 'confirmation of Aboriginal and/or Torres Strait Islander status' under the common seal of an incorporated community organisation. Other forms of documentation may be considered where exceptional circumstances apply;
- is enrolled in an UQ Approved Program in the semester of the award; and  
is not concurrently receiving assistance from another Commonwealth source for the same purpose  
(For example: an ABSTUDY start-up loan or a student start-up loan from Centrelink).

## Indigenous Commonwealth Accommodation Scholarship

Provides assistance with relocation and/or accommodation costs to Aboriginal and/or Torres Strait Islander students. A recipient may not concurrently be receiving a Relocation Scholarship (or any scholarship for the purpose of assisting with accommodation costs) from Centrelink or an ICAS from UQ or another institution. The scholarship is valued at \$2500 for each semester in which the Scholarship is held for recipients enrolled full-time. The Scholarship will be paid pro-rata where a recipient is enrolled part-time. An applicant is eligible for the award of an Indigenous Commonwealth Accommodation Scholarship (UQ-ICAS) in a year, if the applicant—

- is an Australian citizen;
- is a person of Australian Aboriginal and/or Torres Strait Islander descent who identifies as an Australian Aboriginal and/or Torres Strait Islander person and who is accepted as such by the community in which they live or have lived;
- is from a Regional or Remote area;
- provides 'confirmation of Aboriginal and/or Torres Strait Islander status' under the common seal of an incorporated community organisation. Other forms of documentation may be considered where exceptional circumstances apply;
- is enrolled in an UQ Approved Program in the semester of the award; and  
is not concurrently receiving assistance from another Commonwealth source for the same purpose  
(For example: a relocation scholarship payment from Centrelink).

## Lambert McBride Perpetual Bursary

The Lambert McBride Perpetual Bursary is named in honour of the late [Lambert McBride](#), an Aboriginal advocate and lobbyist for Queensland Indigenous rights. Mr McBride believed in the value of education for progress and encouraged Indigenous people to get a good education. This bursary provides the opportunity for 1 Indigenous tertiary student studying in any field at an eligible Queensland higher education institution to continue Mr McBride's legacy through a one-off grant of \$5000 to assist with study expenses, such as a computer, textbooks or stationery.

The funds will be paid as a lump sum after confirmation of enrolment in the semester following the award of the bursary.

To be eligible to apply for this bursary, candidates must provide:

- written evidence of being recognised as a member of an Aboriginal and/or Torres Strait Islander community
- evidence of having completed (or will soon complete) first or second year of study in any field at an eligible Queensland higher education institution in the current calendar year (i.e. 2019).

## ADCO Sports Excellence Program

The ADCO Sports Excellence Scholarship awards sporting scholarships to outstanding sports men and women from around Australia with the chance to help fund their tertiary studies at Bond University.

Eligibility:

- Available to domestic students applying for a single undergraduate or postgraduate degree at Bond University (with the exception of the Bond Medical Program, Doctor of Physiotherapy, Master of Psychology, and Master of Creative Arts).
- Applicants must demonstrate outstanding and current involvement in their chosen sport (preference given to Olympic sports) via a detailed sporting resume and submission of at least two relevant references.
- Applicants must demonstrate strong leadership capabilities.
- Applicants must meet the prerequisites and the admissions requirements for their chosen degree

## Pearl Duncan Teaching Scholarship

If you identify as Aboriginal and/or Torres Strait Islander and are studying or intend to study an undergraduate or postgraduate teacher qualification, the Pearl Duncan Teaching Scholarship might be right for you.

Designed to support aspiring teachers, this scholarship provides financial benefits and the chance to gain valuable experience and skills teaching in a supportive environment while you study, and after graduation.

As a Pearl Duncan Teaching Scholarship recipient, you could receive:

- up to \$20,000 (before tax) to help you with study and related expenses; and
- permanent employment as a teacher in a Queensland state school when you graduate.

This scholarship offers support to aspiring teachers in the following categories:

- Secondary school graduates (up to \$20,000 before tax) – You must have completed Year 12 and be commencing or continuing an undergraduate initial teacher education program (such as a Bachelor of Education) in the first semester of the year after you graduate Year 12.
- Postgraduate students (up to \$10,000 before tax) – You must already hold a degree in a relevant field and be commencing or continuing a postgraduate initial teacher education program (such as a Master of Teaching).
- Department of Education employees (up to \$20,000 before tax) – You must be employed in a non-teaching role with the Department of Education and be commencing or continuing an undergraduate or postgraduate initial teacher education program.
- Post-school studies (up to \$20,000 before tax) – You must be commencing or continuing an undergraduate or postgraduate initial teacher education program and do not meet the eligibility criteria for any of the other categories, eg career changers or mature age students.

## Aspiring Teacher Grant

If you have decided to become a teacher, the Aspiring Teacher Grants will help you to get started.

If successful, you will receive a one-off lump-sum payment of \$2500 for general applicants or \$5000 for rural or remote residents during the first semester of study to assist with study-related expenses.

For students from rural or remote communities, the funds can assist with additional expenses incurred, when moving from your home to undertake study. Funds will be paid after confirmation of enrolment in an eligible initial teacher education course (ITE).

To apply for an Aspiring Teacher Grant, you must:

- Be an Australian or New Zealand citizen or have permanent residency status in Australia;
  - Successfully complete Year 12 at any Queensland school during the current calendar year;
  - Obtain an Overall Position (OP) of between 1 and 6 (or equivalent);
  - Commence an initial teacher education program at a Queensland university or tertiary institution in the first semester of the year after you graduated Year 12;
  - Not have already accepted one of our other scholarships or grants to support your tertiary studies.
- In addition to the general eligibility criteria above, rural or remote applicants must also reside within the catchment of a Queensland state school with a transfer rating of between 3 and 7 as per the Department of Education schools directory.

Priority selection will be given to Aboriginal and Torres Strait Islander students and students who reside in drought affected communities.

## Beyond the Range Professional Experience Grant

The Beyond the Range Professional Experience Grant supports you to experience living and teaching in a priority community across Central Queensland, Darling Downs-South West, Far North, or North Queensland regions.

You could receive up to \$5000 per professional experience placement (including internships) during Semester 1 and/or Semester 2 each year to assist you with travel, accommodation and other placement-related expenses. You may only receive a maximum of 2 grants per semester.

To apply for a grant, you must:

- Be currently enrolled in your second, third or fourth year of an undergraduate initial teacher education (ITE) program or your first or second year of a postgraduate ITE program at an Australian university or tertiary institution; and
- Be planning to undertake a placement in a Queensland state school that is located at least 90 minutes travel each way from your primary residence while at university and within a priority community in our Central Queensland, Darling Downs-South West, Far North Queensland or North Queensland region and
- Provide evidence of a current Queensland Working with Children Check Blue Card.

## Future Teachers Bursary

If you're in Year 11 or 12 and want to become a teacher, some Higher Education Institutions offer programs that allow you to start studying subjects toward your teaching degree before you graduate high school. If you have been accepted into one of these programs, additional financial and peer support is available to get you started in your teaching career with the Future Teachers Bursary. You can finish your teaching degree faster as you will have completed some of the required tertiary subjects while you're still at school.

The cost of the subjects you study while at school will be covered. Generally, universities cover payment for the first unit you complete. If the cost isn't already funded, the Future Teachers Bursary will cover the total cost of the tertiary unit. You will also receive up to \$200 to help cover study costs related to your program. This may include textbooks, stationery, photocopying, and campus visits.

To apply you must:

- be a secondary student completing Year 11 or 12 at a Queensland state school, and
- be accepted into, and studying, eligible education units through one of the following approved programs CQUniversity Start Uni Now (SUN), Queensland University of Technology Start QUT, University of Southern Queensland Head Start and University of the Sunshine Coast Headstart.

## Rural & Remote STEM Graduate Teacher Scholarships

Start your teaching career with permanent employment and a one-off payment to assist you with study and employment expenses like paying off your HECS debt, professional association and union fees, or other beginning teacher expenses, such as teaching resources.

Each year, scholarships are offered to graduating primary or secondary pre-service teachers who are willing to teach STEM in a rural or remote Queensland state school.

If successful, you could receive:

- a one-off taxable financial payment to assist you with study and employment expenses; and
- an offer of permanent employment in a priority region including Central Queensland, Darling Downs-South West, Far North Queensland or North Queensland.
