**WHEREAS** the UCLA Labor Center was established in 1964, and for close to 60 years has existed as an important resource for research, teaching, and serving unions and workers of California and has made historic contributions to improving the working class, immigrants, and communities of color; and

### **Hotel Workers' Rights and Protections**

**WHEREAS** when the COVID-19 pandemic first hit, 95% of hotel workers were laid off, many left without healthcare or job security; these workers are overwhelmingly immigrants and women of color who have dedicated decades of service to the industry; and

**WHEREAS** hotel workers will face new challenges as front line workers in a returning tourism business, they will also face the chronic problems of sexual assault and other threatening conduct, lack of job security, mandatory overtime and lack of fair compensation for increased workloads; and

**WHEREAS** as the economy begins to reopen, we must ensure a just and equitable recovery for hotel workers;

**THEREFORE BE IT RESOLVED** that the Los Angeles County Democratic Party stands with hotel workers and calls for improvements of worker rights and protections, such as worker retention protections to ensure job security, rights to return to work in order of seniority, protections against sexual assault and other threatening conduct, adequate compensation for increased workloads, protections against excessive mandatory overtime, and standardized training for all hotel staff on worker safety, public health requirements, and the rights as employees; and

**BE IT FURTHER RESOLVED** the Los Angeles County Democratic Party joins in the call for fair compensation and improved employee rights and protections for hotel workers.
