Whereas not all SOEs interpret this to allow close enough proximity to facilitate verification of voter identification or decisions made by the clerk reference voter issues; and

Whereas the recently enacted Texas legislation referencing poll watchers allows them free movement throughout the polling place and close enough proximity to poll officials to properly perform their over watch functions; now, therefore, be it

Resolved that the Lake County Republican Executive Committee DEMANDS the legislature clarify what "reasonably necessary" means in order for the poll watcher to be able to observe the electors' signature and photo and be privy to the clerk's decisions regarding voter issues either through legislation or administrative directive.
