**Picking a Comprehensive Plan Team:  
Get Answers April 7, 6pm, Conley-Guerrero Center**

Sure, it sounds like a snoozefest, but a Comprehensive Plan is arguably the most important document a city can create. A well-considered Comprehensive Plan provides a blueprint for how we grow and what matters most to us as a community. Whatever we put on paper today will determine how we live tomorrow – so we sure as heck better pay attention when it happens.

Liveable City has long supported the concept of a Comprehensive Plan, as have the City's Planning Commissioners, many of whom pulled yeoman's duty to initiate this vital project. Of course, community buy-in is a key element in any successful planning effort – so we were more than a little surprised when city staff announced residents would have only five days to vet the finalist teams before the city picked a firm to lead the project. As one observer noted, this was the same time it would take to approve a hammer purchase. To make matters worse, three of the five days fell over a holiday weekend and available information on the three finalists was scant.

Working with other community leaders, Liveable City argued for more detailed information about the finalist firms and a reasonable length of time in which to evaluate it. As a result, Austin City Council members postponed the decision and instead hosted a March 4th forum to gather questions from concerned residents to be submitted to the finalist teams.

Responses will be publicly available March 27, with a second Community Forum scheduled for Tuesday, April 7, at the Conley-Guerrero Center, 808 Nile Street. City Council will vote on the finalists April 23, in what many hope will be a more informed decision.

**Troubling Trends:  
Comprehensive Housing Market Study**

On March 5<sup>th</sup>, the Austin City Council heard some sobering facts about the dwindling stock of affordable housing and its effects on our community. The Comprehensive Housing Market Study, produced by BBC Research & Consulting of Denver, painted a disturbing picture:

- Austin housing costs increased 85% over the last 10 years.
- Austin workers – especially retail workers – are being pushed out of town by high housing prices.
- Recent UT grads and young people are leaving Austin due to high housing costs.
- Austin lacks affordable housing for 29,000 households.
- To improve the situation, Austin needs to add at least 1000 new housing units a year affordable to households earning \$20K or less.
- 23 separate ordinances related to development in the last 18 months have increased development costs.

The research group offered ten recommendations to combat these trends, including elements that should logically fall within the scope of Austin's upcoming Comprehensive Plan (see above). As the Comp Plan moves forward, Liveable City will be working hard to ensure that affordable housing and other important social needs are fully addressed. We hope everyone who calls Austin home will do the same.

### **Public School Accountability: Why Closing Schools Is Not The Answer**

After months of public discussions in communities around the state, one thing is clear: Texans of all political stripes agree that our current school accountability system simply isn't working.

In recent months, Liveable City's Education Committee has been partnering with Save Texas Schools, a growing coalition local of parents, educators and community leaders to push for real reform in Texas' school accountability laws. The group has targeted a 2006 Texas law that triggers automatic closure or alternative management of a school if any student sub-group fails to gain an acceptable rating in any area of the TAKS test for five consecutive years. Due to Texas' unique labeling system, a handful of low test scores in a different sub-group each year may set an otherwise improving campus on the path to closure. Even the

Texas Education Commissioner is powerless to stop an automatic school closure under this law, no matter the circumstances.

School closure is not supported by data as a best practice for student achievement. In fact, research shows that academic achievement typically drops every time a student changes schools. The automatic closure law also disproportionately affects our most at-risk students – every school on the current list for closure serves a low-income, diverse population.

Several bills have already been filed to address this issue and Liveable City is working with Save Texas Schools to incorporate these provisions into the omnibus school accountability bills (HB 3, SB 3).
