

- (b) Each Delegate who offers a resolution shall be given an opportunity to explain it to the Resolutions Committee if he so requests.
- (c) The Resolutions Committee shall prepare suitable resolutions to carry into effect recommendations referred to it, and shall submit to the convention, with the Committee's own recommendation as to appropriate action, these and all other resolutions referred to the Committee, except questions which the Committee by a vote of two thirds of its members may decide not to report.
- (d) The convention by a majority vote may suspend this Rule 4 and may immediately consider a question, or may order the Resolutions Committee to report a question at a certain time, even if the Committee has voted not to report it.
- 5. Notices for announcement to the convention shall be in an acceptable electronic format or legibly printed and signed by the person (or a proper representative of the persons) under whose authority the announcement is issued, and shall be sent to the desk of the Recording Secretary.

IV. Conduct of Debate

- 1. The Convention Chair shall regulate the proceedings at all times so as not to outpace the Recording Secret-
- 2. No Delegate shall speak except upon recognition by the Convention Chair when standing at the floor microphone.
- 3. No Delegate shall speak in debate more than once on the same question on the same day, or longer than two minutes, without permission of the convention granted by a simple majority vote without debate.
- 4. A Delegate shall not substantially repeat what another Delegate has already said on the same motion. The Convention Chair shall warn a Delegate once, and shall revoke any remaining time upon the second offense.

 V. Nominations and Balloting

- 1. The Campaigns Director shall include in his report the list of public offices for which there are multiple contenders and the list of public offices for which there are single contenders. The Convention Chair shall conduct the nominations in the order they appear in the Campaigns Director's report, followed by open nominations for other public offices.
- 2. For each public office for which there are multiple contenders, the total duration of candidate and nominating speeches for an individual contender shall be no longer than two minutes. A separate ballot for each office shall be projected and circulated to the Delegates, and the results of the balloting shall be announced before the next office is considered.
- For each public office for which there is a single contender, the Convention Chair shall read and cause to be projected the contender's name, after which the Convention Chair shall call for any additional nominations for those offices. Additional nominations shall be added to the projected ballot and written in by the Delegates on the ballots they receive, and two minutes shall be allotted for speeched for each contender for only those offices that have become multiply contested. Single contenders are encouraged to sign up for time during the scheduled speaking periods. Voting shall proceed as prescribed above.

VI. Parliamentary Authority

1. The rules contained within Robert's Rules of Order Newly Revised 10th Edition shall govern the Convention in all cases to which they are applicable and in which they are not inconsistent with the Constitution and Bylaws of the LPCO, these Convention Rules, and any special rules of order the Convention may adopt.

Richard is a Fellow of the Society of Actuaries and a CFA Charterholder who has been a successful entrepreneur since the late 1990's. He has been married to Laurie Bratten for 27 years, lives in Highlands Ranch, and has two children - Chelsea, a junior at Hillsdale College, and Cody, a senior at Valor Christian High School.

May 18th, 2013

Attendees: Norm Olsen, Mike Seebeck, Ralph Shnelvar, Steve Gallant, Nick Sarwark, Jeff Orrok, Mike Spalding, Eva Kosinski, Clint Jones, and Stephen VanDyke (Board Member names are underlined.)

Adopted standing rules without objection.

The agenda was adopted after some discussion.

Gallant asked if there was a quorum for the board. It was determined that due to the lack of a quorum, board business could not be conducted.

Sarwark moved to approve last year's minutes. After some discussion they were adopted unanimously.

The Chair and the Treasurer presented board reports.

Constitution and Bylaws - no amendments had been presented to the committee.

Jeff Orrok proposed an amendment from the floor to prevent future amendments from the floor. Discussion concerned several issues. Shnelvar said all changes should go through the C&B committee. Spalding noted that neither committee ever met. Gallant pointed out that C&B is required to finish 6 weeks before the convention. Kosinski said it would be necessary to have a submittal method via the website and FaceBook. Gallant pointed out that this would add confusion to the convention scheduling. Shnelvar made a motion to amend to remove the option of submitting to the board. Sarwark spoke against the amendment as he felt it would lock many folks out of the process. It died for lack of a second.

Shnelvar pointed out that the requirement for a signed document would prevent email. Kosinski objected to the language and proposed alternative language. Spalding seconded. Orrok pointed out that the language would not fit into the current documents. Kosinski withdrew her amendment. Seebeck moved and Kosinski seconded to send this to the Bylaws committee. Sarwark and Spalding objected to postponing. Kosinski asked what problem was being addressed. The main amendment passed 7 to 2. This was over the two thirds required.

Mike Seebeck proposed and Olsen seconded a motion to replace the Western Slope representative with 11 regions. Seebeck explained that this plan would encourage local development and reduce the workload on the one Western rep. Shnelvar asked if these would all be on the board. Seebeck explained that the directors were just coordinating local activity. Olsen felt that this would be a good step in the growth of the party.

Kosinski pointed out that this was similar to a previous affiliate proposal. Gallant noted that this would remove the Affiliate Coordinator job from the Vice Chair.

Jones moved to change the name from Regions Director to Affiliate Coordinator Director. Shnelvar mentioned that the American Constitution Party has the chair be the chair of every county with out their own chair. Olsen said that it wasn't worth haggling details at this time. Sarwark observed that we don't even have a Western Regional Director. Olsen moved to end debate. This was seconded and approved.

On the main motion, Shnelvar asked what was the purpose of the regions. Seebeck responded that this was to help with development. Orrok admitted that the original definition of the Western Slope area was arbitrary. Shnelvar moved that the regions director also be chair of all unorganized counties. It died for lack of a second.

Olsen said that if this passed, we would have to elect a regions director at this convention. It passed with 7 to 2.

Shnelvar mentioned that there were several candidates who couldn't be contacted by the County Clerk. He feels that excessive line holding damages our reputation. Gallant asked if we had minimum requirements. Orrok said this was

unanimously repealed at the 2012 convention. Olsen called attention that although we filled the ballot last year, this year we are going to run 11 quality candidates. Sarwark explained the solution comes with the growth of the party.

Shnelvar moved to reinstate the top of ticket requirements to the constitution. Olsen seconded, Gallant claimed that the current word "qualified" was sufficient. Olsen added that we are currently recruiting good candidates and that the language in question only required declaration 90 days prior to the convention. Kosinski asked if the language specified duties of candidates. Olsen said no. Orrok said orders of the day required adjournment. Sarwark moved to extend 5 minutes. This was seconded and passed.

Jones moved to refer to committee and Gallant seconded. This passed 6 to 1.

Adjourned.

Jurist nominated Sarwark for Vice Chair and Sarwark was elected unanimously.

Sarwark nominated Amy Lunde-Provines for the new position of Regions Director. She was elected unanimously.

Steve Gallant and Marc Goddard declined nominations for Campaigns Director.

There were no nominations for Outreach, Membership, and Campaigns.

Sarwark nominated Matt Hess for Communications Director. He was elected unanimously. Orrok mentioned that Nia Bender of Clear Channel may be a replacement for Matt Hess when he steps down to run for Governor.

Olsen nominated Dave Jurist for Legislative Director. He was elected unanimously.

Since passage of Colorado's Amendment 27 (adopted as Article XXVIII) in 2002, the progressives have effectively waged "lawfare" against opposing campaigns organizations, and elected officials – imposing costs, tying up resources, generating negative publicity, and occasionally imposing fines and penalties for "infractions" of Colorado's arcane campaign finance law requirements.

Spearheaded by the well-funded (ironically, NOT subject to reporting and disclosure requirements) but misnamed "Colorado Ethics Watch", the Left's "lawfare" campaign of harassing attacks has encountered no consistently effective resistance – much less any effective counter- attacks. Our side has, sadly, lacked both Shield and Sword with which to fight back... until now.

MEMBERSHIP

It appears that we are on track to break 27,000 registered Libertarians as of the end of this month. If the trend over the past four years is an indication, there is a pretty good chance that we could break 40,000 by the end of this year. This is short of the desired goal of 50,000, and the effort to get an additional 10,000 is not out of the question. In 2010, two activists registered 50 new Libertarians in one day just by standing in front of a county courthouse. Two hundred activists could theoretically get the job done in a single day. Do we have 200 activists among our 27,000 who would put in a day in our voter registration drive? Do we have 20 activists who could work for ten days? We will really start winning when we really start growing, and we will really start growing when we really start working at getting our message out. We would like to welcome Jacob Erbes, who is the most recent appointee to our Board in the role of Outreach Director, and he would love to have you on his team and see you at the events he is planning.

Colorado is a very active participant in the national Libertarian Party. As you may know, our very own Norm Olsen serves as the Region 1 Representative on the Libertarian National Committee, and Colorado also has two members serving on the national Bylaws and Rules Committee and another two serving on the national Platform Committee. Colorado continues to be one of the top states in terms of Libertarians per capita, and we expect to send a full complement of delegates to the national convention in June. Last year, we were honored to host the annual conference of the Libertarian State Leadership Alliance (LSLA) at our state convention, and we appreciated deepening our ties with other leaders in the liberty movement from around the country.

CAMPAIGNS

If you have been keeping tabs on the website and reading the newsletter, then you know that the really big event for us last year was the recall election which proved two things -- that we can win in court and we can find and field a candidate in extremely short notice. In the span of six months, we had two victories in court, one in Denver District court which overturned part of last year's election "reform" law, and another in the Tenth Circuit which eliminated the unfair discrimination in the campaign finance law that allowed major party candidates to collect twice as much from individual contributors as minor party and unaffiliated candidates can. There are more opportunities for legal victories, and there are lawyers who are willing to fight for us for very reasonable terms, so we need more contributions to our legal fund so that we can keep moving forward.

We want to give a resounding thank-you to Jan Brooks and her family for taking on the challenge of running a campaign in the recall election. And of course, we are also deeply grateful to the passionate activists in El Paso county and the dedicated volunteers who drove down from the Denver area, Boulder, and even Fort Collins to gather signatures and campaign for Jan. Again, our experience shows that victory could be within our grasp when we put in the necessary time and treasure, so please look for ways you can increase your contribution of both, and encourage others to join you.

We are grateful to our Vice Chair, Nick Sarwark, for filling in as interim Campaigns Director, but as this election cycle heats up, we really need someone to step up and champion this vital role. We have a number of people with the knowledge and experience to help a new Campaigns Director hit the ground running and lead the charge on the ballot box.

REGIONS

We are very proud to report that five months ago Evan McMahon, the Executive Director of the Libertarian National Campaign Committee began to work with our Regions Director, Amy Lunde-Provines, and the leadership of our active affiliates. Colorado is one of five states selected for the LNCC's brand new year-long County Development and Enhancement Program (CDEP). The purpose of the program is to create the "party machinery" that will allow us to run real campaigns and raise real money that will let us achieve real victories. As we pointed out last year, the numbers show that there is significant interest in Libertarian candidates even without spending money, so when we do raise and spend money and get our boots on the ground doing good old-fashioned door-to-door campaigning, we can expect to have Libertarians holding office as a matter of course. In addition to the five counties selected for CDEP, we are happy to see development groups springing up in another half-dozen counties. This is important because when a county "graduates" from CDEP, its next job is to sponsor and support another county for the following year, so that the number of active and effective counties doubles every year.

LEGISLATIVE

David Jurist, our Legislative Director, has been putting in a lot of time researching and doing policy analysis and forging and deepening alliances with other organizations. The amount of work required for these tasks is considerable, and he would be very happy to have assistance. Last spring marked the beginning of our partnership with Principles of Liberty, which is a small-L libertarian group that rates the bills being considered in the state legislature. Just a few months ago, Principles of Liberty (POL) launched their training program, and we are pleased to report that a number of Libertarians have completed the program and are now collaborating with other POL volunteers on the bill rating process. We are looking forward to a long and productive partnership with these champions of liberty!

There are a number of very exciting ballot initiatives that are working their way through the language approval and title setting process, including measures to reform the judicial branch, expand the scope of recall petitions to include appointed positions, create a state bank like that of North Dakota's, and institute Yes/No Voting (very similar to Approval Voting) for elections. There are a few others that are in the works that we will report on when they become public. We don't need to wait to win an election to get good laws passed and make some real changes. If each of our 27,000 members would collect seven signatures for each of these petitions, they would all easily have a comfortable margin and could be voted into law this November. Please contact us if you would like to circulate any of these petitions.

COMMUNICATIONS

In the past year, Big-L Solutions has managed to double the number of people receiving the monthly newsletter, but we are still reaching less than half of our membership. We would like to thank Alan Hayman for serving as our newsletter editor, and we are grateful to the many content contributors, but we can always use a few more. We would like to accelerate the contact rate so that we are near 100% going into the 2016 election cycle. To do this, we need to supplement the Big-L staff with volunteers and go-getters who are willing to work on commission. Big-L has also done a lot of the heavy lifting to get our new website launched and has provided a database that we use to manage our relationship with our members. We are still in the process of getting up to speed in terms of our effective use of these tools, and we can definitely use more help from interested volunteers. The position of Communications Director is currently vacant, and it is critical that we find someone who can serve in this capacity during the election cycle and to help us frame our message in future legal battles.

TREASURY

Good news: we just moved in to a new office! Special thanks to Jacob Erbes, Amy Lunde-Provines, and David K. Williams for all of their work painting, as well as all the folks who helped move our assets into the new space. As before, we are benefiting from a very generous in-kind donation when it comes to paying rent in the soft real estate market, so if we want to hold on to this space when the eventual day comes that the market picks up, we will need to ramp up our regular monthly revenue. Please consider joining the 1776 Club to help us keep a roof over our heads. We need an additional 20 new 1776 Club members to give \$20 or more per month.

Another monthly project that we would like to begin is to take advantage of the recently lowered price for SOS data, plus our non-profit status with the USPS, and send a welcome letter to every newly registered Libertarian. A letter is important because a mailing address is often the only way we have to contact our members. If we welcome them and prove our worthiness, then we might get to have their phone numbers and email addresses. As we have reported previously, we would also like to send out an annual mailing to all members prior to the convention as well as another mailing before the general election. The monthly data download costs \$1000 for a two-year subscription, and then printing and mailing letters would cost on average about \$300 per month. We would need an additional 17 new 1776 Club members to give \$20 or more per month to make this a reality.
