Records – Mike Spalding

There were some improvements to records keeping throughout the year. These changes and tools will make operations easier for the next Records Director. Mr. Spalding worked with Caryn Ann Harlos to go through 15 years worth of paper documents. Mike and Caryn Ann removed a couple file cabinets worth of trash and she recovered some priceless historical documents. Mr. Spalding built a minutes template and added a voting block to standardize and simplify the meeting recording process, and he added email motions to the minutes. He also added a spending summary.

As a board member, Mike worked at People's Fair and participated in other outreach and campaign events throughout the year. He also located a budget (\$200) Convention location. He reconstituted his database of 3,000 smaller offices in Colorado, and gave this to Campaigns and others to encourage Libertarians to run for offices that they can win. At the direction of the board, he built and populated a motion tracking database for future reference.

Legislative – Michael Stapleton

As of this report we are 54 days into the 120 day Colorado Legislative Session, 66 days remain. There are many tumultuous days ahead, a looming budget debate with transportation and education funding in question. Legislation to move the caps on Tabor are just around the corner, with bi-partisan support and thirst for increased revenue and spending it could go either way. Many pieces of legislation pertaining to cannabis regulations, both pro and con are still up for consideration and debate.

The wins for Liberty are few and far between; the Colorado Ballot Selfie Bill has passed both chambers and is headed to the Governor for signature. The losses have been many, Civil Asset Forfeiture Transparency, Death Penalty Repeal, Repeal of the 2013 Gun Legislation, Magazine Capacity, just to name a few. With the help of David Aitken, we have e-mailed Colorado Libertarians and asked them to contact their State Senator on over 26 pieces of Legislations in a 6 week period, covering multiple Colorado Senate districts. Hopefully we have had some increased engagement from Colorado Libertarians in the process.

We will continue to send out the Colorado Libertarian Legislative Alerts weekly and grow engagement; Libertarians are in a unique position to have some influence and impact with our Colorado Legislators.

Treasury – John Hjersman

2016 was an eventful year with Libertarian candidates breaking some records and with major party presidential candidates throwing attention to Gary Johnson as the reasonable alternative. This interest is reflected in the level of donations as well as expenses for 2016. LPCO participated in the Gary Johnson Victory Fund PAC and, as such, became registered as a State Party with the Federal Election Commission. Frank Atwood officially became a Libertarian in mid 1990, even though he had been a polite libertarian milquetoast Republican advocating gun rights and anti-prohibition drug policies all his life. After retiring and moving to Colorado in 2000 he became vigorously politically active, he has

run for State House once, and CD 1 twice. He helped repeal the Littleton grocery tax and other community efforts. He has always been concerned that third parties sabotage their philosophical allies and how to resolve that conundrum.

Atwood served on the Arapahoe County Liquor board for a dozen years and has currently applied to be appointed to Littleton's Election Commission. He was a founding member and still active with Littleton's Sunshine Advocates – community watchdog group practicing transparency, accountability and consequences for Littleton leadership. In 2008 he was introduced to Approval Voting and has been an advocate ever since, being the Approval Voting Party presidential candidate in 2016.



Christopher Billman is an outdoor enthusiast who works for the county full time, is currently enrolled in classes finishing a BS in Mathematics/physics full time, and has 3 very intelligent daughters. Married for 10 years, he and his wife enjoy a homesteading lifestyle where they raise

chickens and goats, and try their hand at various gardening techniques each year. Mr. Billman is an avid backpacker, hiker, and obstacle racer participating in Spartan Races or Tough Mudders regularly. Ex-military, with an honorable discharge, Christoper also loves debate, logic, facts, and working out math and physics equations for fun.



Alicia I. Dearn is the founder of Bellatrix PC, a woman-owned, business facing law firm with offices in Saint Louis, Missouri and San Diego, and Riverside, California. Bellatrix PC handles lawsuits and business transactions and gives legal advice in business, employment, real estate, civil

litigation and election law.

In 2012, Ms. Dearn served as General Counsel to Governor Gary Johnson's Libertarian campaign for U.S. Presidency and its related non-profits and PACs. Notably, she successfully defended multiple legal challenges to Governor Johnson's ballot access. This earned Dearn a reputation as fearless as she single-handedly defeated some of the nation's top-ranked election law attorneys in multiple eleventh-hour state electoral proceedings simultaneously.

With a lengthy resume in both federal and state courts, Ms. Dearn's litigation practice is multi-jurisdictional, sophisticated and full-service handling trials, appeals, complex litigation matters, as well as class actions. She has obtained seven-figure judgments and full defense verdicts for her clients. She regularly speaks, publishes and appears on radio to discuss law, women entrepreneurship, politics, labor and business.



State Senator Laura Ebke is a lifelong Nebraskan, elected to the officially non-partisan Nebraska Unicameral in 2014 for a four year term. Before changing her party registration to Libertarian in late May of 2016, she had served as one of the state leaders of the Ron Paul

effort in 2008 and 2012, and was the State Chair and a founding member of the Republican Liberty Caucus of Nebraska from 2008-2015. Her focus on liberty led her to be a primary co-sponsor, and in-committee driver of Nebraska's ban on civil forfeiture in 2016. She was elected Chair of the Judiciary Committee for the 105th Legislature in January, a position she will hold through 2018. She will be up for re-election in the fall of 2018. Sen. Ebke is married, and has three children.



Corey "Sage" Fauconier is a native of Cambria Heights, Queens, New York who currently resides in Highland Springs, Virginia. He is a graduate of Hampton University with a degree in Political Science (1994) and a Paralegal Studies Certificate (1996). Currently Corey serves as the Communi-

cations Chair of the Libertarian Party of Virginia, and he has worked closely with them to bring the Libertarian party platform to the African American community.

Corey received great feedback from Libertarians from coast to coast for his single "Nice: Libertarian Theme," released in July of 2015. With his witty rap lyrics explaining the major party platform issues, he made fighting for liberty a cool thing to do.

In January 2017, Corey took all that he learned and jumped into politics. Mr. Fauconier was the Libertarian Candidate for Virginia State Senate District 9. Because of his run, Elko is now has a yellow dot on the State Board of Election map for the Commonwealth of Virginia representing the Libertarian Party.



Gregory Faust is the Chair and Pennsylvania State Coordinator of the Libertarian Party Radical Caucus and a coordinator of the Mid-Atlantic Liberty Festival, host of the Libertarian Party of Pennsylvania 2017 state convention. Greg will be running for Congress in 2018 in his current dis-

trict, which consists of parts of Philadelphia and its suburbs, and is working on several projects within the liberty movement.

Greg obtained a B.A. in Psychology from McGill University in Montréal, and a J.D. from Brooklyn Law School. He has been a licensed attorney for 17 years, handling at various times both litigation and transactional work. He grew up in New York until moving to the suburbs of Philadelphia for the birth of his son four years ago.



Marc Goddard was born in Portland Oregon and spent his formative years there, becoming politically active at 16 years old. Among his early accomplishments were organizing a fight against using the Willamette river as drinking water, and running a campaign for Mayor of Portland.

This candidate was only 19 (the youngest mayor candidate in the country at the time), and ended up getting 2nd out of 16 candidates. After earning his Associates degree in Portland, Marc earned his Bachelor's degree in political science and philosophy from Marymount University in Arlington, VA.

In 2006, Marc moved to Denver, Colorado and became immediately involved with the LPCO. That year, he ran the Gubernatorial campaign for candidate Dawn Winkler, which unlocked much growth for the LPCO, even getting Libertarians included in the prestigious Club 20 debates for the first time ever. Also in 2006, Marc presided as Parliamentarian over the LPCO state convention. Shortly thereafter, Marc became a NAP Parliamentarian, and has since presided as Parliamentarian over multiple Party conventions. The National Party recognized him for his efforts assisting the 2008 National convention held in Denver Colorado. In 2010, he ran for State House in District 4, where he garnished 5% of the vote - a record for any Libertarian in that district. He also assisted in the campaign for Jeff Schitter for Congress, and in 2014, he was campaign manager for David Williams, candidate for Attorney General of Colorado - a campaign that yielded an impressive total of over 120,000 votes.

Marc now resides in Colorado Springs. He was Parliamentarian and hosted the Presidential debate for the 2016 LPCO convention, which was held in that city. He is back this year to offer his Parliamentarian services once again.



Ron Gowins has worked in the addiction treatment field in Colorado for nearly 19 years. He has a bachelor's degree from The Metropolitan State University of Denver in Addictions Studies. He is a Certified Addiction Counselor III (CACIII). He has worked in outpatient settings, hospital-based

settings, criminal justice settings and currently works in an opioid treatment program. He provides patient needs assessment, direct patient care, clinical supervision for other therapists.



Caryn Ann Harlos became politically active after discovering the Libertarian Party and Libertarian principles. She is a paralegal holding a certification with the National Association of Legal Assistants with twenty years of experience and a Christian author. In addition to her positions as the

Region 1 Representative on the Libertarian National Committee, Communications Director for Libertarian Party of Colorado, and Colorado State Coordinator for the Libertarian Party Radical Caucus, she presently serves in many other volunteer capacities with the Libertarian Party and activist groups on a county, state, and national level, as well as serving as an editor with Independent Political Report. Caryn Ann's passion is to communicate the principles of libertarianism to as wide an audience as possible and to uphold the principles upon which the Libertarian Party was founded.



Wayne Harlos is a native of Colorado and after being a Republican for many years, finally realized that no party other than the Libertarian Party stands for the freedoms that our country was founded on. Wayne is the Vice Chair of the LPCO, as well as the Chair of the Douglas County Liber-

tarian Affiliate, with a goal of "spreading the word." He has a significant passion for gaining liberty for the residents of the State. Matthew Hess is a systems administrator by trade working in a variety of industries and capacities, an occasional Libertarian candidate for offices from county comissioner to governor, Liberty activist engaging in frequent promotion of Libertarian principles, and a recipient of the Pres-

idential Volunteer Service award.



From the time **Blake Huber** was in high school he would argue voluntaryist/libertarian positions. His American government teacher would constantly tell him, "Blake that just won't work." And his response was, "why don't we simply try?" In 1976, someone mentioned to Blake that the

fellow on the radio sounded like him, and after listening for a few minutes, Roger McBride, the fellow on the radio, *did* sound a lot like Blake. Blake became involved in libertarian politics in the early 80s and was elected State Chair of the Kansas party, and to the National Committee as well.

After many years of working on campaigns to help libertarians get elected, Blake decided there's something else going on here that needs to be changed. He got involved with the concept of approval voting approximately 10 years ago, and is now promoting that concept heavily. Approval voting would give more visibility and availability to alternative parties without creating a spoiler effect.

When her parents retired, she took over the family business and has been running the theatre for the last 20 years. She enjoys keeping a part of American History alive. The theater is a place where families and single parents can still afford to attend every week.

She ran for State House Representative in 2014 and 2016, coming very close to winning both times. Susan decided to run for office after a tough battle with Commerce City to keep the business open. Ultimately the city backed down entirely. She is passionate about sharing her lessons learned with other small business people.



Celeste Landry has been studying voting methods since 2012 as a member of the League of Women Voters of Boulder County Voting Methods Team. She is now the team's leader. In March, the Boulder County League approved a position to support implementing alternative

voting methods. Celeste and the team are now in the process of advocating for the state League to adopt the position at their convention in May.



Daniel Lutz was born in Northwest Indiana during the summer of 1986, where he lived until 1995 when his family moved to North Carolina. He graduated from Parkland High School, Winston-Salem NC, in 2005. Three days after graduation he reported for Recruit Training at Marine

Corps Recruit Depot, Parris Island, South Carolina. For his first enlistment he was a Combat Engineer, serving one tour in Iraq on the 15th Marine Expeditionary Unit from November 2006 until April 2007. In 2009 Sqt. Lutz made a lateral move into Combat Journalism. and graduated from the Defense Information's School (DINFOS) in September of 2009. In November of the same year he reported to the Recruiting Station in Kansas City. While stationed in Kansas City, Sqt. Lutz was trained in Professional Selling Skills (PSS), During that time he gained over \$3 Million in free advertising. reduced the stations advertising costs by nearly %50. and conducted countless Enhanced Area Canvassing (EAC) events. In May of 2013 Daniel left the Marine Corps as a Sergeant to expand his education in Political Science and Law. In 2015 Mr. Lutz moved to Colorado with his traveling companion, Ashley, that he would soon marry, and made a home deep in the Rockies.



Apollo Pazell is a long time political activist. For 15 years Apollo has been a fixture in campaign politics, working on some 63 campaigns in 3 political parties. Apollo's specialty is in candidate recruitment and primary elections. He has worked in some of the

As a publisher and professional pundit, Petersen grew The Freedom Report podcast into a top audio news source, with an average of 1.5 million monthly downloads. As a creative content producer, business executive, and successful political organizer, Stonegait's CEO has a lifetime of activism ahead, with decades of professional experience in a wide variety of industries.



Born and raised on the east coast, **Brian Rogers** lived in Maryland and Pennsylvania until graduating from college in 2006 with a dual major in Industrial Technology and Business Management. Following graduation, Brian moved to Colorado. Having managed restaurants on the east

coast Brian began working at a restaurant in Lakewood where he met his fiancé and business partner Caitlin McGuire. The two opened a medical marijuana store together in Breckenridge, CO that was the center of an eight episode CNN Docu-series titled High Profits that focused on the battle with government officials over their store's location. In 2015 the two sold that store and opened another marijuana company, this time on the wholesale and manufacturing side of the industry. Brian is currently the President and CEO of Kayak Cannabis a concentrates manufacturing company as well as Backcountry Cannabis Company, a retail cannabis store in Crested Butte, CO.



Jonathan Singer is in his third term representing House District 11 in Longmont and northern Boulder County. He is Chairman of the Public Health & Human Services Committee and Vice-Chair's the Joint Technology Committee and the Mental Illness and Criminal Justice System Com-

mittee. Rep. Singer has played a key role in efforts to streamline and expand child welfare services, electoral reform and disaster recovery. He is also the legislature's leading authority on the laws and regulations implementing Amendment 64, the landmark 2012 referendum in which the people of Colorado legalized the recreational use of marijuana. 


