11 January 2015 – Motion to Hold 2015 State Convention (Brett H. Pojunis)

Motion: To hold the 2015 State Convention on 31 May 2015 at the Tropicana; approved 6-0, with 3 abstaining.

3 April 2015 – Motion to purchase a component called joomdonation (Brett H. Pojunis)

Motion: We need to purchase a component called joomdonation. We have an older component and with the most recent update it no longer works. Thus will work with future versions of the site as well. Additionally, this will work with PayPal. Its \$24.99; defeated 3-0, with 6 abstaining.

3 April 2015 – Motion to spend \$15/week on Facebook advertising (Brett H. Pojunis)

Motion: I would like to have a \$15 a week budget for Facebook advertising. The foal is to result in more targeted likes. The algorithms for Facebook pages is that when you spend \$45 a month or more we show up more often than pages who do not advertise. This would be a total of \$60 per month; defeated 3-0, with 6 abstaining.

18 April 2015 – Motion to resolve that the Outreach Director be more welcoming and inclusive of all Libertarians (Jim Duensing)



Motion: Be it resolved that the Outreach Director be more welcoming and inclusive of all Libertarians regardless of their opinions on genetically modified foods, fluoridated water, or chemtrails; defeated 1-6, with 2 abstaining

18 April 2015 – Motion to remove Jason Weinman as Outreach Director (Jim Duensing)

Motion: Remove Jason Weinman as Outreach Director because numerous libertarians have informed me they will not get involved specifically because of him; defeated 1-4, with 4 abstaining

27 May 2015 – Motion to approve spending on marketing materials (Brett H. Pojunis)

Motion: to approve the costs for printing new postcards for our booth and some new 12 x 18 posters. These will have the new logo's on them. The total cost will be between \$520 and \$570 dollars. I wont know what it is until I get the final quote; approved 5-0, with 4 abstaining.
