first meetings a few users hit the steep part of the learning curve, but thankfully, that is behind us. We have been able to transact routine business and have even tackled strategic planning - yes, online. As a non-profit, LWVMD qualified for and obtained a <a href="free license to G">free license to G</a></a><a href="Suite">Suite</a> that enables our board members (up to 150 of us) to use Google Hangouts Meet as our online platform.

Our new bylaws already included the following item:

Section 8. Conference Telephone Call Meetings.

Board members may participate in meetings by means of conference telephone calls or similar communication equipment allowing all persons participating in the meeting to hear each other at the same time.

Participation by such means shall constitute presence in person at a meeting. Such meetings shall follow the prescriptions of in-person board meetings. Notification of conference call meetings must be in a timely manner. If your local league does not have that provision, now is the time!

Oh, how can you amend your bylaws when your annual meetings will have to be cancelled, you say? Your local leaders are having the same conversation that we are having at the State Board level and our answer is taking shape: Online. (Unless you are buying or selling property, my recommendation is to hold online votes and affirm actions taken in this manner once you are able to reestablish in person meetings. Our work is too important and must go on.) We have a committee planning an online Council option and the good news is that potentially more people will be able to attend than we could afford to host in one physical location! We hope to feature a guest speaker who doesn't even have to live anywhere near Maryland and the same parameters apply to our panels and any entertainment.

Because we have already made the G Suite connection, we are able to offer it as a solution to you in your local League work. Your email to <a href="mailto:online@lwvmd.org">online@lwvmd.org</a> will go to the members of the Online Services Committee which has been tasked with moving fast to catalogue the best solutions and support. I serve on that group and we'd love to have your local League leaders share what works best and where you need support. Who knows, a bulk purchase of ear buds or webcams may be in our future as well!

Elsewhere in this SBL newsletter you will see the details of the State Board's purchase of a Zoom license so that we can host webinars and larger meetings. Stay tuned!

## March State Board Meeting Highlights

- With the Corona Virus affecting us all, your State Board has made some important changes. The 100<sup>th</sup> Anniversary County Council Meeting will be conducted online. The event is still June 6, 2020 and we still have some very interesting programs for that day. To protect all of us it will be an online event only.
- Many local Leagues will no doubt have to have their Annual Meetings online also. Your State Board is working on ways to help you with this new reality. The Committees are still working hard to improve the State League of Women Voters.
- The Budget Committee is working on next year's budget and the Nominating Committee
  is forming a slate of candidates. Won't you please consider serving when they call you?
  Serving on the State Board can be an invaluable experience for you and can only add to
  the assistance of your Local League.

#### **Voter Services Work**

<u>Voter Registration:</u> In-person voter registration events have been cancelled since early March as part of more general social distancing efforts. In particular, naturalization ceremonies have been canceled until at least April 24. When the ceremonies resume, we will continue with our voter registration program at the District Courthouses in Greenbelt and Baltimore City and at the Baltimore Field Office of US Citizenship and Immigration Services in Halethorpe.

**VOTE411:** VOTE411, the League's online source for voting information and information about candidates, is our

one voter service activity that has continued as planned. Thanks to dozens of volunteers across the state, hundreds of candidates provided answers to our questions. These have been posted and publicly available for several weeks. As distribution of paper *Voters' Guides* may be limited by closure of libraries and other public places, the availability of an online source of information becomes even more important. In addition, VOTE411 is a convenient way to access a variety of voting-related information and services, including voter registration, voter registration updating and applications to vote by mail (absentee ballots).

<u>The Upcoming Elections</u>: The COVID-19 pandemic has necessitated major changes in Maryland's upcoming elections. The Special General Election to fill Elijah Cumming's seat in the 7th Congressional District is still scheduled for April 28, 2020, but the format has been changed to a <u>primarily mail-in election</u>. The Presidential Primary Election has been moved from April 28 to June 2, 2020. Per the <u>Governor's Order on April 10</u>, this election will also be primarily vote by mail.

The League of Women Voters of Maryland has been in communication with other voting rights advocates working collaboratively to ensure clear plans are put in place for these elections which allow every eligible voter to exercise their right safely. In coalition we have submitted letters to both the <a href="Governor">Governor</a> and the <a href="State Board of Elections">State Board of Elections</a> with recommendations for best practices and <a href="questions">questions</a> from communities leaders which need be considered as plans are implemented.

Issues still to be addressed include the legal requirement that ballot marking devices must be available so that disabled voters can cast a secret ballot, the problem of students who registered where they attend college but are not currently on campus, and the plan to mail ballots only to active voters, not all registered voters. No matter how these matters are ultimately resolved, it will be very important for our Leagues to take an active role in informing the public about how the elections will take place and about the importance of up-to-date voter registration.

## Maryland's Legislative Session Early Adjournment

The General Assembly adjourned at about 5pm on March 18th – about 3 weeks earlier than they had planned.

Since the announcement of the first case of community transmission of COVID-19 on March 12<sup>th</sup>, there has been a rapid expansion of measures to prevent the spread of this pandemic. Mass gatherings were prohibited by the Governor at this time, and the General Assembly put in place measures to limit interaction of members and legislative staff with others. By the 13<sup>th</sup>, all non-essential employees were required to telework, and only those who have a state-issued credential were allowed in the government buildings. General Assembly leaders decided to work through the weekend and declared they would prioritize legislation for consideration in case of early adjournment. Click here to read more.

LWVMD applauds the General Assembly leaders for working to find a solution that will meet the needs of Marylanders during this difficult time.

However, there was concern for the lack of public access to their legislators while they are making critical decisions on legislation. In response, we signed on to a letter with dozens of other advocacy groups requesting that the General Assembly pause the legislative session and return when it is once again safe to do so. On Sunday, March 15<sup>th</sup>, the leaders of the General Assembly announced that they would continue their work through Wednesday, March 18<sup>th</sup>, at which time they adjourned (Sine Die was scheduled for April 6th). They plan tentatively to reconvene for a special session the last week of May to take care of any other legislative business.

More than 660 bills were passed by the General Assembly between Sunday and Wednesday.

During this shortened session, LWVMD advocates submitted more than 90 pieces of testimony. which you can access on our <u>testimony page</u>.
