This Voters' Guide contains responses only from candidates whose races will be on the General Election Ballot plus Write-In candidates who submitted their responses before the print deadline. Some candidates may have withdrawn since the material was compiled and others may have been added. **Tuesday, November 8, 2016: General Election.** Polls open 7 a.m. and close 8 p.m.

**Identification in Maryland:** *Not required* except under some circumstances. For example, if the voter has registered by mail and has failed to include identification as requested for mail-in registration.

**Felon voting in Maryland:** Those convicted of felonies are welcome to vote in Maryland after they have been released from incarceration.

**Age to register in Maryland:** 16

**Age to vote:** 18 on or before General Election Day, November 8, 2016

### ABSENTEE BALLOTS

Any registered voter may vote by absentee ballot.

#### HOW TO GET AN ABSENTEE BALLOT

There are three ways you can request an absentee ballot.

- From the Maryland State Board of Elections web-site <http://www.elections.state.md.us/voting/absentee.html>, you may request an absentee ballot online if you have a Maryland's driver's license or MVA-issued ID card.
- Or from the same link you may download a form, read the instructions, enter the required information, print the form, sign it, and return it to your local board of elections. You can return it by mail, fax, or email (scanned as an attachment).
- Or you may go to your local board of elections and fill out and turn in the form.

#### DEADLINE FOR RECEIPT OF ABSENTEE BALLOTS

- If returned **in person**, the County Elections Board must receive an absentee ballot no later than 8 p.m. on Election Day. Absentee ballots must be returned **by mail or in person** directly to the Board of Elections; they cannot be accepted at the polls on Election Day or returned on-line.
- If you **mail your ballot**, it must be postmarked on or before Election Day and it must be received by your local board of elections by 10 a.m. on Friday, November 18, 2016 for the general election. Voters are cautioned that if an absentee ballot has been issued to them, they will not be permitted to cast their vote at their polls on Election Day.

#### PROVISIONAL BALLOTS ARE REAL BALLOTS.

You may be asked to vote by provisional ballot rather than on the voting machine if

- Your name does not appear on the E-Poll Books when you check in
- You live at a different address than is shown on the E-Poll Books when you check in
- You had been assigned to vote at a different polling place
- You have been asked to show identification but are unable to do so

Provisional ballots are checked after the election and, if everything is in order, the votes are cast.

## **PRESIDENT OF THE UNITED STATES**

### **GROUND RULES FOR PRESIDENTIAL CANDIDATES**

- All qualified presidential candidates were invited to provide biographical information and responses to five specific questions. Candidates qualified if they met the following criteria: 1. The candidate must have made a public announcement of her/his intention to run for her/his Party's nomination for President; 2. The candidate must meet the Presidential Election Campaign Fund Act's minimum contribution threshold requirements for qualifying for matching funds, based on the most recent data publicly available on the FEC website; and, 3) The candidate must qualify for the ballot in enough states to win a majority of electoral votes.
- Responses were limited to 400 characters and were truncated thereafter.
- If a candidate did not respond by the date of publication, "Candidate has not responded." is printed.

## **ABOUT THE OFFICE OF THE PRESIDENT**

**DUTIES:** The President is the head of state of the United States of America and is the Chief Executive Officer and the Commander in Chief of all military forces. The powers of the President are described in the Constitution and federal law. Subject to Senate approval, the President appoints the members of the Cabinet, ambassadors to other nations and the United Nations, Supreme Court Justices and federal judges. The President, along with the Cabinet and its agencies, is responsible for carrying out and enforcing the laws of the United States. The President may also recommend legislation to the United States Congress.

**SALARY:** \$400,000.

**TERM:** Four years, limit of two terms.

**HOW ELECTED:** Every four years, political parties nominate candidates to run for President of the United States in a general election that is held on the first Tuesday, after the first Monday in November. Although all parties use conventions to nominate their candidates, in most states the Democratic and Republican parties also run state-wide primary elections or caucuses. The results of the primary influence how the delegates to their respective party's convention will cast ballots for candidates for President. The degree to which the result of the primary influences the votes of delegates at conventions varies from state to state.

**Duties:** U.S. Senators make laws along with the House of Representatives, ratify treaties, and conduct investigations on issues of national importance. The Senate confirms Presidential appointments.

**How Elected:** In 2016, Maryland voters will elect one Senator. Voters elect two Senators from each State who serve six years. About one-third of the 100 members of the Senate is elected every two years. Senators must be at least 30 years old, have been citizens of the United States at least 9 years and be residents of the state they want to represent.

**Term:** Six years

**Base Salary:** \$174,000

**1. QUALIFICATIONS:** How does your experience prepare you for the duties of a Senator?

**2. ECONOMY:** What economic policies would you support to assist low and middle income citizens?

**1. QUALIFICATIONS:** As a Maryland small business owner, I understand the tools business leaders and job creators need to get the people of Maryland back to work. **JUDGE OF THE CIRCUIT COURT – CIRCUIT 7**  
**Vote for up to 4**

**DUTIES:** Judges preside in the Circuit Court, which is a trial court of general jurisdiction covering major civil cases and more serious criminal matters. Circuit Courts also may decide appeals from the District Court and certain administrative agencies.

**SALARY:** \$154,433

**TERM:** Fifteen years, no term limit. Mandatory retirement age of 70 years.

**HOW ELECTED:** The state is divided into 8 Judicial Circuits. The General Assembly determines the number of judges in each circuit and county. When there is a vacancy, the Governor appoints a qualified person to fill the office. Each newly appointed Circuit Court judge then must stand for office at the first election that occurs at least one year after the vacancy happened. One or more other qualified members of the bar may also run to fill the vacancy. All candidates run on both the Democratic and Republican primary ballots. The winners of each primary (equal to the number of seats to be filled) advance to the general election ballot, but without party designation.

**Vote Yes or No for Continuance in Office**

**DUTIES:** The Court of Appeals is the highest court in the State (commonly called the Supreme Court in other states and at the federal level). It hears cases almost exclusively by way of certiorari, a process which gives the court discretion to decide which cases to hear. However, the Court of Appeals is mandated by law to hear cases involving the death penalty, legislative redistricting, removal of certain officers, and certifications of questions of law.

**SALARY:** \$176,433 annual base

**TERM:** Ten years, no term limit. Mandatory retirement age of 70 years.

**HOW ELECTED:** Members of the Court are initially appointed by the Governor and confirmed by the Senate. Subsequently, they run for office on their records, unopposed. If voters reject a judge's retention in office or there is a tie vote, the office becomes vacant and must be filled by a new appointment. Otherwise, the incumbent judge remains in office for a ten-year term. The Court is composed of seven judges, with one elected from each of seven judicial circuits.

**JUDGE OF THE COURT OF SPECIAL APPEALS – AT LARGE**  
**Vote Yes or No for Continuance in Office**

**DUTIES:** Judges preside in the Court of Special Appeals, the intermediate appellate court in Maryland. The Court reviews the actions and decisions of the Circuit Court and of the Orphans' Court in cases brought before it. The Court, usually sitting in



panels of three judges, decides if the trial judge followed the law and legal precedent.

**SALARY:** 163,633 annual base

**TERM:** Ten years, no term limit. Mandatory retirement age of 70 years.

**HOW ELECTED:** When there is a vacancy on the Court of Special Appeals, the governor appoints a qualified person to fill the office, with the consent of the State Senate. Once appointed, the appellate judge holds the office until the first election that occurs at least one year after the vacancy happened. At that time, the judge runs for an uncontested election for a ten-year term on their record (yes or no for continuance in office). No one is permitted to file against them. If the incumbent judge is approved, the judge faces another "retention election" every ten years to continue in office. If the incumbent judge is rejected by the voters, the post becomes vacant, and the governor makes a new appointment. The Court is composed of 15 judges: eight at large and one each from seven appellate judicial districts.

### **BOARD OF EDUCATION – PRINCE GEORGE'S COUNTY**

**DUTIES:** The BOE shares its responsibilities with the Chief Executive Officer (CEO) to establish and oversee educational policies; to make decisions on educational, facility, and financial matters; and to appraise the educational and administrative management of the public school system. The CEO implements public school policies and programs. The BOE may not contradict management and oversight of fiscal affairs except by a 2/3 vote of the BOE. The purpose of the Board is two-fold: to raise the academic achievement of students and the level of engagement of parents, students, and community. The BOE consists of 9 elected members, 3 members appointed by the County Executive, 1 member by the County Council, and 1 student member.

**SALARY:** \$18,000 + \$7,000 reimbursement

**TERM:** 4 years; no term limits

**HOW ELECTED:** By popular vote within one of nine districts. Districts 1, 4, 5, 7, and 8 are elected during Presidential elections; Districts 2, 3, 6, and 9, during Gubernatorial elections. BOE races are non-partisan and all registered voters may vote in both Primary and General elections. The top two vote getters in each race advance to the General election; uncontested races (only one or two candidates) do not appear on the primary election ballot.

**1. QUALIFICATIONS:** What makes you qualified (in education, community involvement, budget matters, etc.) to serve on the Board of Education?

**7. OTHER SUCCESSFUL PRACTICES:** We need to encourage more of our county residence to support their neighborhood schools by volunteering their time and their resources to support our students. More importantly, we need to encourage ALL of our residence to send their students to their neighborhood schools. There are so many great and wonderful school in Prince George's County that get overlooked because of preconceived notion of what a school is about. After all, we all benefit from great schools.

**8. PREPARATION FOR OFFICE:** When my 10 year old son was 2 years old, I started volunteering with and for our neighborhood school, that was 8 years ago. For 8 years I have been working hard to make our schools better. Believe me, I'll be prepared on day one.

**1. QUALIFICATIONS:** Since its restructuring in 2013, the PCGPS Board of Education has focused squarely on education policy and funding, as well as community engagement. I have the unique qualifications through both my academic and workplace experiences to represent District 7 in these areas. I have worked for The Education Trust, the University System of MD, the MD Higher Education Commission, MD Sen. Ulysses Currie, and MD Lt. Gov. Anthony Brown, as well as both undergrad and graduate studies in education policy.

**2. DISPARITIES IN DELIVERY OF SERVICES:** I have always been a critique of the notion that there are disparities between the northern and southern portions of the county. The disparities are more prevalent when comparing schools and communities inside and outside of the 495 beltway. District 7 is cut in half by 495, so I am extremely aware of the needs these two communities require. The most important, in my opinion,





are our facilities - that is why I am fighting to bring resources to build a brand new, state of the art Suitland H.S.

**3. ACADEMIC ACHIEVEMENT:** Over the past few years, the MD grad rate has risen incrementally. However, due to the great work of Dr. Maxwell, his team, and our dedicated educators, PGCPs' grad rates have increased well above the MD average increase. Just recently, PGCPs 2015 cohort grad rates increased 2.16%, with Suitland H.S. increasing 6.91%, Dr. Henry Wise H.S. increasing 3.38%, and Forestville H.S. only decreasing by less than %. We must, however, work to decrease the 15.03% dropout rate through 9th grade detection.

**4. ENGAGEMENT OF PARENTS, STUDENTS, AND COMMUNITY:** As the incumbent member on the Board of Education for District 7, I serve on the Parent, Family, and Community Engagement committee where it is my role to increase the board's presence and perception throughout the county. One of the three main areas that I am spearheading is strengthening the engagement of our PGCPs alumni. As an alum of the school system, I encourage my fellow alums to give back your time and talents to your alma mater through mentorship, guidance, as well as pride and passion

**5. BUDGET FACTORS:** As I travel throughout District 7, whether it as PTA meetings or civic association events, I hear three main concerns when it comes to the budget: 1. efficiency in spending; 2. school construction; 3. raising wages for teachers. These three priorities are on the top of my list, but I am also mindful of the overwhelming need for universal pre-k sections, especially for our low-income communities.

**6. ACHIEVEMENT GAP:** If you examine the graduation rates for our school system, the demographic that decreases that percentage are those students who are not english proficient. It's simple: if you cannot speak english well, you are less likely to pass english class and since english is required for four years, if you fail once, you're off track for on-time graduation. The Board and the Administration have worked and will continue to work to increase services to ESOL students and students of low english proficiency

**7. OTHER SUCCESSFUL PRACTICES:** Our school system is often times compared to neighboring jurisdictions in both Maryland and Virginia - which is fair, given our proximity. However, if there is one successful practice that our neighbors do well - it is the availability of SAT/ACT prep courses. Whether it is an after school program or a course students take during school hours, PGCPs must do better by preparing our college-bound students for the SAT and ACT. I believe, if done well, our scores will certainly increase over time.

**8. PREPARATION FOR OFFICE:** I'm currently a Member of the Board of Education, representing District 7. In fact, I announced my candidacy well before I was appointed by County Exec. Baker and confirmed in a 9-0 vote by the County Council in November 2015. I am truly prepared to continue the work and relationships I have so that I can successfully advocate for the students, families, educators, and communities of District 7.

**1. QUALIFICATIONS:** I have worked in education in Prince George's County for 20 years. I spent the last seven as an elementary school teacher, and have also worked as a

resource teacher, tutor and advocate for students. Additionally, I have been extremely active in the community since I moved here 25 years ago, working on civic associations, volunteering with local youth organizations and partnering with businesses.

**2. DISPARITIES IN DELIVERY OF SERVICES:** These disparities are the reason for my slogan "Equality for District 8." I have seen them firsthand and heard the concerns from colleagues and students. My 8 Point Plan focuses on reducing class sizes, ensuring student resources, retaining quality teachers, and holding town hall meetings where students and community members share concerns like these. I have an inside view of these pressing issues.

**3. ACADEMIC ACHIEVEMENT:** Begin by focusing on individual schools to determine what is needed to enhance the performance within their building, offering alternative choices to high schoolers that peak their interest, and weeding out ineffective teachers, so quality teachers can flourish. These along with my 8 Point Plan will provide solutions to cement student's' academic foundation.

**4. ENGAGEMENT OF PARENTS, STUDENTS, AND COMMUNITY:** Communication is the best way to foster better collaboration. In addition, the grading policy that ensures all students receive 50% is not preparing students to be college and career ready.

**7. OTHER SUCCESSFUL PRACTICES:** The culture of "equality," "respect," etc. that is put into place in Howard and Montgomery Counties, respectively. For their counties it is not just words, but actions. Teachers and students must have a sense of security, which is currently lacking in PGCPs. Everyone is walking on eggshells in this climate of fear. PGCPs has to become proactive instead of reactive. The anonymous tip line will assist in this feat. Also, allowing creativity back into the classroom. As in New York's C.A.S.A.

**8. PREPARATION FOR OFFICE:** From the start of my campaign, I have focused on engaging the citizens of District 8. This has included holding Town Hall meetings, speaking to PTAs and Civic Association, and attending community events. I have also been to Board of Education meetings in order to understand the way the Board functions and create a plan that will work for the community on my first day in office.



## STATE BALLOT QUESTIONS

### Question 1

#### **Constitutional Amendment: Process to Fill Vacancy in the Office of Attorney General or Comptroller of Maryland (Amending Article V, Section 5 and Article VI, Section 1 of the Maryland Constitution)**

**Ballot Language:** Changes the way the Governor fills a vacancy of the Attorney General or the Comptroller and requires a special election for vacancies that occur on or before a certain date. Under current law, the Governor fills a vacancy by appointing an individual to serve for the remainder of the term. Under the amended law, if the vacating Attorney General or Comptroller was a member of a political party, the Governor must fill the vacancy from a list of three names provided by the political party of the vacating official, and if no names are provided by the political party within a set time period, then the Governor must select a successor from the political party of the vacating official. If the vacating Attorney General or Comptroller was not a member of a political party, then the amended law requires the Governor to appoint any qualified individual. The Governor must make the appointment within a set time period following the vacancy. The amended law requires a special election to replace the successor if the vacancy occurs early enough in the term to allow for candidates to participate in the regular elections held in the second year of the vacating official's term.

**Origin of the ballot question:** The 2016 session of the General Assembly passed legislation (HB 260) proposing a constitutional amendment to change how vacancies in the offices of Attorney General and Comptroller will be filled. A bill that amends the Maryland Constitution requires a three/fifth vote in each chamber (Maryland Senate and House of Delegates) and approval by the voters at the next general election.

**Present Practice:** Under the Maryland Constitution, when a vacancy occurs in the office of the Attorney General or Comptroller, the Governor appoints a person to serve for the rest of that term. Appointment of the Comptroller also requires the approval of the Maryland Senate. The Governor is not required to choose someone of the same political affiliation as the person being replaced. There also is no provision for the voters to choose someone to fill a vacancy in either office through a special election, no matter how much time is left in the term of office.

**Proposed Change:** The Governor would be required to appoint a replacement Attorney General or Comptroller within 30 days of the vacancy, with someone from a list of three persons submitted by the State Central Committee of the political party of the previous office holder. (If the person being replaced was not affiliated with a political party, the Governor could appoint any qualified person.) The appointed person would serve for the rest of the original term if the vacancy occurs in the last two years of the term. However, if the vacancy occurs six weeks before a scheduled presidential primary (that is, there are more than two years remaining in the term) a special election would be held as part of the presidential election process.

#### **Arguments FOR the amendment:**

- The person appointed by the Governor must be of the same political affiliation as the person being replaced. This reflects the preferences of the voters when they

chose the Attorney General or Comptroller at the last election.

- If there are more than two years left in the term, the voters are able to choose who will fill the office at special elections held at the same time as the next presidential primary and general elections.
- By choosing the new official at the same time as the scheduled elections, there would be no additional costs for conducting separate special elections.
- It is likely that many more voters would participate if the vacancy is filled at a regularly scheduled election, than if the special elections were held at a separate time.

#### **Arguments AGAINST the amendment:**

- Requiring the Governor to appoint someone recommended by a political party central committee gives power to a small group of people elected only by members of that political party.
- Under current rules, the Governor may appoint a qualified person of any political affiliation.
- Holding a special election to choose someone to fill the last two years of a term when the Governor has already appointed a replacement may result in frequent changes in leadership.

**A vote FOR** the constitutional amendment means the Maryland Constitution would be amended to (1) require the Governor to fill a vacancy for Attorney General or Comptroller with someone from the same political affiliation as the person being replaced; and (2) require that a replacement be elected at the same time as the presidential election if more than two years are left in the term.

**A vote AGAINST** the constitutional amendment means the Maryland Constitution would not be amended. When a vacancy occurs, the Governor may appoint someone of any political affiliation to fill the rest of the term of Attorney General or Comptroller.

## COUNTY BALLOT QUESTIONS

**Questions A, B, C, E, and F are referenda required by the County Charter. They allow the County to fund the projects listed in the enabling bills and detailed in the approved Fiscal Year 2017-2022 Capital Improvement Program by borrowing money and issuing bonds. The projects are found throughout the county.**

**Questions D and G are proposed Amendments to the County Charter and as such require approval by the Voters. They originate from the listed County Council Bill.**

### Question A

#### **Charter Required Referendum (CB-45-2016) Library Facilities Bonds**

An Act enabling the County to borrow money and issue bonds in an amount not exceeding \$60,765,000 to finance the design, construction, reconstruction, extension, acquisition, improvement, enlargement, alteration, renovation, relocation, rehabilitation or repair of Library Facilities, as defined therein.

A vote **FOR** the Charter Referendum means: the projects will be funded using county bonds.

A vote **AGAINST** the Charter Referendum means: another means for funding the projects must be found.



### **Question B**

#### **Charter Required Referendum (CB-44-2016) Public Safety Facilities Bonds**

An Act enabling the County to borrow money and issue bonds in an amount not exceeding \$66,591,000 to finance the design, construction, reconstruction, extension, acquisition, improvement, enlargement, alteration, renovation, relocation, rehabilitation or repair of Public Safety Facilities (including Fire/EMS Department Facilities), as defined therein.

A vote **FOR** the Charter Referendum means: the projects will be funded using county bonds.

A vote **AGAINST** the Charter Referendum means: another means for funding the projects must be found.

### **Question C**

#### **Charter Required Referendum (CB-46-2016) Community College Facilities Bonds**

An Act enabling the County to borrow money and issue bonds in an amount not exceeding \$48,363,000 to finance the design, construction, reconstruction, extension, acquisition, improvement, enlargement, alteration, renovation, relocation, rehabilitation or repair of Community College Facilities, as defined therein.

A vote **FOR** the Charter Referendum means: the projects will be funded using county bonds.

A vote **AGAINST** the Charter Referendum means: another means for funding the projects must be found.

### **Question D**

#### **Charter Required Referendum (CB-40-2016)(DR-2)**

**Ballot Language:** To provide for the election of council members by district and at large, to change the composition of the County Council to a system of nine district members and two at large members, and to provide that a Council member who has been elected to two consecutive terms of office as a district member shall not serve more than two consecutive terms as an at-large member.

**Origin of the ballot question:** The County Council passed legislation (CB-040-2016) proposing to the voters of Prince George's County, an amendment to Sections 301, 303, and 307A of the Charter of Prince George's County to change the composition of the County Council to include nine Council District Members and two At-Large Members and to provide the eligibility of the At-Large Members to the County Council.

**Present Practice:** The County Council is composed of members from nine Council Districts within Prince George's County with each District having its own County Council Member. At the time of a County Council Member election which coincides with the election of State Officers, a County Council Member shall reside in one of the nine Council Districts within Prince George's County and the member shall be elected by the qualified voters of the Council District of which they reside. County Council members are limited to serving two consecutive terms.

**Proposed Change:** The proposed amendment changes the composition of the County Council by maintaining the system of nine Council District Members while adding two At-Large Members for a total of eleven members to the County Council. The two At-Large Members will be elected by the qualified voters of the entire County. The amendment would allow an opportunity of a term limited Council Member, from one of the nine County Council Districts, to be nominated and elected to an at-large seat thereby potentially doubling the time a Council Member could serve from two to four terms. At-Large members will be term limited to no more than two consecutive terms as an At-Large Member.

#### **Arguments in Favor:**

- Current County Council members of the nine districts who become At-Large members will have improved opportunity to gain chairmanship or seniority to seats of regional boards thereby increasing the County's influence in State and Regional affairs and advancing economic and social benefits for County residents.
- At-Large Members will not be parochial to a specific area or district of the County and will assess legislation as it impacts the entire county.
- Council Members who may gain four terms total as Council Members from a District and At-Large will have time to influence and rework legislation.

#### **Arguments Against:**

- At-Large County Council candidates will face a higher election cost to campaign county-wide and will be beholden to donors who contribute significant amounts to their campaigns.
- The measure circumvents term limits. In 1992, Prince George's County voters approved a citizen-driven initiative to limit the County Executive and County Council to two terms (four years to a term or total of eight years). In 2014, the County Council through ballot referendum (Question J) sought to extend term limits to three terms and the referendum was not approved by voters.
- There is a significant fiscal impact to adding two At-Large members while the County is facing budgetary constraints and many programs are in need of funding. Per the Legislative Audit from the Prince George's County Office of Audits and Investigations, the enactment will have an impact on the County in the amount of \$1,144,112 per fiscal year, beginning in fiscal year 2020.

**A vote FOR the charter amendment means** the County Council will be changed to a composition of nine council members elected by District and two At-Large members elected county wide with eligibility of county council members of a district to run and be elected At-Large.

**A vote AGAINST the constitutional amendment means** the County Charter would not be amended and the County Council remains composed of nine County Council members from separate districts.

### **Question E**

#### **Charter Required Referendum (CB-43-2016) Public Works and Transportation Facilities Bonds**

An Act enabling the County to borrow money and issue bonds in an amount not exceeding \$199,263,000 to finance the design, construction, reconstruction, extension, acquisition,



improvement, enlargement, alteration, renovation, relocation, rehabilitation or repair of Public Works and Transportation Facilities (including roads and bridges, parking lots, and maintenance facilities), as defined therein.

A vote **FOR** the Charter Referendum means: the projects will be funded using county bonds.

A vote **AGAINST** the Charter Referendum means: another means for funding the projects must be found.

#### **Question F**

##### **Charter Required Referendum (CB-47-2016) County Buildings Bonds**

An Act enabling the County to borrow money and issue bonds in an amount not exceeding \$120,494,000 to finance the design, construction, reconstruction, extension, acquisition, improvement, enlargement, alteration, renovation, relocation, rehabilitation or repair of County Buildings, as defined therein.

A vote **FOR** the Charter Referendum means: the projects will be funded using county bonds.

A vote **AGAINST** the Charter Referendum means: another means for funding the projects must be found.

#### **Question G**

##### **Charter Required Referendum (CB-41-2016)(DR-2)**

**Ballot Language:** To provide that in the event the County Attorney determines there is a conflict of interest between the executive and legislative branches on matters requiring legal services and advice, both branches shall engage outside council.

**Origin of the ballot question:** The County Council passed legislation (CB-041-2016) proposing to the voters of Prince George's County, an amendment to Section 508 of the Charter of Prince George's County to provide for outside counsel in the event of a conflict between the executive and legislative branches on matters regarding legal services and advice.

**Present Practice:** The County Attorney provides legal counsel to both the legislative and executive branches of the Prince George's County Government. If one branch seeks guidance that would inversely impact the other branch, a conflict of interest is created, thereby restricting adequate legal advice to both branches of government.

**Proposed Change:** The proposed amendment allows for legal counsel outside of government to be hired and retained for legal advice in situations where there is a conflict of interest between the branches of government.

#### **Arguments in Favor:**

- The Charter Amendment provides clear procedural instruction that when the County Attorney determines a conflict of interest in representing both the executive and legislative branches both branches are to seek outside counsel.

#### **Arguments Against:**

- There are no limitations on costs incurred from outside legal counsel when representing the legislative or executive branch. The amount of adverse fiscal impact

cannot be estimated as proposed billing rates are determined by the outside counsel chosen and the nature and complexity of a matter to be resolved.

- County Council currently has the authority to seek outside counsel when the body determines outside counsel is needed.

**A vote FOR the charter amendment means** the County Executive Branch and the County Legislative Branch will need to seek outside counsel when the County Attorney determines there is a conflict of interest in representing both branches of County Government.

**A vote AGAINST the constitutional amendment means** the County Charter would not be amended.
