FROM OUR CO-PRESIDENTS

Dear League Members,

When researching poverty in Baltimore County, a Goggle search turned up a paper entitled “Poverty and Food Insecurity Affect Thousands of School Children in Baltimore County” by our League member Dr. Laurie Taylor Mitchell and published in the April/May 2015 *Voter*. The article makes the point that poverty in the County is increasing. Most schools within Councilmanic Districts one, four, six, and seven have over 50 percent of the students living in poverty.¹ According to The Annie E. Casey Foundation *Kids Count Report*, in 2013, 22,685 or 12.9% of the County’s children lived in poverty compared with 18,533 or 10.4% in 2017. Compared with Baltimore City in 2013, 41,957 or 32.6% of children in the City were poor; in 2017, 39,518 or 31.8% were poor, a modest decrease. Whereas Baltimore County’s percentage of children in poverty fell by 2.5%, the City’s rate fell only by .8%.² Much of this decline can be attributed to the current stronger economy and low unemployment rate. So, the premise of the article is not born out, but nevertheless the future of the County is inevitably tied to the future of Baltimore City.



The City, of late, has been the subject of much national negative press. Witness the *New York Times Magazine* article “The Tragedy of Baltimore”,³ the Mayor Pugh book scandals, and the trouble regarding the UMMS board’s absence of ethics disclosures and lucrative contracts. (Much of this is reminiscent of the Dale Anderson and Spiro Agnew days as County Executives in Baltimore County.) Will the reputation of the City and the changes underway in the City affect Baltimore County? It is inevitable, unless the County avoids the political pitfalls that are the underlying causes of the City’s problems. That is where the League comes into this story.

This year, the Board has undertaken, with the able leadership of member Barbara Hopkins, the development of a strategic plan. One important component of the plan is to redevelop and reenergize our scrutiny of the activities of our local government. To this end, we need volunteers who will keep up with the deliberations of the County Council and the initiatives of the County Executive and the County Departments.⁴ The goal is to become an influential source of information that is well researched, educational, and non-partisan. The article in *The Voter* authored by Taylor Mitchell survives today as an example of what we can do. Some of the troubles in the City have occurred because of the absence of citizen oversight and participation. Let that not be part of the landscape in the County!

LWVUS

Green New Deal

The LWVUS, weighing in nationally on the recently released Green New Deal, published nine talking points entitled *Engagement with the Green New Deal Letter to Congress* to help us understand our League's position.

"LWVUS provides these talking points to Leagues about our engagement with a possible Green New Deal and climate change policy more generally. These points are meant to inform Leagues of the activities of LWVUS and can be used by individual Leagues in their messaging on this subject.⁵

- *LWVUS joined a January 10th letter with more than 600 organizations urging Congress to hold hearings and openly debate legislation about climate change in response to the momentum across the country to address this important issue.*
- *This letter is a request to hold hearings that will help educate the public on the subject, a process that is critical to democracy and aligns with the League's longstanding support for a transparent process.*
- *As with any omnibus legislation, we will work to elevate and protect the components that align with our positions. On the parts that do not align, we will work to negotiate separately and in a way that supports the League's work.*
- *It is important for LWVUS to be at the table as this process begins to make sure the important work we have done for many decades is included in any comprehensive climate change package that is developed.*
- *Being part of this initial conversation around the subject positions us to influence the outcome of the potential legislation on this issue.*
- *Being at the table is the only way we can advance the work our organization has done on climate change. We can't stand by silently and wait for the legislation to be crafted.*
- *Currently there is no bill, but LWVUS stands ready to negotiate when the time comes.*
- *As with all legislation, we will examine final language before supporting or opposing a bill publicly.*
- *LWVUS staff continues to consult the LWVUS Climate Change Taskforce, a group of dedicated and trusted League leaders, regarding legislation around climate change issues. We will continue to look to our long-standing positions to guide our engagement on this topic."*

Bottom line: LWVUS supports discussion and debate in Congress to educate the public on issues of concern to so many, and to make progress on a host of fronts related to threats to the environment and to vulnerable people overhauling the economy in the process.

The *Student Support Network's* Second Annual Spring Drive was a huge success! Over \$14,600 of in-kind donations were distributed to 22 schools and \$2,300 in monetary donations were used to shop for items over the two days of the drive. The items in greatest demand by schools for students in need were food, underwear, and socks, followed by school supplies. Many thanks to the League members who helped publicize and supported this event; over 50,000 students in Baltimore County Schools now live in severe poverty.

The Summer SNAP for Children Act, HB 338 and SB 218, has passed both the House (118-21) and Senate (47-0)! This bill will ensure that thousands of Maryland children have access to the nutrition they need when school is out of session during the summer and winter months. Counties can apply for the Summer SNAP for Children state funding this fall and the program will begin in July 2020.


