May 16, 2018

Annual Meeting Minutes

Welcome, Introductions, and Agenda: Co-president Krista Boughey called the meeting to order at 5:35 PM. She thanked those involved, especially Roberta Safer, for organizing this annual meeting, and Norma Imershein and Margaret Dunkle for their work in producing the two Books of Annual Meeting materials. She also noted the Remembrance page for Gracie Rymer (page 29, Book II) who was an instrumental member from the early days of the Calvert League.

Introductions were then made around the room with some 35 members in attendance. Krista announced that our guest speaker, Kristen Scott, from the County Board of Elections, was unable to attend this evening. She then asked for approval of the agenda which was moved by Chris Banks and seconded by JC Hooker. The agenda being approved, Krista then read the Meeting Rules, asking for a motion to adopt, which was offered by JC Hooker and seconded by Janet Ashby, and approved by the membership. Krista also read the non-partisan policy to be adopted. Norma Imershein moved and Chris Banks seconded a motion to adopt this policy and it was passed.

Krista announced the appointment of Malcom Funn as Parliamentarian and Norma Imershein as timekeeper for the evening. Greetings from the LWVMD were offered by Liz Demulling, who announced that State Council will be held on June 9th in Harford County. She noted that the Council will be discussing important structural changes under review by the national League to attract younger and less advantaged individuals as part of an effort to update the organization as we approach our 100th anniversary.

The Minutes of the 2017 Annual Meeting were approved after some discussion that the minutes ought to identify which officers of the Board are appointed. This matter will be reviewed and the minutes will be updated. Pat Pease so moved and Anne Mychalus seconded.

Proposed Budget for 2018-2019: The budget was approved; JC Hooker moved and Gladys White seconded.

2018-2019 LWVCC Programs:

Sharron Bickel led a review of the past year's programs and requested input regarding those to be continued into 2018-2019 as follows:

Website: Sharon noted the extraordinary contributions of Miriam Gholl and Pat Hofmann along with others in securing first the Nation Builder software, which was replaced by Wix to provide our online presence.

Transparency Project/Observer Teams: John Perryman referenced his report in Book II and indicated that they do need more volunteer observers, whose function can be accomplished at home by viewing BOCC meetings on television. Pat Pease reported on the Board of Education team. JC Hooker covered the Planning Commission observer team.

Legislative Evening: Cassandra Okumabua described this successful event that brought out more than 100 attendees and included notables from around the county and state as well as hopefuls and community organizations and covering a wide range of topics.

Voter Services: John Perryman described voter registration efforts led by Pat Hofmann in all of the county's libraries as well as their Green Expo and CSM venues. Janet Ashby reported on the Vote 411 project that provides information on a variety of topics about which candidates were questioned along with their responses. It is now available online and promotional materials such as bumper stickers and business cards are available for distribution to alert citizens to the availability of the information.

History Fair: Margaret Dunkle reported on this highly successful program and the League's award for which we received acknowledgment from the School Board; the senior winner was Caliope Millman who created a documentary on women's suffrage. Next year's Fair theme will be Triumph and Tragedy.

Civics Education for Youth: Pat Pease reported on the status of the equity program in the schools, in partnership with #Our Common Calvert.

WOW: Sandra Raviv reported this sell-out event with noted journalist Judy Woodruff as guest speaker. She is looking for one or two League members to assist with the next 2019 WOW event.

Calvert County Green Expo: Krista Boughey is seeking several folks to sit at the LWVCC table this year.

Membership and Membership Events: Roberta Safer reported on last summer's 50th LWVCC Celebration and the (cancelled) winter social, as well as the regularly scheduled EGGS and Issues and Wine and Wishes events that seek to draw people from the community as well as bring the membership together to discuss topics of concern. This year's summer social in August will be held at the Bayside History Museum in North Beach.

Co-Sponsored Events: Pat Hofmann reported on the success and importance of League's association in two collaborative programs, the showing of films and programs at the Library, and our membership in Sustainable Calvert, a coalition of 16-member organizations which she then identified.

Publicity: Krista Boughey reported on the newsletter that will be regularly emailed to the membership.

Cindy Peil moved and ?? seconded that we accept and continue all of the above activities for the next program year. The motion was passed. JC Hooker added that membership needs to be at the top of the list so that we can recruit and expand into the future. Renita Alexander was proposed as our next membership chair, and the motion to approve her in this position passed.

Directions to the Board: a discussion then considered various suggestions from the membership regarding new initiatives and ideas. Margaret Dunkle suggested reviving our policy of student membership with outreach to young folks. Renita Alexander suggested alternating daytime and evening Board meetings so more people who work can attend; Sharron Bickel proposed a second membership meeting per year in addition to the Annual Meeting to comply with the LWVCC bylaws which require two membership meetings per year. Roberta safer offered a history of attempts to hold evening meetings which becomes problematic for senior during winter weather, but felt it was worth trying again. A committee will convene to consider various proposals made. JC Hooker proposed that the Bylaws be revised to allow for email vote; this has been put into practice, but nothing official appears in the Bylaws.

Liz Demuling noted that the State Board has not yet taken a position on state primaries based upon local league consensus meetings.

Pat Hofmann suggested that more voter registration sessions be held at the libraries before the midterm elections.

*Following discussion of how this slate is not in compliance with Bylaw requirements, Grace Mary Brady volunteered to withdraw her name as elected director nominee for the term 2018-2020. She volunteered to be a nominee for the position of elected director for the remaining unexpired term 2017-2019. (This position was never filled by the elected director).

Sharron Bickel moved and Krista Boughey seconded a motion to accept the slate of officers and directors as revised. The slate was accepted.

Malcolm Funn was proposed for the Nominating Committee by Roberta Safer; Helenmary Ball seconded and the motion was passed. A motion was then made and passed to accept the Nominating Committee report with changes above.

Roberta Safer gave a brief overview of her involvement in LWVCC going back in time; she will be leaving the League to move to CA later this summer. She described an early fashion-show fund-raiser to support the "Know Your County" League project that she and Barbara Fedderhof organized which proved so successful that it was held five more years. She described the four years of her involvement on State Board which included a 50-year anniversary celebration attended by 50 members, as well as many events at the Cosmos Club. She recalled the exchange program with Zambia and the hosting of the Russian delegation here, the may socials she has organized, and how the League has tackled difficult issues including the development of the transparency teams as well as events that have not always been well received by other county figures.

Christine Scoll reported on the State Board of Elections that found 2-3 probes were made during the last election into the voting system. Extra security measures have been taken and several times per week the system is checked by staff who have security clearance.

Two upcoming events were announced: The Concerned Black Women and NAACP are hosting a program on May 30th at 7 PM at the Prince Frederick Library about the Josiah Henson story. Henson was born in Port Tobacco, MD and was held as a slave, first in Montgomery County and then in Kentucky, before he was eventually able to return to MD, buy his freedom, and make his way to Canada.

Also, Dr. Renee Yuengling will speak on Unconscious Bias on June 3rd from 4-6:30 PM at the Library. Before adjourning the meeting, elected officials in attendance at the Annual Meeting were recognized: Helenmary Ball, Mike Fitton, Dawn Balinski, Margaret Phipps, and Susie Hance-Wells. The meeting was adjourned at 7:35 PM.

Calvert County LWV Nonpartisan Policy

Revised May 2017

Adopted by the League of Women Voters of Calvert County

The purpose of the League of Women Voters is to promote political responsibility through informed and active participation of citizens in government. The League of Women Voters (LWV) is nonpartisan. It does not support or oppose any political party or candidate; it is political in that it takes positions on selected governmental issues after member study and agreement.

The nonpartisan policy is a source of strength to the LWV and is the cornerstone of the Voters Service Program. Candidates are willing to appear on the LWV platforms and to provide materials for the Voters' Guide because they are confident they will be treated fairly and the material will be used for nonpartisan purposes. Organizations, citizens and businesses also have confidence in the League because of the nonpartisan policy.

Voter service activities are to be carried out in a professional, neutral way as not to display favoritism or discrimination to any party, faction or candidate. The ground rules are to be the same for candidates in Voters' Guides and in candidates' meetings and/or forums.

The LWV urges members to become fully informed about candidates and issues and encourages them to work actively in the political process. Calvert League members, except officers and board members-see next paragraph, may seek an active role in the nomination of candidates for public office, run for office, stimulate public discussion of candidates’ views during the campaign, urge citizen commitment to parties and candidates by means of political contributions and, in general, take part in the political activities of their choice. Individual League members may take action on whatever they choose; as long as they do so in their own name, do not use the League name, and leave no impression they speak for the League.

Board Members

Elected Office. Board members shall not run for nor hold any partisan public elective office.

Political Party Office. Board members, who represent the League before the public or hold voter service portfolios, shall not serve in any position in a political party.

Campaign Contributions. Board members, except the LWV Calvert President and Voter Service Director, may attend fundraising events and make campaign contributions to individual candidates.

Political Campaigns. Board members may not chair or administer fundraising or campaigns for political parties or political candidates or campaign for their own elective office, partisan or nonpartisan.

Social and Other Media. A Board member shall not indicate her/his political affiliations or candidate preferences at any level of government in the media (including on social networking sites or other public venues) that also prominently identify her/him as a member of the LWV Calvert Board.

Petitions. Board members may sign petitions.

Spouses and Relatives. The political activity of a spouse or relative of a board member should be considered separate and distinct from the action of the Board member.

Additional Clarification. Board members shall present questions about specific situations to the LWV Calvert Board where the foregoing policies do not resolve the question.
