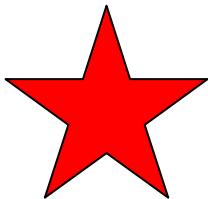

Highlights of the LWVAAC Annual Meeting, Saturday, April 30

Business Meeting:

- Thirty-six people attended, including our liaison from the LWVMD board, Betsy Singer, who commended our League on its many achievements this year.
- Treasurer Fussell reported that our Education Fund received a \$1,000 bequest from the estate of Ruth J. Smith. Members approved the 2016-17 LWVAAC budget as proposed.
- Program chair Siegel sought volunteers for the Transportation and School subcommittees of the Community Relations fact-finding project. Fussell encouraged interested members to join the Public Housing subcommittee.
- Members voted to elect the following slate to a two-year term: Alfa Stevens, Treasurer, and Carolyn Ciepiela, Lois Coon and Kathy Larrabee, Directors. The 2016-17 Nominating committee will be chaired by Anne Schifferle, with Shirley Hatch as the off-board member.

Members' Direction to the Board:

- Strandquist reported an issue with polling place accessibility, and asked whether the League could investigate.
- Fussell suggested placing highlights of the *Report from State Circle* in our newsletter.
- Siegel asked members their opinion of this year's discussion based on the book "Give Us the Ballot." Several responded in favor of scheduling another similar meeting featuring a book or other readings.
- Cochran urged the League to monitor County Council and Board of Education meetings in person; "being there" is essential.
- Viamonte expressed concern about increasing divisiveness in many areas of U.S. culture, and asked the League to address this issue regardless of the outcome of the 2016 general election.
- Dickerson suggested a survey to ascertain the effectiveness of *Voters' Guides* and Vote411.org cards.
- Cochran said LWVAAC should use its position on immigration to educate citizens. She suggested that our League work more on development issues with GAN (Growth Action Network), and reminded us that state and national LWV positions may be used a basis for action.

Planning for 2016-17: Notes from the LWVAAC Board Retreat, June 11, 2016

Each summer, LWVAAC board members and interested members gather for an informal brainstorming session that we call “retreat.” The purpose is to set goals and make preliminary plans for the coming League year; however, the mental effort is usually made very enjoyable by a lovely venue and delicious potluck feast.

This year was no exception! Host Arlene Gavin welcomed us into her comfortable living room with its wall-to-wall views of the woods, and the buffet was laden with board members’ culinary contributions of every kind.

We began by reviewing members’ direction to the board at the annual meeting (see article on p. 4), and assigning responsibility for follow-up actions when appropriate. Program chair Myrna Siegel then introduced a suggested calendar of monthly activities for our consideration and discussion. With respect to the candidates’ forum scheduled for October, Carolyn Ciepiela sought guidance on which Congressional districts to invite (Anne Arundel County contains sections of four districts: 2, 3,4 and 5). Membership chair Kathy Larrabee proposed a new activity called the Third Thursday League Connection (TTLC), designed to be a no-host, no-agenda get-together for LWVAAC members and friends. She also cited the importance of recognizing and celebrating LWVAAC members who achieve “life member” status.

As a result of our retreat discussions, States’ Attorney Wes Adams has been invited to speak on recent criminal justice reforms at our fall kickoff meeting on Tuesday, September 20. In addition, the inaugural Third Thursday League Connection (TTLC) has been scheduled for July 21, 5 p.m. at Carrol’s Creek Café in Annapolis. Every year, representatives of the 14 local Leagues in Maryland get to make decisions about the state League’s upcoming program year. In even-numbered years, a partial-day meeting called Council is held to conduct necessary League business, and to provide participants with information and networking opportunities.

On Saturday, May 21, LWVAAC members Lois Fussell and Kathy Larrabee (pictured right) joined other local League delegates and the state League’s board of directors at the LWVMD Council hosted at Hood College by the League of Women Voters of Frederick County. COMMUNITY OUTREACH & ACTION

Annual Meeting Speaker Discusses Poverty Amidst Plenty in Anne Arundel County

Dr. Pamela Brown, Executive Director of Anne Arundel County Partnership for Children, Youth and Families (ACY) was the featured speaker at the LWVAAC’S Annual Meeting, Saturday, April 30, 2016. Dr. Brown, who earned her doctorate at Florida Atlantic University, is certified to conduct ethical research. She is a University of Phoenix Research Reviewer and Dissertation Chair specializing in qualitative case study methods. Dr. Brown has been conducting community needs assessments for over 20 years, most recently researching and writing the fifth (2015) edition of *Poverty Amidst Plenty* for the Community Foundation of Anne Arundel County.

ACY has a staff of 12, reports to the County Executive and is self-funded through grants and other means. They conduct programs with United Way and other organizations with a multi-dimensional approach to community problems. Her organization focuses on populations in need, including hungry and disconnected student children, homeless youth, and families impacted by incarceration.

Dr. Brown explained the “geography of poverty.” She has developed maps showing areas with low income households, high crime rates, instances of mental illness, ER visits, food deserts, public housing and public transportation in Anne Arundel County. In this county, problems resulting from poverty are heavily

concentrated in North County, particularly in the Glen Burnie area, but resources to attack the problems are primarily in Annapolis. This demonstrates poor planning and coordination between agencies. She also singled out the flawed public transportation system, which seems designed to serve shoppers rather than people going to work. She is encouraged that County Executive Schuh is considering this problem.



Dr. Brown said that three key elements in alleviating poverty are affordable housing, affordable child care and transportation. Currently, housing is out of reach for many people: a single-earner family with two children needs a minimum of \$25/hour to live here, but 50,000 residents earn only \$12/hour. Even worse, quality child care has a price tag of \$21,000 per year!

The gap between rich and poor is growing rapidly. While the overall poverty rate in the county is 5%, 26% of Brooklyn Park residents live in poverty. Countywide, about 12% of young people age 16-24 are unemployed, but the rate for blacks is 20%, Hispanics 13%, whites 10%.

The number of homeless families is rising, and there are 1,400 homeless children in our schools. Of these, 300 are “unaccompanied.” Dr. Brown mentioned five children living in

a Glen Burnie hardware store with no adult guidance, but working and attending school.

Looking ahead, Dr. Brown noted that the population of senior citizens will continue to grow until 2030. Although “baby boomers” believe they are “redefining” old age, significant impacts on health care and hospitals loom. While poverty is an issue for many in the county, seniors from all income levels experience depression and loneliness.

ACY has an extensive community plan, but programs have not been coordinated thus far. There is a need for elected officials, planners, work force developers, the business community - everyone - to understand the patterns laid out in Dr. Brown’s talk. All of these entities benefit from, and recognize the importance of, a financially-healthy community, politics notwithstanding. Legislative action will play a role in solving some of the problems, and Dr. Brown believes the League can help in that arena.

Environment: Pollinator Protection Act

Maryland’s Pollinator Protection Act passed in the General Assembly and became law without Governor Hogan’s signature. This bill restricts consumer use of neonics, which are systemic pesticides known to contribute to bee mortality and declines in native pollinators including wild bees, birds and butterflies. Studies also show harm to aquatic molting blue crabs and macro-invertebrates from neonics. They may also affect the developing human nervous system.

Managed bees are critical to our food supply, pollinating many of our favorite foods. Known as the “angels of agriculture,” bees pollinate 71 of the 100 crops that make up the majority of the world’s food supply and many of the fruits and vegetables grown in Maryland.

The Pollinator Protection Act takes neonics off the retail store shelves and prohibits anyone who is not a veterinarian, farmer, certified pesticide applicator or their employee from using them. This should be the first step in eliminating neonics altogether.
