The Value of Civic Participation

Forest Conservation Bill 68-19 Passes

On November 18, the Anne Arundel County Council passed Forest Conservation Bill 68-19 unanimously (7-0). This was a big shift in support from where the bill started when first introduced in September 2019. The passage of Bill 68-19 is a good example of bipartisanship and community engagement. The Council heard three hours of testimony for and against the bill and worked through three rounds of amendments.

Passage of this bill has been noted as historic for Anne Arundel County. No other Maryland jurisdiction has

increased the amount of forest required, under state law, to be conserved during residential, industrial or commercial development. The County now has one of the highest fee-in-lieu payments (fee paid in lieu of planting required reforestation amount) and the highest fee in the state for clearing of trees in violation. In addition, the County has incentivized areas for revitalization.

Kudos to all League members who got involved, whether with phone calls or letters to your Council member or testimony before the Council. Thank you!

LWVAAC Board Meeting Highlights - November 19, 2019

Plans for celebrating the 19th Amendment Centennial are being firmed up. The Board voted to use funds from the Education Fund to pay for the onewoman performance by Kate Campbell Stevenson, "Amending America: How Women Won the Vote". There will also be a viewing of "Iron Jawed Angels". Both events will take place in April. In addition, bookmarks are being created with information about the Suffrage Movement on one side and LWVAAC on the other. Bookmarks will be distributed throughout the libraries.

Observer Corps has been active, particularly in the area of housing. They attended a meeting of the Housing Commission of AA County. We may revisit and update our position on Affordable Housing.

Programs: Plans are underway for a presentation on the "Electoral College Then and Now" in March. In January, members will engage in a brainstorming session about civic education based on an LWVMD fact sheet on the subject. Also in January, members will meet for Program Planning for LWVUS and LWVAAC.
