

## About the League of Women Voters General Election Voters' Guide

**The League of Women Voters (LWV) does not support or oppose any candidate or political party.** It is a nonpartisan organization of women and men that promotes informed participation in government. This *Voters' Guide* is published by the LWV Education Fund, a 501(c)(3) nonprofit, to assist citizens in their decision making process as they prepare to vote in the November 2016 presidential election.

The LWV has a long history of impartially reporting candidates' verbatim responses on issues important to voters. To prepare this *Voters' Guide*, the LWV sent questions to all qualified candidates requesting a reply before our mid-September print deadline. Responses appear exactly as entered by the candidates through an online interface. Answers end when the pre-established 400-character limit is reached. Candidates and offices are listed in ballot order.

Candidates are welcome to add to or revise their responses after the print deadline. The **Vote411.org** website has current candidate information and photographs, as well as responses from write-in candidates. Voters are encouraged to visit **Vote411.org** prior to voting for updated responses, as well as information on candidate forums, voting sites and a personalized ballot.

# Frequently Asked Questions About Voting in Maryland

#### Am I registered to vote?

In Maryland, registration is permanent as long as you continue to live in the state and keep your name and address current. To verify that your registration is up-to-date, go to **voterservices.elections.maryland.gov/ VoterSearch,** or call the Board of Elections at (410) 222-6600.

#### Am I eligible to register to vote?

To register, you must be at least 16 years old, a U.S. citizen and a Maryland resident. You must not be under court-ordered ineligibility to vote due to mental disability, nor convicted of buying or selling votes. If you have been convicted of a felony, you must have completed serving any prison sentence.

# How and when can I register, change my party or update my address?

To vote absentee or on General Election Day, November 8, the deadline to register or make changes to your registration is Tuesday, October 18, at 9 PM. Go to <u>aacounty.org/</u> <u>elections</u> and click "Register to Vote."

You may also register to vote during early voting (October 27-November 3) at any Anne Arundel County early voting center. Bring a Maryland driver's license, identification card, learner's permit, or other proof of residency. If you are already registered, you may correct your address, but you cannot change your party affiliation during early voting.

#### Who can vote in the General Election?

Registered voters must be at least 18 years of age on or before November 8, 2016 to vote in the General Election.

#### What Congressional District am I in?

To determine your congressional district, enter your residential address in **Vote411.org** or **mdelect.net**, check your sample ballot or call the Board of Elections (410) 222-6600.

#### Write-In Candidates

Maryland law allows a voter to write in a candidate's name for a General Election office. Write-in candidates have until Thursday, October 20 to file their candidacy. A list of write-in candidates who have filed with the State Board of Elections may be found at all polling places and online at elections.state.md.us.

#### **VOTE ABSENTEE**

Any Maryland registered voter may vote by absentee ballot. To request an absentee ballot application, go to aacounty.org/elections and click on "Request an Absentee Ballot," or contact the Board of Elections at (410) 222-6600 or elections@aacounty.org. You may receive the ballot by mail, fax, email or in person, and application deadlines vary accordingly. Details may be found in the sample ballot mailed by the Board of Elections, or at **aacounty.org/elections**. The completed absentee ballot must be postmarked on or before General Election Day, or hand delivered to the County Board of Elections before 8 PM on General Election Day, Tuesday, November 8, 2016.

#### **VOTE ON GENERAL ELECTION DAY**

Your local assigned polling place will be open from 7 AM to 8 PM on Tuesday, November 8, General Election Day. If you are unsure of your assigned polling place, check the back of your sample ballot or go to

voterservices.election.maryland.gov/ PollingPlaceSearch.

First time voters in Maryland should bring identification with your current address, such as a driver's license.

**Duties:** The President is the head of state of the United States of America and is the Chief Executive Officer and the Commander in Chief of all military forces. The powers of the President are described in the U.S. Constitution and federal law. Subject to Senate approval, the President appoints members of the Cabinet, ambassadors to other nations and the United Nations, Supreme Court Justices and federal judges. The President, along with the Cabinet and its agencies, is responsible for carrying out and enforcing the laws of the United States. The President may also recommend legislation to the United States Congress.

**How Elected:** Every four years, political parties nominate candidates to run for President of the United States in a general election that is held on the first Tuesday, after the first Monday in November. Although all parties use conventions to nominate their candidates, in most states the Democratic and Republican parties also run state-wide primary elections or caucuses. The results of the primary elections influence how the delegates to their respective party's convention will cast ballots for candidates for President. The degree to which the result of the primary influences the votes of delegates at conventions varies from state to state.

**Term:** Four years. Limit of two terms.

**Salary:** \$400,000 per year.

**Ground Rules for Inclusion in this Voters' Guide:** All qualified presidential candidates were invited to provide biographical information and responses to five specific questions. Candidates qualified if they met the following criteria:

- (1) The candidate must have made a public announcement of her/his intention to run for her/his party's nomination for President;
- (2) The candidate must meet the Presidential Election Campaign Fund Act's minimum contribution threshold requirements for qualifying for matching funds, based on the most recent data publicly available on the FEC website; and
- (3) The candidate must qualify for the ballot in enough states to win a majority of electoral votes. Responses were limited to 400 characters and were truncated thereafter.

## **U.S. Senator**

**Duties:** U.S. Senators share the responsibility with Representatives for enactment of the nation's laws as provided for in the U.S. Constitution. They may also conduct investigations on issues of national importance. The Senate is charged with ratifying treaties established by the President and confirms Presidential appointments.

**How Elected**: The Senate consists of 100 members, two from each state. Senators are elected by a state at large and serve for six years. One-third of the Senate is up for election every two years. A Senator must be at least 30 years of age and must have been a citizen of the United States for at least nine years. In 2016, Maryland voters will elect one Senator.

**Term**: Six years

**Base Salary**: \$174,000

- 1. QUALIFICATIONS: How does your experience prepare you for the duties of a Senator?
- 2. ECONOMY: What economic policies would you support to assist low and middle income citizens?
- 3. FOREIGN POLICY: What are the most important foreign policy issues and how would you address
- 4. IMMIGRATION: What changes, if any, would you support in immigration policy?
- 5. ENVIRONMENT: What is the most pressing environmental problem and what measures would you support to address it?
- 6. INEQUALITY: What policies would you support to address increasing concern about economic, racial, and social inequality?
- 7. TAX REFORM: What changes, if any, would you support in federal tax policy?
- 8. OTHER PRIORITIES: What other issues are priorities for you?

## Kathy Szeliga (REP)

1. QUALIFICATIONS: As a Maryland small business owner, I understand the tools business leaders and job creators need to get the people of Maryland back to work. After working to elect Governor Larry Hogan in 2014, I was selected to serve as the minority leader in the State House. Maryland is starting to change for the better; now we need to bring real change to Washington.

- **2. ECONOMY:** We need to empower more Marylanders with opportunities to achieve the American dream. By improving our education system, we can help more people improve their lives and increase their incomes. Our students should be presented with as many options as possible so they are fully prepared for the current job market, including charter schools or vocational programs.
- **3. FOREIGN POLICY:** One of the most serious threats facing our country is radical Islamic terrorism. - **6. INEQUALITY:** Education and jobs. The fact that we are not preparing our students for the true job market they are facing. We need plumbers, military personnel, and people in law enforcements just as much as we need doctors, lawyers, and accountants. That is why it is extremely important that we reform our education system so that our children are given every opportunity.
- **7. TAX REFORM:** Our tax code is yet another example that the federal government has become too complex for the average person to navigate. The tax code is more than 73,000 pages long. There is no way Maryland families and small businesses could begin to understand it. We must simplify our tax code and eliminate loopholes.
- **8. OTHER PRIORITIES:** As the daughter of an Army officer, I strongly believe we must honor the promises we have made to our men and women in uniform. But right now, we are failing them. The VA is a bureaucratic nightmare and needs

immediate reform. These brave men and women have sacrificed so much to keep our country safe – it is the least we can do.

- 1. QUALIFICATIONS: Like Senator Barbara Mikulski, I believe in delivering results. In Congress and the General Assembly, I've worked together with grassroots activists and community leaders to make a positive difference. I know when to stand and fight for what we believe in, and when to find common ground to achieve results for Marylanders. I've been endorsed by Maryland groups like SEIU, MD Firefighters, and UAW.
- **2. ECONOMY:** I have a plan that cracks down on Wall Street's risky financial dealings and boosts paychecks of working Americans with a Paycheck Bonus Tax Credit, with a savers bonus to help families prepare for retirement. We must also strengthen the safety net, raise the minimum wage, improve access to affordable childcare, provide earned paid sick leave and family leave, and ensure equal pay for equal work.
- **3. FOREIGN POLICY:** I opposed the Iraq War from the start and believe we must work with and support our allies in the Middle East to defeat ISIL. I oppose putting troops on the ground there and risking Iraq 2.0. We need to support our soldiers and returning veterans by providing healthcare, education, and job opportunities, and ending veteran homelessness.
- **4. IMMIGRATION:** I support comprehensive immigration reform to strengthen border security, streamline our visa system, and create an earned path to citizenship to bring the undocumented out of the shadows. This strategy will boost job growth, reduce our deficits, increase the Social Security Trust Fund, and strengthen our national security. I'm pleased to be endorsed by CASA de Maryland.
- **5. ENVIRONMENT:** Every community must be safe from toxic pollutants and chemicals like lead. The Sierra Club endorsed me because I fight for environmental justice and have a plan to address climate change by cutting carbon pollution while also putting money back in the pockets of middle class families. I've fought to stop oil drilling in the Chesapeake Bay watershed and for federal support for clean-up efforts.
- **6. INEQUALITY:** Our country must meet its promise of equal opportunity and justice for all, but we're not there yet. Our system is rigged for the wealthy and privileged. I want to stop CEOs from writing off big bonuses if they don't give employees raises. We have to open the doors of opportunity to all with early education, debt-free college, and

- job training. We must end unjust mass incarceration.
- **7. TAX REFORM:** Our tax code is rigged for those who make money off of money instead of working Americans. **How elected:** The state is divided into 8 Judicial Circuits. The General Assembly determines the number of judges in each circuit and county. When there is a vacancy, the Governor appoints a qualified person to fill the office. Each newly appointed Circuit Court judge then must stand for office at the first election that occurs at least one year after the vacancy happened. One or more other qualified members of the bar may also run to fill the vacancy. All candidates run on both the Democratic and Republican primary ballots. The winners of each primary (equal to the number of seats to be filled) advance to the general election ballot, but without party designation.

**Term:** Fifteen years, no term limit. Mandatory retirement age of 70 years.

2. COURT NEEDS: All citizens deserve equal access to justice and the fair, affordable and efficient administration of their court system. Maryland's judicial system must better insure that these needs are met for everyone. For criminal cases, public defenders are available to qualified

individuals. However, there is no similar service for the poor in civil matters such as divorce and domestic violence cases.

- **3. ACCESS TO JUSTICE:** Some good pro bono and legal assistance programs currently exist, but those in need are often not aware of them. We need to better communicate these opportunities to the public. Also, attorneys need to be encouraged to volunteer their services more often, either through mandatory requirements or greater awareness.

## **Court of Appeals**

**Duties:** The Court of Appeals is the highest court in the State (commonly called the Supreme Court in other states and at the federal level). It hears cases almost exclusively by way of certiorari, a process which gives the court discretion to decide which cases to hear. However, the Court of Appeals is mandated by law to hear cases involving the death penalty, legislative redistricting, removal of certain officers, and certifications of guestions of law.

Salary: \$176,433 annual base.

**Term:** Ten years, no term limit. Mandatory retirement age of 70 years.

**How Elected:** Members of the Court are initially appointed by the Governor and confirmed by the Senate. Subsequently, they run for office on their records, unopposed. If voters reject a judge's retention in office or there is a tie vote, the office becomes vacant and must be filled by a new appointment. Otherwise, the incumbent judge remains in office for a ten-year term. The Court is composed of seven judges, with one elected from each of seven judicial circuits.

## **Court of Special Appeals**

**Duties:** Judges preside in the Court of Special Appeals, the intermediate appellate court in Maryland. The Court reviews the actions and decisions of the Circuit Court and of the Orphans' Court in cases brought before it. The Court, usually sitting in panels of three judges, decides if the trial judge followed the law and legal precedent.

Salary: \$163,633 annual base.

**Term:** Ten years, no term limit. Mandatory retirement age of 70 years.

**How Elected:** When there is a vacancy on the Court of Special Appeals, the governor appoints a qualified person to fill the office, with the consent of the State Senate. Once appointed, the appellate judge holds the office until the first election that occurs at least one year after the vacancy happened. At that time, the judge runs for an uncontested election for a ten-year term on their record (yes or no for continuance in office). No one is permitted to file against them. If the incumbent judge is approved, the judge faces another "retention election" every ten years to continue in office. If the incumbent judge is rejected by the voters, the post becomes vacant, and the governor makes a new appointment. The Court is composed of 15 judges: eight at large and one each from seven appellate judicial districts.

# Anne Arundel County Board of Education

**Membership:** The Board is comprised of nine members: five adult Members, each of whom resides in a different legislative district (Districts 30, 31, 32, 33, and that part of District 21 that lies within Anne Arundel County); three adult Members appointed from the county at-large; and one Student Member, who is a regularly enrolled senior-year student of good character and in good standing in a public county high school. With the exception of the Student Member, all Board Members must be registered voters of Anne Arundel County and may not be an employee or contractor of the Board.

**Selection:** The adult Members are appointed by the Governor from a list of nominees submitted by the School Board Nominating Commission of Anne Arundel County. The Student Member is elected to the Board by the Chesapeake Regional Association of Student Councils (CRASC), and confirmed and appointed by the Governor.

**Duties:** The powers and mandatory duties of the Board are divided into executive, legislative and quasi-judicial responsibilities. They include, but are not limited to the following: selecting and appointing the Superintendent of Schools; appointing personnel; continuous appraisal of the educational and administrative management of the school system; communicating and meeting with community members, staff and students; ratifying collective bargaining agreements; adopting policies, budgets, and courses of study; establishing school boundaries; making decisions on facility, procurement and financial matters; and deciding appeals.

**Term of Office:** The eight adult Members are appointed to a term of five years, and continue to serve until a successor is appointed and qualifies, subject to the approval or rejection of registered voters at the next general election following appointment. The Student Member is elected for a one-year term beginning July 1, and continues to serve until a successor is appointed and qualifies.

**Base compensation:** \$6,000 per year

**Background:** In November, county voters will be asked to mark their ballots **FOR** or **AGAINST** one amendment to the Maryland Constitution and six amendments to the Anne Arundel County Charter. These amendments have been passed by the state legislature and county council, respectively, but must be approved by voters before they become part of the state constitution or county charter. They are presented on the ballot as questions. In the following explanations, the text of the proposed amendments that will appear on the ballot appears in bold type.

# **Maryland Statewide**

## **QUESTION 1**

Appointments and Special Elections for Attorney General and Comptroller Constitutional Amendment (Ch. 511 of the 2016 Legislative Session)

Amending Article V, Section 5 and Article VI, Section 1 of the Maryland Constitution

Changes the way the Governor fills a vacancy of the Attorney General or the Comptroller and requires a special election for vacancies that occur on or before a certain date. Under current law, the Governor fills a vacancy by appointing an individual to serve for the remainder of the term. Under the amended law, if the vacating Attorney General or Comptroller was a member of a political party, the Governor must fill the vacancy from a list of three names provided by the political party of the vacating official, and if no names are provided by the political party within a set time period, then the Governor must select a successor from the political party of the vacating official. If the vacating Attorney General or Comptroller was not a member of a political party, then the amended law requires the Governor to appoint any qualified individual. The Governor must make the appointment within a set time period following the vacancy. The amended law requires a special election to replace the successor if the vacancy occurs early enough in the term to allow for candidates to participate in the regular elections held in the second year of the vacating official's term.

**Origin of the Amendment**: The 2016 session of the General Assembly passed legislation (HB 260) proposing a constitutional amendment to change how vacancies in the offices of Attorney General and Comptroller will be filled. A bill that amends the Maryland Constitution requires a three/fifth vote in each chamber (Maryland Senate and House of Delegates) and approval by the voters at the next general election.

**Present Practice:** Under the Maryland Constitution, when a vacancy occurs in the office of the Attorney General or Comptroller, the Governor appoints a person to serve for the rest of that term. Appointment of the Comptroller also requires the approval of the Maryland Senate. The Governor is not required to choose someone of the same political affiliation as the person being replaced. There also is no provision for the voters to choose someone to fill a vacancy in either office through a special election, no matter how much time is left in the term of office.

**Proposed Change:** The Governor would be required to appoint a replacement Attorney General or Comptroller within 30 days of the vacancy, with someone from a list of three persons submitted by the State Central Committee of the political party of the previous office holder. (If the person being replaced was not affiliated with a political party, the Governor could appoint any qualified person.) The appointed person would serve for the rest of the original term if the vacancy occurs in the last two years of the term. However, if the vacancy occurs six weeks before a scheduled presidential primary (that is, there are more than two years remaining in the term) a special election would be held as part of the presidential election process.

#### **Arguments FOR the amendment:**

- The person appointed by the Governor must be of the same political affiliation as the person being replaced. This reflects the preferences of the voters when they chose the Attorney General or Comptroller at the last election.
- If there are more than two years left in the term, the voters are able to choose who will fill the office at special elections held at the same time as the next presidential primary and general elections.
- By choosing the new official at the same time as the scheduled elections, there would be no

additional costs for conducting separate special elections.

It is likely that many more voters would participate if the vacancy is filled at a regularly scheduled election, than if the special elections were held at a separate time.

#### **Arguments AGAINST the amendment:**

- Requiring the Governor to appoint someone recommended by a political party central committee gives power to a small group of people elected only by members of that political party.
- Under current rules, the Governor may appoint a qualified person of any political affiliation.
- Holding a special election to choose someone to fill the last two years of a term when the Governor has already appointed a replacement may result in frequent changes in leadership.

A vote FOR the constitutional amendment means the Maryland Constitution would be amended to (1) require the Governor to fill a vacancy for Attorney General or Comptroller with someone from the same political affiliation as the person being replaced; and

(2) require that a replacement be elected at the same time as the presidential election if more than two years are left in the term.

A vote AGAINST the constitutional amendment means the Maryland Constitution would not be amended. When a vacancy occurs, the Governor may appoint someone of any political affiliation to fill the rest of the term of Attorney General or Comptroller.

# **Anne Arundel County**

## **QUESTION A Charter Amendment: Compilation of Laws**

To amend the Anne Arundel County Charter to remove the requirement of recodifying the Anne Arundel County Code at least every ten years.

Origin of the Amendment: County Executive

Present Practice: The County Code is supplemented and codified on an ongoing basis, and is readily available in both paper and electronic formats.

**Proposed Change:** The present practice will continue and the Charter will updated to remove an obsolete requirement.

**Pro:** The requirement in the Charter is obsolete because electronic methods allows ongoing compilation of the laws. This amendment corrects the Charter to reflect present-day technology and norms.

Con: None

A vote **FOR** the amendment removes the requirement that the entire County Code be recodified every ten years. A vote **AGAINST** the amendment retains the requirement for recodification of the County Code every ten years. (Resolution 6-16, passed April 4, 2016)

## **QUESTION B**

### **Charter Amendment: Effective Date of Ordinances - Appropriations**

To amend the Anne Arundel County Charter to provide that ordinances related to transfers of appropriations under Charter Section 711, supplementary appropriations under Charter Section 712, and amendments of the capital budget under Charter Section 716 shall take effect when they become law.

Origin of the Amendment: County Executive

**Present Practice:** The Charter imposes a 45 day wait period for routine appropriations bills to take effect after becoming law; only emergency ordinances become effective immediately upon signing. To avoid the delay in funding, some appropriations bills are currently designated emergency ordinances.

# **Anne Arundel County**

**Proposed Change:** Ordinances for routine appropriations will become effective immediately upon becoming law.

**Pro:** This amendment will expedite routine fund transfers, and eliminate confusion with actual emergency appropriations.

**Con:** Appropriations bills that amend the approved budget for routine expenditures will no longer to subject to a 45 day wait period.

A vote **FOR** the amendment allows ordinances related to transfer of appropriations, supplemental appropriations, and amendments to the capital budget to become effective immediately upon signing (the date they become law), thereby removing the necessity of a 45 day wait period for ordinances other than emergency ordinances to become effective.

A vote **AGAINST** the amendment leaves the effective date of ordinances related to transfer of appropriations, supplemental appropriations, and amendments to the capital budget as it is currently in the Charter, 45 days after becoming law, unless designated an emergency ordinance.

(Resolution 7-16, passed April 4, 2016)

# QUESTION C Charter Amendment: Purchasing Contract Limits

To amend the County Charter to permit the County Council to increase the minimum value of purchases and contracts requiring competitive bidding from \$25,000 to an amount up to \$75,000.

Origin of the Amendment: County Executive

**Present Practice:** Purchases valued at \$25,000 or more require a formal sealed bidding process. For lesser amounts down to \$5,000, the County generally seeks three written, but unsealed, bids. **Proposed Change:** A full competitive bidding process would only be required on purchases of \$75,000

**Proposed Change:** A full competitive bidding process would only be required on purchases of \$75,000 or more.

**Pro:** Raising the floor for full competitive bidding to \$75,000 will make the purchasing process less costly and more efficient, and will apply to a large percentage of County purchases and contracts. Most purchases under \$75,000 will still be subject to competition with unsealed, written bids. Anne Arundel County's current minimum for competitive procurement is lower than most county jurisdictions in Maryland.

**Con:** Not requiring a full competitive procurement process for purchases between \$25,000 and \$75,000 may disadvantage small businesses. Savings resulting from formal competitive bidding sometimes offset the added cost of administration.

A vote **FOR** the amendment raises the minimum dollar amount of procurement contracts requiring full competitive bidding from \$25,000 to \$75,000.

A vote **AGAINST** the amendment keeps \$25,000 as the minimum dollar amount of procurement contracts requiring full competitive bidding. (Resolution 8-16, passed April 4, 2016)

## **QUESTION D**

# Charter Amendment: Budgetary and Fiscal Procedures - Pre-Submission Public Meetings

To amend the Anne Arundel County Charter to require the County Executive to hold two public meetings on the proposed County budget no later than 30 days before the start of the annual legislative session of the County Council, before submission to the County Council.

Origin of the Amendment: County Council

**Present Practice:** There is currently no requirement for public meetings and input on the County budget during its preparation by the County Executive (budget season). The County Executive may choose to hold town hall meetings to receive public comment.

Proposed Change: The County Executive would be required to hold two public meetings during

the budget season to hear public comments and proposals for inclusion.

**Pro:** This requirement would provide members of the public an opportunity to express budgetary priorities and concerns to the County Executive before the proposed budget is finalized for submission to County Council.

**Con:** The public is able to submit comments to the County Executive through calls, letters and social media without the cost of a meeting.

A vote **FOR** the amendment requires the County Executive to hold at least two public meetings during the budget season in order to receive public comment and proposals for inclusion in the proposed County budget. A vote **AGAINST** the amendment leaves the Charter as it is with no requirement for the County Executive to hold public meetings during budget season. (Resolution 30-16, passed June 6, 2016)

## **QUESTION E**

# Charter Amendment: The County Executive - Powers and Duties of Office - Director of Programming

To amend the Anne Arundel County Charter to change the title of Director of Programming to Economic Development Officer in Section 405 of the Charter.

**Origin of the Amendment:** County Executive

**Present Practice:** The Economic Development Officer performs the duties of the office of Director of Programming as enumerated in the Charter. The title Director of Programming is no longer in use. **Proposed Change:** The title for this office is updated to Economic Development Officer in the Charter.

**Pro:** This amendment replaces an obsolete title with the title presently in use.

Con: None.

A vote **FOR** the amendment changes the title of Director of Programming in the Charter to the currently used title of Economic Development Officer.

A vote **AGAINST** the amendment keeps the obsolete title of Director of Programming in the Charter. (Resolution 31-16, passed July 5, 2016)

## QUESTION F

#### **Charter Amendment: Interim Notes**

To amend the Anne Arundel County Charter to allow the County Council to pass ordinances authorizing the issuance of interim notes to temporarily fund appropriations for capital projects.

**Origin of the Amendment:** County Executive

**Present Practice:** After the County's Capital Budget is adopted in June, County Council must pass a bond authorization ordinance, which takes effect 45 days after becoming law. This process can take several months become of bill preparation time and the Council's schedule. Projects cannot advance until the bond authorization is in effect.

**Proposed Change:** The County Council will be able to authorize the issuance of interim notes to provide temporary financing of a capital project in advance of the bond authorization bill taking effect. The notes must be paid off by June 30 of the fiscal year following the fiscal year in which they were issued.


**Pro:** Funding from interim notes will allow projects in the capital budget, such as school construction, to proceed in a timely manner and will prevent costly delay.

**Con:** In the unlikely event that County Council failed to pass the capital bond authorization bill, interim notes would have to be paid back from available funds.

A vote **FOR** the amendment allows the County Council, at its discretion, to authorize interim notes during the time period between passage of the annual budget and the effective date of the bond bill. A vote **AGAINST** the amendment leaves the current Charter requirements for Bond Issue Authorization Ordinances which does not allow for interim notes. (Resolution 43-16, passed July 18, 2016)
