**FACTS FOR VOTERS**

To be a registered voter in Howard County, you must meet the following requirements:

- US citizen and County resident
- At least 16 years of age (but cannot vote until 18 years old by date of next general election)
- No conviction for buying or selling votes
- No felony conviction unless you have completed court ordered sentence of imprisonment
- Not be under guardianship for mental disability, or legally found unable to communicate a desire to vote
