Can you answer the question “Where did ‘Uncle Sam’ get his name?”

Here is the answer: The original Uncle Sam –the goatee, twinkling eye, and all - was Samuel Wilson. He formed a partnership in the meatpacking business with his brother Ebenezer in Troy, New York. The brothers contracted to supply the Army with beef and pork during the War of 1812 and marked their shipping barrels ‘U.S’. The soldiers jokingly called the meat ‘Uncle Sam’s’ beef or pork-after Sam Wilson. A soldier drew a caricature of Sam Wilson with his goatee and flowing hair and labeled the picture, ‘Uncle Sam of the USA’. This picture was the original of the ones used to depict Uncle Sam today. ### PAST UNIT MEETING UPDATES

**February Unit Meeting:** Only one Unit Meeting was scheduled for February and because of inclement weather, the meeting was rescheduled to Wednesday, March 6, 2019.

Betsy Singer, our LWVHC Environment Director, lead a very animated discussion on the important environmental issues which are before the Maryland General Assembly. She shared the League's positions on those issues which are Legislative priorities for the LWVMD.

Topics included the Clean Energy Jobs Act, the Ban on Expanded Polystyrene Foam Food Packaging, Forest Conservation, and the Pipeline Safety Act.


Thank you to Betsy for fitting this into her busy schedule during the General Assembly session.

**March Unit Meetings:** The March meetings were jam-packed with information and information-gathering as we worked on "Program Planning" and completed a required review of LWVHC positions. The current positions and suggested changes are available to members online in the *Annual Meeting Workbook* which is on our website. At the Annual Meeting, you will be asked to vote on any suggested position changes and also on suggested "studies" for the 2019 – 2020.

Also, at our March Unit Meeting, we worked on developing consensus for the LWVMD's Bail Reform Study. This study could just as easily been titled the "Pre-Trial Justice System" as our discussion included bail, bail bond agents, District Court commissioners, pretrial services and how they might be funded, and general questions such as "Should bail be abolished?"

An interesting piece of information that was new to many of us - the United States and the Philippines are the only countries in the world that impose bail.

At both meetings, consensus was reached and our final report was sent to the LWVMD. They will compile the information from all Maryland Leagues and determine what the League position should be regarding the pretrial justice system in Maryland. All Maryland Leagues will then be able to use this position statement when giving testimony either before the General Assembly or on legislative bodies in their own counties.

As of the writing of this report, the Maryland General Assembly was still in session and you can follow the action on bills of interest to you at the <http://mgaleg.maryland.gov>. Bills can be tracked by the number of the bill or by broad subjects or by selecting from the menu. You can track the bill from introduction to final status at this site.

Please join us at future Unit Meetings. Our meetings serve two purposes:

#### **Education:**

- To learn more about topics of interest to League members through presentations by League members and other members of the Howard County community.
- To share ideas and information of interest to all league members.

#### **Consensus**

- To determine consensus on program topics/studies which have been approved at the Annual Meeting or have been studied by the Maryland League of Women Voters.
- To determine consensus on legislative issues to be taken at local, state, and national levels.
- Once consensus is reached, a position on an issue is identified and the LWVHC uses these positions to advocate at all levels of government.

## **EDUCATION LEGISLATION UPDATE**

### **ACTION ALERT!**

The LWVMD recently sent an action alert asking members to contact their lawmakers asking them to support **full funding** for the **Blueprint for Maryland's Future** bill (Senate Bill 1030 and House Bill 1413), including the addition of \$325 million in FY 2020 and \$750 million in FY 2021 and **not to cut** \$100 million from the special education provisions. **The Blueprint for Maryland's Future** bill provides for recommendations made by the Kirwan Commission on Innovation and Excellence. (Learn more about the Kirwan Commission here: <https://www.mabe.org/adequacy-funding/>)

#### **The 2019 report identified policy recommendations in five major areas:**

1. Expand free full-day preschool to all low-income three- and four-year olds.
2. Raise standards and status of the teaching profession, including a performance-based career ladder and raising salaries to match those of fields with comparable education requirements.
3. Create an internationally benchmarked curriculum that empowers students to be college- and career-ready, including early college, Advanced Placement courses, and technical/vocational education.
4. Create broad and sustained support for schools with high concentrations of students living in poverty, including before- and after-school and summer academic programs, access to health and social services, and increased support for English language learners and special education students.
5. Create an oversight board that ensures these recommendations are being successfully implemented.



## **EDUCATION LEGISLATION UPDATE, *continued***

Both the Senate and the House voted on March 14 in support of spending plans for FY 2020 and FY 2021 that provide funding for all of the Kirwan Commission's recommendations. These plans include \$200 million in funds from the Kirwan Commission on Innovation and Excellence in Education Fund and \$125 million in casino revenue allocated to the Education Trust Fund (ETF).

However, Governor Hogan's proposed state budget for 2020 does not include any of the \$200 million from the Kirwan Commission Fund and commits only \$24 million of the \$125 ETF fund to support the Commission's recommendations. An additional \$45 million of ETF funding is allocated to a new school construction program administered by the Maryland Stadium Authority.

In addition to support from LWVMD and LWVHC, the Commission and its recommendations have the support of the Maryland Association of Boards of Education, the Public School Superintendents Association of Maryland, the Maryland State Education Association, Strong Schools Maryland, Maryland PTA, Advocates for Children and Youth, ACLU Maryland, and the Maryland Association of Counties.

## **CORPORATE GIFT MATCHING**

Members can double their donations to the League of Women Voters of Howard County (LWVHC) by participating in matching gift programs. Many companies and businesses offer these programs to employees who want to help their favorite nonprofit earn fundraising dollars. A large number of nonprofits miss out on needed donations because donors are unaware of their company's matching gift program. Through matching gift donations, members and supporters of the League can help to generate more resources.

Operating a nonprofit is financially challenging for many organizations. A matching gift donation is a great way for members and supporters to assist in significantly increasing fundraising revenue. Companies distribute money after employees make donations to an eligible non-profit organization. Consider applying for a corporate matching gift to support the League's important work.

Here are examples of matching gift programs and how they work:

- Coca-Cola will match eligible donations at a 2:1 ratio. The company will match \$25 to \$10,000 a year for full-time employees and retirees,. Employees can submit a matching request to <https://fed.ko.com/communitykonnnect/>.
- The T. Rowe Price Group will match donations by full-time, part-time and retired employees. The Group is willing to match a minimum of \$25 and as much as \$20,000 at a 1:1 ratio to most nonprofits. Matching gift requests should be registered electronically through the company's intranet. - Apple will match donations of \$1 to \$10,000 for full-time and part-time employees. Employees can view complete guidelines by clicking on this link: <https://apple.benevity.org/>. - Nordstrom's donations are based on 1% of all gift card sales.
