THE LEGISLATIVE DISTRICTS

The state is divided, on the basis of population, into 47 legislative districts, each of which elects one senator and three delegates to the General Assembly. Some of the legislative districts cross county lines, particularly in the rural areas. Some legislative districts are subdivided into three single-member or one single-member and one two-member legislative districts. In a legislative district containing more than two counties, no county may have more than one delegate residing in it.
