### U.S. Foreign Policy and Petroleum, Jonathan Chanis

What is the effect of U.S. petroleum security on foreign policy? For 45 years, the country has alternated between periods of energy security and insecurity, sometimes able to wield petroleum as a useful instrument of foreign policy, sometimes not. Despite the so-called "energy revolution," the U.S. today is by no means disentangled from foreign dependence and global trends. In order to be successful, policymakers must recognize both petroleum security circumstances and patterns in the relationship between petroleum and foreign policy.

## The Future of Forests

LWVHC hosted *The Future of Forests, The Benefits of Urban Trees* on Thursday, April 13 at 7 pm at Historic Oakland Manor Main Ballroom.



Dr. Joseph Sullivan, Professor and Associate Dean, University of Maryland College of Agriculture & Natural Resources, shared his research in Prince William Forest Park and the importance of urban trees and forests in improving air and water quality and enhancing carbon storage and sequestration.

The program was co-sponsored with the Howard County Legacy Leadership Institute for the Environment (HoLLIE) and the Town Center Community Association. Thanks to Lillie Gallant and Michele Trotter for setting up the LWVHC membership display and sign up sheet in the foyer. Patti Laidig publicized the lecture through LWVHC and Columbia Association channels and HoLLIE invited its graduates as a continuing education opportunity.

## GREENFEST

LWVHC sponsored a display at the annual Howard County GreenFest, sponsored by the Department of



Recreation and Parks on Saturday, April 22 from 10 a.m. until 4 p.m. at the Howard Community College. Thanks to League members Carole Graves, Barbara Russell, Denise Kickham and Joy Calvert for staffing the exhibit. We were very busy with many of the 2,000 people who came to GreenFest stopping to ask questions and signing up for membership information.

The League exhibit featured environmental legislation that we worked hard to pass during the 2017 Maryland General Assembly session. We had a successful session!



No Fracking in Maryland - 2017 was the last chance to get a total ban on hydraulic fracturing in Maryland. We went into the General Assembly session with time running out on a 2.5 year moratorium on hydraulic fracturing or “fracking.” Fracking causes great harm to water supplies, air quality, and communities where it is used to extract natural gas from shale **deposits**. Leaking of gas and methane is a regular part of this deep vertical and horizontal drilling process. Toxic chemicals are used to alter the consistency of the millions of gallons of fresh water used in drilling and the water picks up radioactive material after being forced deep into the shale formation. The water can never be cleaned or reused.

A bi-partisan group of delegates voted HB 1325 out of the Environment & Transportation Committee. (Thanks to Howard County’s Del. Bob Flanagan, D-9B) A week later, the bill went to the full House and passed with a veto-proof majority, 97 to 40 on March 10. SB 740, of the same name, went to the Senate Education, Health, and Environmental Affairs Committee and had a lengthy hearing on Feb. 28. In a surprise move, Gov. Hogan held a press conference on March 17 to announce that he would support legislation to ban fracking in Maryland. The bill to ban fracking then passed out of the Senate committee and went to the full Senate where it passed by a vote of 36-10. The Gov. signed the legislation on April 4 and Maryland is now the first state that actually has gas reserves that has banned fracking legislatively.

Renewable Energy Portfolio Standard Revisions raises Maryland’s Renewable Portfolio Standard requirement to 25 percent by 2020, up from the previous goal of 20 percent by 2022, including increasing the solar requirement to 2.5 percent by 2020. The Governor vetoed this legislation in 2016. On Jan. 31, 2017, the House of Delegates voted to override the Governor’s veto and the Maryland Senate followed on Feb. 2. LWVMD wrote testimony in support of the original legislation and advocated for the override.

Pollinator Friendly Solar - In an unusual coupling of energy production and cultivation of nature, the legislature passed **SB 1158** that establishes a process for Maryland to designate a utility-scale ground mounted solar facility as “pollinator friendly.” The designation includes solar facilities that use native vegetation and habitat management practices to maximize habitat creation for birds, pollinators and other small wildlife.

Clean Cars **SB 315/HB 406** altered the Electric Vehicle Recharging Equipment Rebate Program for electric plug-in vehicles. They also authorize motor vehicle excise tax credits for new plug-in electric drive vehicles and increase the amount of funding to be transferred from the Strategic Energy Investment Fund (SEIF) to the Transportation Trust Fund to offset the cost of the program.

Energy Efficiency Thinking ahead to possible challenges to the EmPOWER Maryland program, **SB 184/HB 514** now requires the Public Service Commission to designate each electric company in the state to provide energy efficiency and conservation to its customers beginning with the 2018-2020 program cycle. EmPOWER is extended until at least 2024. The program will create nearly \$12 billion in energy savings over the next ten years while reducing the carbon equivalent of taking nearly 200,000 cars off the road each year. The EmPOWER program is a major pillar needed to achieve the reductions of the Greenhouse Gas Reduction Act of 2016.



## Vigorous 2017 LWNCA Convention Energizes Attendees

The annual LWNCA Convention was held Saturday morning, May 6 at Clyde’s at Gallery Place in Washington, DC. The fast paced, full agenda of the League of Women Voters of the National Capital Area Convention supported an enriching experience for the approximately 50 delegates and others who attended.

Guest Speaker Dr. Mark Graber, University System of Maryland Regents Professor and Professor of Law, University of Maryland Casey School of Law, spoke entertainingly and with overwhelming erudition on the topic, *“The Electoral College: From the Federalist Papers to Trump.”* Dr. Graber had a lively Q&A session.

The annual LWNCA Business Meeting was convened by President Kathy McGuire. The 2017 Convention Minutes Reading Committee was appointed. Treasurer Nancy Bliss reported LWNCA in League year 2016-2017 had balanced \$11,210 income and expenses. Budget Committee Chair Sherry Zachry led discussion and approval of the proposed FY 2017-2018 LWNCA Budget.

Director for Program Diane Hibino reported activities for 2015-2017 and gave the nine-person Program Committee’s report on the review of LWNCA Positions and the changes recommended. Positions on Airports, Controlled Substances, and Land Use/Housing were retained. Positions on Beltway Safety, Comprehensive Health Planning, Regional Governance, and Water Resources were retained but edited. The recommendation for the position on DC Financing was to postpone review. An update from the LWNCA Metro Finance Committee was given by Chair Nancy Soreng.

The Nominating Committee Report on officer and director candidates was given by Andrea Gruhl. There were no nominations from the floor, so the slate was elected as follows.
