Patricia Jamison opened the meeting at 11:15 a.m.

Updates:

- Patricia Jamison distributed a Board contact list. She will send an updated version that includes email addresses.
- Patricia Jamison will be checking to see if the state League will have liaisons to county leagues.
- Joyce Woodford presented the framed QAC County Proclamation for the 100th Anniversary of the passage of the 19th amendment to the U.S. Constitution. The Board agreed to see if the new Women's Museum can display it.
- Patricia Jamison, Barbara Sharkey, and Pat Sommers gave a summary of the State League convention. Patricia Jamison noted that Diversity, Equity, and Inclusion (DEI) was an emphasis.
- The Board reviewed the results, to date, of the annual meeting votes. At this time there are 49 LWVQAC members. As of June 9, 28 members returned their ballots with votes designated as: 28 voted to approve the slate of Board members, 28 voted to approve the annual budget, and 27 voted to approve the change to the by-laws. One ballot indicated a NO for the by-laws changes. According to the current by-laws, 2/3 votes of members at the annual meeting (which we are counting as those who returned ballots) are required for final approval. Thus, all 3 items are approved.
- The Board discussed the Smithsonian Exhibit, Voices and Votes, at Kennard African American Cultural Heritage Center in Centreville. The exhibit will be in Centreville until July 24. Patricia Jamison emailed information to several Board members about opportunities to be a docent at the exhibit.
- Barbara Sharkey is looking at a tablecloth with our logo on it to be used at the voter registration and information events. We will discuss options at our next meeting.
- The Board discussed the Guide to Government Officials. A question arose about whether Judge Frank Kratovil, a judge for the Queen Anne's County

- District Court should be included. The Board will discuss further at the next meeting.
- Patricia Jamison will follow up to find out who has the electronic file for both the LWVQAC membership brochure and the By-Laws so that we can update them and get them printed.
- The Board agreed that there will not be a meeting in July and August. We expect the Queen Anne's County Public Library to re-open the use of their conference room by September and we anticipate again holding our meetings there.
