SIX POLICE REFORM DEMANDS IN PRINCE GEORGE'S COUNTY

1. FULLY UNREDACT THE GRAHAM EXPERT WITNESS REPORT TO THE PUBLIC TO REVEAL EXTENT OF RACIAL BIAS AND MISCONDUCT IN THE PRINCE GEORGE'S POLICE DEPARTMENT.

2. ENSURE JUSTICE FOR LEONARD SHAND AND WILLIAM GREEN, WHO WERE KILLED BY PGPD OFFICERS.

3. TAKE ACTION NOW TO ADDRESS THE NEARLY 7,000 USE OF FORCE COMPLAINTS RULED "JUSTIFIED" BY PGPD.

4. MAKE PUBLIC THE STATE'S ATTORNEY LIST OF PGPD OFFICERS BARRED FROM TESTIFYING DUE TO PAST LIES TO THE COURT.

5. UPDATE THE AMOUNT THE COUNTY HAS SPENT IN FEES DEFENDING HNLEA VS. PRINCE GEORGE'S COUNTY, A LAWSUIT BROUGHT BY BLACK AND BROWN PGPD OFFICERS WHO HAVE BEEN TARGETED BY RACISM AND RETALIATION. BY APRIL THE TOTAL AMOUNT WAS ALREADY \$6.3 MILLION.

6. SUPPORT THE STATEWIDE PLATFORM OF POLICE REFORM DEMANDS FROM MORE THAN 85 ORGANIZATIONS.
