Voter registration forms are available at libraries, schools, social service agencies, Motor Vehicle Administration offices and the Board of Elections. Register online or obtain a form at elections.maryland.gov.

Registration closes 21 days before each election for new registrations, for changes of name/address and for changing party affiliation.

If you are a registered voter, you will receive a sample ballot indicating your polling place from the Board of Elections shortly before each election.

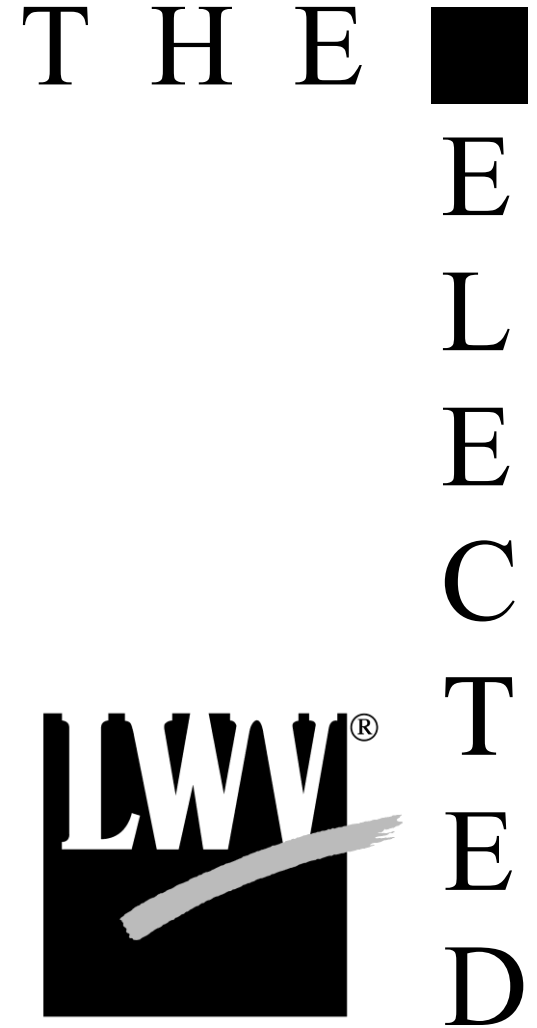
