**ELIGIBILITY:**

- U.S. citizen
- legal resident of Washington and
- at least 18 years or older by the date of the next election

**WHERE TO REGISTER:** Mail-in voter registration forms are available at the county courthouse, city and town clerks' offices, public libraries, public schools or fire stations. Online registration, address change and mail-in registration forms can also be obtained from the Secretary of State's website at [www.vote.wa.gov](http://www.vote.wa.gov).

**WHEN TO REGISTER:** New Washington State residents may register in person at least 8 days before an election, or by mail at least 29 days before an election. When registering, contact the County Auditor's Office at 360-786-5408 for registration deadlines.

**RE-REGISTER IF YOU:** Move, change your name, or change your mailing address.

**HOW TO VOTE:** All elections within Thurston County are conducted by mail. Ballots are mailed to registered voters and can be returned by mail or placed in ballot drop boxes. For drop box locations, call the county or refer to [www.ThurstonVotes.org](http://www.ThurstonVotes.org).
