State of our finances

The finances of LYMEC are in good shape. LYMEC has good working relationships with both the European Liberal Forum (ELF), ALDE Group and ALDE Party, all three of which kindly sponsor events or general office expenses. Also, LYMEC profits from the Erasmus+ grant of the European Commission, which allows LYMEC to have paid staff (our Secretary General and Assistant) at the office in Brussels.

There are four general topics which I would like to address.

1. Remaining grant from the European Commission

When the 2016 Financial Report was adopted in May 2017, LYMEC had not received the remaining 10.000 euros of the Erasmus+ grant yet. Therefore, this amount could not be booked in 2016 and it is now booked in 2017. ("Income previous financial year")

This year, the same issue arises. On the date of writing this financial report, it has not been definitively confirmed that LYMEC will receive the remaining 20%. We do expect to receive it, but we need to be sure before we can book it financially. Therefore, the remaining 20% of the grant is not booked in 2017, but will be booked in 2018.

2. Tallinn gala dinner restaurant

LYMEC celebrated its 40th birthday during the anniversary congress in Tallinn in November 2016. You may remember that the deposit that LYMEC paid (€4.200) was initially not returned to our accounts. The Bureau is happy to report that the amount was finally returned in November 2017. We sent several reminders by email, but the restaurant only returned the deposit after we had sent a registered letter.

3. Stockholm congress invoices

Our Congresses are mostly sponsored by our partners ALDE Group, ALDE Party and ELF. Despite clear instructions (regarding what should be invoiced to whom), the Stockholm Congress hotel compiled incorrect invoices for our sponsors. Due to those erroneous invoices, our sponsors were unable to cover the costs of the Congress. After sending a registered letter and several calls with the hotel manager, this issue was finally solved shortly after our Autumn Congress in Sofia.

4. New furniture and computers in the office

In December, the Bureau decided to refurbish the office. The office now has height adjustable standing desks and new, modern laptops for our secretary general and assistant.

Goods that have a purchase price of more than €250,- are depreciated over three years (laptops) and five years (desks). Our bookkeeping system runs this depreciation automatically.

Other goods (new printer, new computer screens, etc.) had a purchase price that was lower than €250,- and have been fully booked in 2017 (in "office equipment").

5. Allocating the surplus: a new visual identity

Ever since ALDE Party was rebranded in 2017, the Bureau has had the ambition to create a new visual identity LYMEC as well. The Bureau has come to the conclusion that the best option is to look for a professional firm. The 2017 surplus offers a unique opportunity to cover this option financially. We therefore aim to allocate the 2017 surplus to the new visual identity.

A.1 | European Commission Grant

The largest general funding LYMEC receives is the Erasmus+ grant of the European Commission. LYMEC has to apply for this grant every three years. Every spring, LYMEC receives 80 percent of the requested amount. After closing the books of a financial year and reporting to the Commission, LYMEC receives the other 20 percent.

On the date of writing this financial report, it has not been definitively confirmed that LYMEC will receive the remaining 20%. We do expect to receive it, but we need to be sure before we can book it

financially. Therefore, the remaining 20% of the grant is not booked in 2017, but will be booked in 2018.

A.2 | ALDE Party Grant

Another large donor is the ALDE Party. Even though ALDE Party only sponsors actual costs, these can be any (office) expense. Therefore, the ALDE Party grant is considered general funding.

A.3 | Membership fees

The total fees invoiced to our Member Organisations in 2017 amount to 16.948,58 euros.

By 31 December 2017, 4 of our Full Member Organisations and 8 of our Associate Member Organisations had not paid their membership fees yet. You can find details of their debts in the attachment to this financial report.

LYMEC Congress can decide to reduce the membership fee or debt of an organisation. In 2017, Congress has decided to reduce the fees of six organisations:

- MLBiH (Bosnia and Herzegovina): reduced by €196,-
- LiDem (Macedonia): reduced by €104,20
- ANC Youth (Armenia): reduced by €11,34
- Alliance Youth (Nothern Ireland): reduced by €115,-
- Lietuvos Liberalus Jaunimas (Lithuania): reduced by €244,-
- European Youth of Ukraine (Ukraine): reduced by €156,-

Congress also decided to write off debts of several organisations. Those write-offs are not shown here, but are written off through the 'allowance for doubtful accounts' on the balance sheet.

A.3.2 | Individual membership fees

LYMEC has a growing number of Individual Members. Members of the Individual Members Section (IMS) pay through PayPal, so that the payments can be automated every time the membership ends. LYMEC has three membership types:

- One year membership: 10 euros
- Five-year membership: 35 euros
- Lifelong membership: 90 euros

Currently, existing members are not automatically invoiced but can rather voluntarily renew their membership. Most IMS members have an automatic payment plan through PayPal.

A.4 | Participation fees

The participation fees of congresses are collected by LYMEC. The income that is created is therefore technically not attached to a project and can be spent on any expense. Therefore, the participation fees are shown in general income.

A.5 and A.6 | Donations and other general income

Our first alumni network event was a great success. Together with IFLRY, we organised a gathering during the ALDE Congress in Amsterdam. IFLRY and LYMEC shared the income, and LYMEC received €441.21.

The 'other general income' consists of 10 dollars that was found on an unused LYMEC PayPal bank account.

B.1 | ALDE Group Grants

Many expenses that are covered by the ALDE Group grant have been invoiced directly to the ALDE Group. That means the expenses do not pass our bookkeeping. Therefore, most part of the grant is not shown in our expenses nor our profit and loss statement.

B.2 | European Liberal Forum Grants

The European Liberal Forum funds full events. Most expenses for these events are paid directly by ELF. Most part of the grant cannot be shown in our profit and loss statement.

Some expenses for ELF events are paid for by LYMEC and reimbursed by ELF after an event. Those expenses are shown in our profit and loss statement, since LYMEC was invoiced for those expenses.

B.3 | ALDE Party Congress Grants

The ALDE Party currently covers 10.000 euros for the hotel during a LYMEC congress. This payment does not pass through our bank account but is instead paid for directly by the ALDE Party. Therefore, the grants are not shown in our profit and loss statement.

C.1 | Income previous financial year

When the 2016 books were closed, the Bureau had not received a confirmation that LYMEC would receive the remaining part (20%) of the 2016 Erasmus+ grant. Therefore, that amount could not be booked in 2016. It is booked in 2017 as "Income previous financial year".

Expenses in detail

The following section will show all expense budget lines, section by section, and offer explanations to what is and what is not included in every budget line. The expenses are divided in the following fashion.

- Non policy-related general expenses: expenses that are recurring yearly and that are not influenced by LYMEC Policy. These include bank fees, audit expenses, etc.
- Policy-related general expenses: all general expenses that can be influenced by LYMEC policy.
- Project expenses: all expenses that are related to projects and events.
- Other expenses: expenses for the previous financial year that have been booked in 2016 or expenses that are generated by the bookkeeping system, such as 'rounding'.

D.1 | Association fees

LYMEC is members of the European Liberal Forum as well as the European Youth Forum and pays fees to both organisations. These are budgeted as Association fees.

D.2 | Audit Expenses

The annual Audit is done by both our own (internal) auditors and professional (external) auditors. The internal auditors meet twice a year in Brussels; their travel and accommodation is covered by LYMEC. The external audit is conducted every year by a professional company, selected by Congress.

D.3 | Bank fees & insurance

This account includes the basic fees for having a bank account at KBC Bank. Furthermore, whenever LYMEC transfers money to a country outside the euro zone, a fee is automatically charged by the bank. PayPal fees are automatically charged to LYMEC whenever LYMEC receives a payment on its PayPal account.

D.4 | Bad debts reserve

Every year, the "allowance for bad debts" is increased in order to cover the risk of unpaid invoices. The Bureau has increased the debt allowance by €3520,30 to €5.550,50, which was the total amount of overdue invoices on 31 December 2017. This means the allowance now fully covers all outstanding debts and that Congress can waive membership fee debts without any financial consequence.

D.5 | VAT

LYMEC sometimes orders goods or services from outside Belgium. In some cases, the VAT is paid to the Belgian authorities separately.

D.6 | Depreciation

When LYMEC orders new office equipment, those goods still have financial value. The good (e.g., a laptop) is placed on the balance sheet and written off as the good loses its value (as time passes). The bookkeeping system calculates this 'depreciation' automatically.

E.1 | Contribution to all ELF Events

In 2017, LYMEC covered 50% of the ELF events. This was not calculated per event, but rather based on the total grant of 40.000 euros. LYMEC paid 20.000 euros to ELF at the start of the year.

E.2 | Bureau Expenses

These accounts show bureau expenses. E.2.1 (Communications) includes the telecommunications refund every bureau member is allowed to receive. Also, it includes the Project Management system LYMEC uses: Basecamp.

In 2017, the LYMEC Bureau has not held a separate Bureau weekend, but has only met in person during events. (e.g. the Young Leaders Meeting, LYMEC Congress)

E.3, E.4 and E.5 | Communications and PR; Office; Political Activities

The accounts 'Communications and PR and Office rather speak for themselves. In account 42.1, Facebook advert expenses are also included.

Rent for 2017 booked in 2016

By accident, the rent of the first three months of 2017 (€1.500,-) was booked in 2016. Therefore, only €4.500,- has been booked in 2017.

E.6 | Representation

If LYMEC is invited to an event, such as an event of the European Youth Forum, the travel expenses are shown here. If LYMEC receives a travel refund from the organisation that we visit, the refund is booked as credit (= negative expense) to the 'Representation' account. Thus, the refund is subtracted from the travel costs (and not booked as income).

G.1 | Expenses previous financial year

There are two expenses from the previous financial year. Both are negative expenses ("revenue").

- In 2016, LYMEC paid for a flight of its assistant. The flight costs were reimbursed in 2017 because the assistant's flight was cancelled. It is booked as a negative expense to the previous financial year.
- In 2016, LYMEC paid a deposit to a restaurant for the 40th anniversary Congress in Tallinn. This was not returned until November 2017, after sending several reminders and a registered letter. The deposit was booked as an expense in 2016. Therefore, the refund from the restaurant is booked as a negative expense to the previous financial year.

1 | Bank Accounts

LYMEC has three bank accounts: two accounts at KBC Bank (one Current, one Savings) and one account at PayPal. The PayPal accounts is primarily used to collect membership fees from our Individual Members.

2 | Current Assets

The Current Assets include invoices that had not been paid on 31 December as 'Accounts Receivable'. A full list of the accounts receivable of 31 December is shown in attachment 2.

Some of the unpaid invoices are old and will most likely never be collected (e.g. invoices sent to member organisations that are not active anymore). Therefore, we have an 'Allowance for doubtful accounts'. That accounts serves as a financial buffer for invoices that will most likely have to be written off in the future. If an old invoice is written off, it is written off from the allowance.
