- 8. Without membership in LP, member of LY loose right to be a candidate on parliamentary election list of LP.
- 9. Foreign citizen can be a honorary member of LY.

The Liberal Youth of Montenegro enjoys autonomy within Liberal party of Montenegro and is not subordinate to any other authority of the party or other organisation.
