## 2. Current political situation

AP starts with current political situation. The Bureau discusses the issue of Roma and freedom of movement. It agrees to issue a statement should the situation demand it in the coming days. JD reports on the state of play regards Dutch coalition talks. MF introduces the topic of parental leave. She will look into the topic and communicate further to the Bureau.

## 3. Follow-up of decisions taken at the last Bureau meeting

MLN goes through the decisions from the last Bureau meeting.

On CAP public consultation - we missed the deadline for the CAP consultations. But will still try to get a meeting with commissioner and EP spokesperson. The future CAP will be discussed during the Danish Presidency in 2012.

Kyrill Lapin: AP will try to get in touch through Kyrill's company.

YiA application: we will include deadline in newsletter and information sent to international officers.

Other outstanding issues will be dealt as part of agenda of this meeting.

## 4. Finances

MF reports that Jeroen Benning paid his outstanding obligations. She also reports that ELDR awarded us 19 000 euros of funding for next year's projects. She warns that we are still low on the spending side and we should keep it that way AP reports that concerning Jeroen Benning the case will remain with the CDA since he substantially damaged the image of LYMEC.

MF reports on her meeting with internal auditors and that they seemed happy and commented only on the Benning case, outstanding donations and that we should have an overview of paid/unpaid MO fees.

## 5. IFLRY

The Bureau discussed membership fees, IFLRY's fundraising proposal and LYMEC-IFLRY understanding on mutual cooperation. Different Bureau members will engage in discussion with fellow IFLRY Bureau members on these issues.

VG reports on cooperation with IFLRY over CoE Train the Trainers program. LYMEC is asking for a fully-covered COE training course in their facilities with their professional trainers

# 6. ELDR and ALDE – present situation

AP reports on the ELDR Bureau meeting:

- a) ELDR grant to LYMEC. AP foresees no problems in this regard.
- b) The individual membership in ELDR. AP will try to influence this discussion. Some form of IMS is being introduced.
- c) ELDR Bureau elections are coming up and LYMEC will naturally be part of the process.

Bureau discussed preparations for ELDR Congress. Everything is in order logistically for LYMEC delegation and in terms of its input. This time the Bureau members' travel is not covered by the organization but the Bureau agrees to discuss this issue principally at the next meeting.

#### 7. Events

MHS starts reporting on events.

YLM: VG and MHS report on the preparations. The invitation will go out soon. Congress: VG and MHS report. Office will send the contract, once it is finalized, to MLD.

Representation to IFLRY GA will be discussed at a later point in time. CB voiced her interest in attending.

MHS will finalise the guide to organizing event and share the draft with the Bureau for their input.

#### 9. New Libertas and Website

JD reports on the preparations for the next issue (Liberalization of Europe). JD will send an email to the board of editors concerning the next issue. He states that his aim is to have the issue done by YLM. Storyboard will be sent to the Bureau once it is finished, articles to Slaven Klobucar once their done and first draft of the PDF to the Bureau for correction as soon it is ready. We will probably not be able to afford postal mailing this time (for JD to check out). VG states that for the future she would like to get our own photographers on board.

JD will have by the YLM Bureau meeting results on his open tender procedure for the production of the magazine. He will write a call for LYMEC mailing.

CB will come up with a proposal within a week's time on how to celebrate LYMEC's 35<sup>th</sup> anniversary. No big visual changes to our brand should occur.
