ELSEWHERE ALONG THE ROUTE THERE IS HOPE...

Much of the construction is completed in Saskatchewan and Wisconsin but in Minnesota the project has yet to be approved.

The Minnesota Department of Commerce concluded the project should not be build at all and the old pipeline should be decommissioned

The Minnesota Public Utilities Commission said the Environmental Review is inadequate

The Minnesota Department of Human Rights raised questions about tribal impact due to the potential destruction of wild rice fields

Enbridge will be cutting and capping the old pipeline and will fill it with gas to prevent corrosion. However this inert gas pumped inside may not stay inside the pipe since according to Enbridge the pipe is currently "weeping".

"Line 3 has experienced an accelerated rate of deterioration associated with external corrosion, Stress Corrosion Cracking, and long-seam cracking due to the disbonded coating and fatigue growth of defects in the flash welded long seams. I consider Line 3 to be in the deterioration stage, as external corrosion growth is increasing in an exponential fashion."
