RESOLUTION

WHEREAS, the officers and members of the South Dade Democratic Black Caucus, Inc., Ron Brown Chapter, found in the year, 2001, are bound by certain Objectives to meet the mandates of the Democratic Black Caucus of Florida, The Florida Democratic Party, and the Democratic National Committee;

WHEREAS, these Objectives are found under Article II of our Democratic Black Caucus of Florida, Inc., Bylaws, Section 1 to 7 and Section 6 of Article II states, "To ensure that issues of concerns to the Black community are made known to the Democratic Party and that the Democratic Party positions on these issues are communicated to the Black community;"

WHEREAS, Friday, December 30, 2016, Mr. Jamar Rollins was fatally shot by one or two Miami-Dade Police Officer(s), Jesus Coto and Andrew Garcia, in the West Perrine community of Miami, Florida;

WHEREAS, it is the intent of this Resolution to request the Miami-Dade Police Department (Mr. Juan Perez, Director) and the Florida Department of Law Enforcement (Mr. Troy Walker) to perform an individual and in-depth investigation of this shooting, as well as being communicative with the bereaved family and providing them a complete and accurate report to the extent of the Statutes of Florida and the United States of America; and,

WHEREAS, this organization will serve as one of the "watchdogs" until a resolution has been reached and the effected family and community are at rest.

NOW, THEREFORE, BE IT RESOLVED that this Resolution will serve the family as a Beacon of Hope and reminding them about the powerful words of Dr. Martin Luther King, Jr., "Injustice anywhere is a threat to justice everywhere."

NOW, THEREFORE, BE IT FURTHER RESOLVED that after the investigations with regard to violations of law and policy are completed, the Miami-Dade Police Department examine the shooting in the context of what might have been done differently to avoid the use of deadly force for use in the future training of police officers.
