Dear Mayor Cornett,

I can't begin to express my disgust, outrage and utter embarrassment upon learning of the approved satanic Black Mass on September 21, 2014 at the Oklahoma City Civic Center by city officials. This deplorable event is a promotion of hatred against Christians and should have absolutely no place at the center of our great state.

Additionally, by supporting this event you are unleashing the power of evil in a region that has already suffered through the horrific events of the Oklahoma City bombing, and are now being forced by your acceptance, to be subjected to a breeding ground of darkness and hate. Tragically, those bombing victims' taxpayer dollars are funding the venue to host this satanic event. This is outrageous and insensitive on countless levels.


I'd also like to know if it has become the practice of Oklahoma City to grant permits to sex offenders? Adam Daniels, the man who has applied for this permit, is in the Oklahoma Department of Corrections database (Adam B. Daniels, DOC #601440) and was sentenced for Sexual Battery of a person under 16 years of age. The DOC has taken his offenses so seriously that Mr. Daniels is required to register every 90 days for life. Whether you realize it or not there is truly a spiritual battle going on for the soul of our nation and these choices don't help our battle for good.

As a public official and a Catholic, I believe I speak for Christians across our state and nation when I ask why you are permitting a hate crime like this against Christians? You have the authority to reject this event. It is evident in (6) of the Terms and Conditions on the event application:

(6) COMPLIANCE WITH LAWS - The permittee shall comply with federal, state and local law including all rules and regulations established by any authorized officer or department of the City. The permittee shall not allow to be done anything on said premises in violation of any such local laws, rules or regulations. **No performance, exhibition or entertainment shall be given or held in the public events facilities which is by community standards illegal, indecent, obscene, or immoral, and should any such exhibition, or performance, or any part thereof, be indecent, obscene, lewd, immoral or in any manner publicly offensive, then said Director or OCPA may cancel said performance or exhibition or any part thereof and all monies paid by the permittee as rental will not be refunded.**

In conclusion, allow me to reiterate how strongly I urge you to withdraw the permit for this event. If this event is allowed to take place, I will personally withdraw my support of Oklahoma City and be a voice in such a position. Like you, I was elected to represent the citizens who comprise my district. In no uncertain terms, I have received their message and am taking up their outcry against this event, which insults all persons of faith in Oklahoma. I pray you have the courage to prevent this blasphemous sacrilege from taking place.

Your earliest response to this will be greatly appreciated.
