

Community Power 2017 Minneapolis Candidate Questionnaire

Community Power invites all candidates to complete the following questionnaire to inform Minneapolis voters on positions shaping Minneapolis's energy future:

1. What role do you feel energy infrastructure, sourcing, and decision-making play in shaping livability, affordability, economic resilience and community health for Minneapolis residents and businesses? How do you propose to fulfill that role?

A beautiful Minneapolis will be the one where all, regardless of income or neighborhood, have access to affordable, renewable energy. My task as Mayor will be to lay the groundwork to achieve the long-term objective of making renewable energy, first, an abundant energy source, second, the most financially sensible energy source, and, ultimately, the exclusive energy source in Minneapolis.

2. Do you think Minneapolis is adequately prepared to respond to climate change? If yes, how? If no, what do you think Minneapolis should do to become prepared?

The city has good plans in place, but needs strong, intelligent leadership to not only enforce the plans, but also to adapt and modify goals as circumstances change.


Moreover, I will change the partnership from its sluggish quarterly meeting pattern to a monthly


By ensuring renter's rights against predatory landlords. City communications will include information on the energy rights for all tenants, and remedy routes if those rights are violated.

9. How should the City of Minneapolis evaluate the effectiveness of the Minneapolis Clean Energy Partnership as its second two year work plan ends in late 2018? What criteria or thresholds would convince you that the Minneapolis Clean Energy Partnership is succeeding (and should be sustained and expanded) OR is failing (and the city should pursue a different route)?

The CEP must be judged based on the goals set in the document itself. In evaluating each specific target, no excuses can be made or accepted for underperformance. I think the city has been too lenient on half-hearted efforts by utilities partners to achieve these goals -- 2018 will be the time to push the topic to the center of the table. On any failed target, a thorough examination will be ordered, led personally by me, and remedies will be negotiated.
