OUR GOAL IS TO CONVINCE GOVERNMENT OFFICIALS AND BUSINESS LEADERS TO WORK AGGRESSIVELY FOR A SWIFT, COMPLETE, AND JUST TRANSITION AWAY FROM FOSSIL FUELS TO CLEAN AND RENEWABLE ENERGY.
